

LICENSING ACT 2003

LICENSING COMMITTEE HEARING PROCEDURE ALCOHOL, LATE NIGHT REFRESHMENT AND ENTERTAINMENT REVIEW OF PREMISES LICENCE / CLUB PREMISES CERTIFICATE

- The Chair will introduce Members of the Sub Committee and Officers present and explain the procedure to be followed.
- The Licensing Officer will outline the nature of the matter to be considered by the Sub Committee.

In the following paragraphs where the term "party" or "parties" is used in addition to other terms this will mean anyone to whom notice of this meeting has been given.

- 3 (i) The Applicant for Review ("the Applicant"), or representative, addresses the Sub Committee. The Applicant may be asked relevant questions about the matters before the Sub Committee by the other parties, the Licence Holder and the Members.
 - (ii) The Applicant or representative, may call witnesses in support of the application and each witness may be asked relevant questions by the other parties and the Members
- 4 (i) Any interested parties [defined in s.69(3)] making relevant representations (or their representative) will take it in turn to address the Sub Committee and may be asked relevant questions by the other parties, the Applicant, the Licence Holder and the Members.
 - (ii) Any interested party (or their representative) may call witnesses in support of their representations and each witness may be asked relevant questions by the other parties, the Applicant, the Licence Holder and the Members.
- Any Responsible Authority [defined in s.69(4)] making a representation will address the Sub Committee. The Responsible Authorities may be asked relevant questions by the other parties, the Applicant, the Licence Holder and the Members.
- The Licence Holder (or their representative) will address the Sub Committee. The Licence Holder may be asked relevant questions by the other parties, the Applicant and the Members.
- 7 The Applicant will then be invited to briefly summarise the application.
- The other parties will then be invited in turn to briefly summarise their points if they wish in the same order as before.
- The Chair will invite the Sub Committee to move into private session to enable the Sub Committee to deliberate in private in accordance with Paragraph 14(2) of the Hearings Regulations 2005. The Sub Committee will only reconvene to resolve any points of uncertainty on the evidence already given. During their deliberation the Sub Committee will be accompanied *for advice only* by the Legal Adviser and the Committee Administrator. The Sub Committee may retire to a private room or alternatively require vacation of the meeting room by all other persons.
- 10 When the Sub Committee resumes, the Chair will announce the decision in public; this will include the reasons (or advise that the decision will be released in writing with reasons within the statutory time limit in this instance 5 working days).

Please Note:

- Where the Sub Committee considers it necessary to do so, it may vary this procedure.
- Decisions will generally be taken regardless of whether the Applicant is present. All notices and representations received from absent parties will be considered.
- Only in <u>exceptional circumstances</u> will the Sub Committee take into account any additional late documentary or other information produced by an existing party in support of their application/representation. This will be at the discretion of the Chair and with the agreement of all the other parties. No new representations will be allowed at the hearing.
- The hearing will take the form of a discussion However, the Sub Committee will allow all parties to ask questions of another party present, as set out above, but formal cross examination will be discouraged.
- The Sub Committee will disregard any information or representation given by a party which is not relevant to the Application and the Licensing Act 2003.
- The Chair will allow the parties an equal maximum period of time in which to make representations. The amount of time will be at the discretion of the Chair, but in the interests of costs and efficiency will not normally exceed <u>twenty minutes</u>. This will include the time taken for the presentation and the summing up, but not the time taken for questions.
 - NB Where there is more than one party making relevant representations the time will be split between those parties. It is recommended that they arrive early to discuss the application with the other interested parties.
- The Chair may require any person attending the hearing who is behaving in a disruptive manner to leave the hearing and refuse to allow that person to return, or only allow them to return subject to certain conditions. Any person so excluded will however be entitled to submit to the Sub Committee any information which they would have been entitled to give orally had they not been required to leave.

Bath & North East Somerset Council is committed to taking decisions in an honest, accountable and transparent fashion, but on occasion may find it necessary to exclude members of the press and public based upon the legal framework given in the Local Government Act 1972 Schedule 12 (a). On these occasions decisions based on the above framework will be given.

1 THE ISSUE

1.1 An application has been received from an interested party for a review of a Premises Licence under the Licensing Act 2003 in respect of **Bodrum Takeaway**, 34 Broad Street, Bath, BA1 5LP.

2 RECOMMENDATION

2.1 That the Sub Committee determines the application to review the Premises Licence.

3 FINANCIAL IMPLICATIONS

3.1 There are no financial implications arising from this report.

4 THE REPORT

An application for a review of the Premises Licence for Bodrum Takeaway, 34 Broad Street, Bath, BA1 5LP has been received from Environmental Protection (Annex A).

The application relates to the **prevention of public nuisance** licensing objective. The application states that 'as a result of the provision of late night refreshment, patrons congregate outside the premises late into the night causing disturbance to neighbouring residential premises.'

- 4.2 The Licensing Authority may, having had regard to the application and any relevant representations, take any of the following steps (if any) as it considers necessary for the promotion of the licensing objectives:
 - a) Modify the conditions of the Licence
 - b) Exclude a licensable activity from the scope of the Licence
 - c) Remove the Designated Premises Supervisor
 - d) Suspend the Licence for a period not exceeding three months
 - e) Revoke the Licence

Where the Licensing Authority takes a step mentioned in 4.5 (a) or (b), it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.

Any determination made by the Licensing Authority does not have effect until the end of the period given for appealing against the decision, or, if the decision is appealed against, until the appeal is disposed of.

- 4.3 The Licensing Authority will also have regard to the Council's Licensing Policy, the Statutory Guidance issued under Section 182 of the Licensing Act 2003, the Licensing Act itself, and, in particular, to:
 - a) Sections 4, 9, 10, 13, 51, 52, 53, 182, and 183 of the Act.
 - b) Chapters 8 11 of the Statutory Guidance (as revised on October 2010).
 - c) Paragraphs 3, 5, 6, 15, 18 20, 33 37 and 40 45 inclusive of the Policy.
- 4.4 An appeal may be made to the Magistrates' Court within 21 days of the notification of the decision by the Council to the applicant for the review, the holder of the premises licence or any other person who made relevant representations in relation to the application.

On appeal the court may either; dismiss the appeal, substitute the decision appealed against for any other decision which could have been made by the Licensing Authority, or remit the case to the Licensing Authority to dispose of it in accordance with the direction of the court. The court may make such Order for costs as it thinks fit.

- 4.5 The current Premises Licence (Annex B) permits the following licensable activities:
 - 1) The **Provision of Late Night Refreshment** between the following hours:

Sunday to Thursday 23:00 to 03:00 Friday and Saturday 23:00 to 04:00

2) The current **Opening Hours** are:

Sunday to Thursday 12:00 to 03.00 Friday and Saturday 12:00 to 04.00

- 4.6 The following **conditions** are attached to the Premises Licence:
 - Any individual employed to carry out a security activity must be licensed by the Security Industry Authority.
 - CCTV to be used and maintained inside and outside the premises. Recordings to be kept for a minimum period of one month.
 - Staff will clear litter from outside the premises including the street on every night that the premises is open for business.
 - No alcohol to be served.
- 4.7 A site plan is attached at **Annex C**.
- 4.8 In accordance with the requirements of the Act the applicant has served copies of the application upon the Licence Holder, Police, Fire Authority, Environmental Health, Development Control, Trading Standards, and the Child Protection Agency.
- 4.9 Notices were placed by the Licensing Officer outside the premises and in the public area of the Licensing Office at 9-10 Bath Street, Bath, BA1 1SN, for a period of 28 days.
- 4.10 A representation has been received from the Police in relation to the licensing objective of the prevention of crime and disorder. (Annex D). The representation suggests that a reduction in hours may be necessary but also recommends the imposition of the following condition:
 - "A minimum of two SIA registered doorstaff will be on duty at the premises from 23.00 hours until the end of licensable activities on Friday and Saturday each week to ensure good order in and outside of the premises."
- 4.11 A representation has been received from The Abbey Residents' Association in relation of the prevention of public nuisance licensing objective (Annex E).
- 4.12 A representation has also been received from a local resident in support of the premises (Annex F).
- 4.13 This report has not been sent to the Trades Union because they would have no involvement in this application.

- 1. My name is Diarmid Henry, I am employed by Bath & North East Somerset Council as an Environmental Health Officer within the Environmental Protection Team of the Council. This Team is designated a 'responsible authority' for the purposes of the Licensing Act 2003 and its main concern is 'the prevention of public nuisance'.
- 2. The Environmental Protection Team spends considerable effort consulting on licence applications in an attempt to ensure that the licensing objective of prevention of public nuisance is upheld. As part of this role, the Team makes representations to the licensing sub-committee where it believes that public nuisance is likely to occur as a result of the licensable activity. The team also investigates complaints of alleged statutory nuisance by virtue of the Environmental Protection Act 1990. In order for a noise to constitute a statutory nuisance, the noise must emanate from premises. In situations where a statutory nuisance exists the Council is obliged to serve an abatement notice requiring the nuisance to be abated. In situations such as that encountered with Bodrum Takeaway where the source of the noise is patrons on the pavement outside the premises, the Council is unable to take statutory nuisance action because the noise emanates from the public highway rather than premises which falls outside the scope of the Environmental Protection Act 1990. For this reason the only option available to the Environmental Protection Team to remedy the situation is to request a review of the premises licence.
- 3. A complaint of noise disturbance from Bodrum, 34 Broad Street, Bath was first received in July 2010, it was alleged by the complainant that noise from patrons of Bodrum regularly caused noise disturbance until 4:00am, particularly on Friday nights, Saturday nights and Monday nights. A second complaint was received in October 2010 from Mr. N. Stanley who lived opposite Bodrum Takeaway concerning excessive noise from patrons of Bodrum late at night, a copy of this letter of complaint is presented in Appendix A. A further complaint was received in December 2010 from Ms. C. Dent who also lives opposite Bodrum again alleging sleep disturbance as a result of late night noise associated with patrons of Bodrum. A copy of this letter of complaint is presented in Appendix B As part of the investigation, Ms. Dent was asked to keep a log of specific incidents of disturbance which occurred over the next four week period. Prior to this a letter had been sent to the manager of Bodrum to advise of the complaint and the procedure that would be followed by the Environmental Protection Team in investigating the matter further, a copy of this letter is presented in Appendix C. Ms. Dent then returned a completed log of incidents of disturbance which occurred in December 2010 and early January 2011, a copy of this log is presented in Appendix D.
- 4. To enable further investigation of the complaint, noise monitoring equipment was installed in Ms. Dent's home from 13 to 17 January 2011. The noise monitoring equipment consists of a Class 1 sound level meter housed within a locked case, a microphone fixed on a tripod is connected to this case along with a trigger switch which the complainant presses to make recordings of the noise being complained of. Prior to making any sound recordings the complainant had been instructed on how to operate the equipment and advised to ensure that any noise was in fact coming from Bodrum prior to making any recordings. Once the noise monitoring equipment was retrieved on 17 January 2011, the sound recordings were downloaded to a secure Council laptop using proprietary software. Sound recordings had been made from 14 to 16 January 2011 which demonstrated noise from loud shouting and screaming



occurring in the vicinity of Bodrum as late as 4:29am. A copy of these recordings is attached on CD marked Appendix E. In addition a log of the specific recordings made and notes of the content of these recordings is presented in Appendix F. In addition a copy of the log kept by Ms. Dent while making the sound recordings is presented in Appendix G

- 5. I visited Bodrum at 2:00am on Sunday 23 January 2011. At this time I observed six people sitting on the railings outside Bodrum eating and shouting loudly. I returned to Broad Street at 4:10am when I observed a male walking towards Bodrum talking loudly on his phone, I observed this male enter Bodrum at this time.
- 6. I installed noise monitoring equipment in Ms. Dent's home again from 4 to 7 February 2011, again I instructed the complainant on the operation of the equipment and explained the importance of verifying that the noise was coming from Bodrum prior to making any sound recordings. Once the noise monitoring equipment was retrieved on 7 February 2011, the sound recordings were downloaded to a secure Council laptop using proprietary software. Sound recordings had been made from 5 to 6 February 2011 which demonstrated noise from loud shouting and screaming occurring in the vicinity of Bodrum as late as 4:03am. A copy of these recordings is attached on CD marked Appendix E. In addition a log of the specific recordings made and notes of the content of these recordings is presented in Appendix H. A copy of the log kept by Ms. Dent while making the recordings is also presented in Appendix I.
- 7. I visited Broad Street, Bath again in the vicinity of Bodrum at 2.00am on Sunday 6 February 2011. At 2:10am, there were nine people sitting outside on the railings in front of the shop shouting and eating, two taxis stopped within minutes of each other to pick up patrons of Bodrum. At 2:15am there were twelve people outside with a number of males shouting "whoa" loudly and repeatedly. A taxi stopped again at 2:23am to pick up three girls who were shouting loudly. Two further taxis stopped at 2:27am and 2:31am to pick up further passengers. At 2:27am, there were five people sitting on the railings throwing food in the air, three people approached Bodrum minutes later shouting "is that the queue for food?" At 2:30am, there were approximately 15 people on the street in the immediate vicinity of Bodrum eating and shouting loudly. At 2:40am, a male could be heard screaming "f**king taxi," at this time there were approximately 16 people outside with one male repeatedly shouting "where's Jono?" A taxi also stopped at this time and four men approached shouting "let's get a f**king kebab," there were now approximately 25 people on the street outside Bodrum. At 2:35am two further taxis stopped and there were approximately 27 people on the street outside Bodrum.
- 8. At 2:45am four girls arrived at Bodrum and began shouting loudly, four additional people arrived at the premises and one of them began shouting "Jono!" At 2:47am a taxi arrived to pick up patrons of Bodrum, at this time a male was also shouting at two women very aggressively outside Bodrum, he then punched the window of a neighbouring shop. At 2:50am three taxis stopped to pick up patrons from Bodrum, at this time a male could be heard shouting "do you want it?" loudly and repeatedly at a female who began crying.
- 9. At 3:00am there were ten people outside, a group of four people became rowdy and one person shouted "every f**king one calm down." At 3:05am there were 15 people outside eating and talking loudly, there were also two people sitting on the

steps of a neighbouring shop eating and shouting. At 3:10am a further taxi stopped to pick up patrons of Bodrum, at this time a female was repeatedly screaming "f**k off." At 3:15am there were 15 people outside eating and shouting, at the same time three members of staff chased a customer towards the city centre on foot. At 3:20am, a taxi stopped, further taxis stopped again at 3:25am and 3:30am. At 3:35am there were 7 people outside eating, laughing and shouting. At 3:40am, there were nine people outside with one person shouting "f**k off," a taxi stopped to pick up patrons of Bodrum at 3:45am who left slamming the taxi doors. At 4:00am there were 6 people outside taking loudly and eating. Between 4:05am and 4:08am two taxis stopped to pick up patrons of Bodrum, there were also eight people outside taking loudly. At 4:05am 5 people went into Bodrum despite the premises only being licensed to provide late night refreshment until 4:00am on this day of the week. At 4:15am, there was loud shouting and talking coming from within Bodrum. At 4:15am, four people left Bodrum heading towards George Street shouting as they walked. The premise was still open at 4:30am when I left Broad Street.

- 10. As a result of the noise disturbance observed on 23 January 2011 I sent a letter to Mr. Ramazan Kolcak on 7 February 2011 to advise of the evidence gathered to date and my intention to apply for a review of the premises licence for Bodrum. A copy of this letter is presented in Appendix J. I was contacted by Mr. Kolcak on 9 February 2011 in relation to my correspondence of 7 February 2011. Mr. Kolcak said that the hours 2:00am - 4:00am were his busiest period and that to close earlier would "put him out of business." I explained that complaints of noise disturbance were continuing to be received and that in my view, it may be appropriate for the premises to close earlier particularly as the majority of people in Broad Street in the early hours of the morning were visiting Bodrum. I therefore explained that it was my view, that if Bodrum were not open so late that there would not be the noise disturbance which currently exists. Mr. Kolcak said that he did have a sign in the window asking patrons to be guiet but admitted that he had little or no effect in controlling the noise from people outside his premises. I finally explained the licence review process to Mr. Kolcak and stated that if the situation did not improve that this would be the only option to remedy the situation.
- 11. I visited Broad Street, Bath again in the vicinity of Bodrum on Friday 18 February 2011 at 12:10am At 12:15am it was generally quiet in the vicinity of Bodrum, four people walked down the street at 12:20am, at 12:25am two people left the premises quietly with food. Three females went into the premises at 12:30am, loud voices could be heard from within the premises. A few minutes later a further two females went into the premises with a third running towards Bodrum shouting then sitting on the railings outside the premises. At 12:35am two men approached a female sitting outside Bodrum; one of the men unzipped his trousers and approached the female. The female then began shouting "no one would touch that." The female continued to shout at the two males as they walked towards George Street. At 12:40am there were two females leaning on a neighbouring shop talking loudly. At 12:45am a female was waiting outside Bodrum shouting and crying. At 1:20am there were seven people outside talking loudly, at 1:30am there were three males sitting on the railings in front of the premises eating and talking loudly. At 1:50am two females entered Bodrum staggering and talking loudly. At 2:00am there were six people sitting on the railings eating, talking and laughing loudly.
- 12. A 2:05am a male customer came out of Bodrum and crossed the street to urinate in a shop doorway, he then crossed the street and went back into Bodrum. At

- 2:10am, a male was outside Bodrum talking loudly on the phone ordering a taxi. At 2:10am a taxi stopped to pick up passengers from outside Bodrum, at 2:15am five girls ran screaming towards Bodrum. At this time, there were nine people outside eating and talking loudly. At 2:25am a customer came out of Bodrum and urinated in the doorway of an adjacent property. At 2:30am there were four people outside Bodrum shouting across the street. At 2:45am two men walked into Bodrum shouting "prick, you're a f**king prick," one of the males then came out and urinated in a doorway of an adjacent property.
- 13. At 2:45am a male was sitting on the railings outside Bodrum talking loudly on his phone saying "Bodrum, wait till I get food" several times. At 2:57am four people went into Bodrum shouting "f**king hell." At 3.00am loud voices could be heard from within Bodrum, four people went into the premises at this time shouting "hello." At 3:03am five people went into Bodrum which is beyond the terminal hour for the provision of late night refreshment. There were three people sitting outside at 3:05am eating and talking loudly. At 3:07am two people went into Bodrum followed by another three people at 3:10am, at this time seven people came out of Bodrum talking loudly.
- 14. At 3:15am, a male lifted a female on top of the railings outside Bodrum and began simulating sex. At this time there were approximately fifteen people outside Bodrum shouting and laughing loudly. There were also two males on the opposite side of the street sitting in a doorway eating, these two males were shouting "Jamie f**ks me, la la," "Jamie takes it up the bum hole," "Jackie likes it hardcore." These phrases were shouted loudly and repeatedly.
- 15. At 3:17am a car stopped outside and the two occupants went into Bodrum, a further two people arrived and entered the premises. People began running back and fourth across the street shouting "Jamie." At 3:20am two people went into Bodrum. I left Broad Street at 3:25am at which time the premises was still open, in the half hour leading up to this the area became increasingly noisy with people shouting, swearing and wandering aimlessly in the middle of the road without any awareness of their surroundings. Between the hours of 2:00am and 3:25am I observed approximately 107 people walk past Bodrum, of this number 78 entered the premises and 29 walked past. Of the 29 who walked past the majority did so relatively quietly and on the opposite side of the street to Bodrum.
- 16. I made a final visit to Broad Street, Bath in vicinity of Bodrum on Sunday 20 February 2011 at 1:55am. At this time there were 6 people outside sitting on the railings eating and talking loudly. At 2:00am a male and a female collapsed in the street, three men came out of Bodrum and waked over to the man who had fallen and began to antagonise the man who had fallen. The police later arrived at the scene and diffused the situation. At 2:10am there were eighteen people outside Bodrum eating, laughing and shouting loudly. At 2:15am two taxis stopped to pick up passengers from Bodrum, a third taxi arrived behind and began sounding his car horn. At 2:20am, there were 14 people outside talking loudly and eating. At 2:25am five females left Bodrum talking loudly, however there were still approximately twenty people on the street outside the premises eating and talking loudly. At 2:30am a further six people entered Bodrum as a queue began to form at the entrance to the premises. At 2:35am three men were walking towards Bodrum one of whom went inside, one of the men was on the telephone shouting "doner kebab, get some food you f**king cow." At 2:40am, there were fifteen people outside the premises queuing to enter. At 2:45am there were twenty five people outside sitting on the railings and

standing in the road, eating and shouting loudly. At 2:50am a male walked along Broad Street with three other people screaming "Bebe" and entered Bodrum.

- 17. At 2:55am there were 14 people outside Bodrum shouting and singing. At 3.00am twenty six people arrived at Bodrum, at 3:05am a customer crossed the street to urinate in a doorway. At 3.10am there were eleven people outside talking and eating some of which began clapping hands. At 4:03am beyond the terminal hour of 4:00am on this day of the week for the provision of late night refreshment, a person went into Bodrum, at 4:12am, a taxi stopped outside Bodrum and left the engine running with music playing loudly within while the driver went into Bodrum. Another person entered Bodrum at 4:15am.
- 18. At 4:20am six people went into Bodrum, loud talking and shouting could be heard from within the premises. Loud talking and shouting could still be heard from within the premises at 4.25am as the door to the premises was still open. At 4:30am, five people exited the premises and sat down on the railings to eat talking loudly while booking a taxi. A taxi arrived at 4:40am with passengers slamming the doors as they left
- 19. Over the period from 1:55am to 4:25am approximately 18 taxis stopped to pick up customers waiting outside of Bodrum. With many of the taxis that left came the noise of slamming car doors which became a more prominent noise source as the night went on and the ambient noise levels became progressively quieter.
- 20. On Sunday 20 February 2011 between 1:55am and 4:25am, approximately 351 people walked past Bodrum, of this number 188 people entered Bodrum and 163 people walked past. As noted on previous occasions, the majority of people who walked past Bodrum did so on the opposite side of the street and with a small number of exceptions did so relatively quietly. Between 3:00am and 4:25am, approximately 112 people were observed walking past Bodrum of which 82 entered the premises and 30 walked past. This should be interpreted as a clear indication that later into the night an increasing number of people are drawn to Broad Street solely as a result of Bodrum being open so late.
- 21. In the view of the Environmental Protection Team late night noise disturbance occurs as a direct result of the activities of Bodrum. The premises licence holder has been contacted twice to advise of the disturbance which is occurring and the impact that this disturbance is having on neighbouring residential properties. The area of Broad Street in the vicinity of Bodrum was visited on four occasions and on all four occasions the premises was observed to be trading beyond the terminal hour stipulated in the premises licence for the provision of late night refreshment. It is the view of this Team that these practices present evidence of a lack of interest in upholding the licensing objective of 'prevention of public nuisance.' Furthermore it is the opinion of this Team that the premises licence holder is unable to control the noise arising from patrons visiting his premises late at night, an admission made by the premises licence holder during my telephone conversation with him on 9 February 2011. A sign is present in the window of the shop asking patrons to leave quietly, however this is ineffective based on the evidence of noise disturbance which has been obtained. The situation outside the premises late at light is exacerbated by the lack of inhibition of customers of Bodrum as a result of the consumption of alcohol earlier in the evening and the shear numbers of people that congregate outside the premises. This Team does not therefore believe there are any relevant conditions Page 21

which could be imposed to remedy this situation, therefore the only option in the Team's opinion to uphold the relevant licensing objective is to request that the hours permitted for the provision of late night refreshment be curtailed.

22. The Department for Culture Media and Sport state on their website that "Including late night take-away's and fast-food outlets in the Act extends the licensing regime which previously operated in most of London to all of England and Wales. It was felt this was necessary to protect local residents because premises which serve late night refreshment can be used by customers who may have been drinking at other premises earlier in the evening, thereby creating the potential for disorder on and near the premises. Also, because large numbers of customers may gather at places serving late night refreshments, there is a potential for nuisance and disturbance for local residents."

- 23. This statement therefore appears to acknowledge the detrimental impact that a late night takeaway can have on a residential community. It had been demonstrated by the monitoring visits undertaken that as the night draws on, the numbers of people passing along Broad Street to visit Bodrum increase over those passing-by. It therefore follows that if Bodrum were not open until such late hours that the disturbance currently experienced would not otherwise occur. While it may be argued that people passing along an urban street at night are likely to make noise as the effects of alcohol already consumed takes it affect, noise of this nature is transient and normally dissipates fairly quickly. In any event the monitoring visits demonstrated that members of the public not visiting Bodrum tended to walk past on the opposite side of the street and tended to pass by relatively quietly. In addition to the monitoring visits I have considered the sound recordings made by Ms. Dent in a neighbouring residential property to Bodrum. I have also considered additional noise log sheets kept by Ms. Dent through mid-January until 6 February 2011. A copy of these log sheets are presented in Appendix K.
- 24. The immediate vicinity of Bodrum has in fact become a make shift taxi rank as was observed by the relatively high numbers of taxis stopping outside the premises over a 1 to 2 hour period. Indeed the practice of waiting for taxis appears to exacerbate the noise disturbance which is occurring, while someone might otherwise order a take away and make their way home instead the food is consumed outside on the pavement while waiting for a taxi. In the brief isolated periods when there were no customers at Bodrum, the surrounding area was found to be extremely quiet except for passing traffic, there are no other licensed premises in the immediate vicinity of Bodrum which are open to such a late hour. Since the surrounding area becomes increasingly quiet with the onward passing of the night, any noise which occurs in the vicinity of Bodrum will have an increasing impact.
- 25. In considering the impact of Bodrum on the neighbouring residential community it is necessary to have regard to the character of the area. Importantly each situation must be considered on its own merits and the location of Broad Street within the city centre is a unique example. While people living in a city centre can certainly expect greater exposure to noise than people living in the countryside, there is a distinction in that the urban environment and particularly Broad Street in Bath after midnight during the week and an hour later at weekends becomes significantly quieter. This is influenced by a drop in traffic noise and the closure of shops, bars and restaurants in Page 22

the surrounding area. It must also be recognised that night time is the opportunity for people to sleep and with such low levels of noise, incidences of slamming taxi doors, shouting and singing in the street will undoubtedly result in significant noise nuisance to residents. A further letter of complaint was received from a resident of Broad Street in the vicinity of Bodrum on 9 February 2011, this complainant also kept a noise log of specific incidents of disturbance. A copy of this letter of complaint and noise log sheet is presented in Appendix L.

- 26. Ms. Dent came into the Council offices to listen to the sound recordings made from 14-16 January 2011 and 5-6 February 2011. Ms. Dent verified that the recordings which had been made were representative of the disturbance that had been experienced as a result of Bodrum. These recordings together with Ms. Dent's noise log sheets present an insight into the detrimental effect of the late night activities of Bodrum on a nearby resident. Ms. Dent also provided a statement of evidence detailing the impact the noise from Bodrum has had. A copy of this statement is presented in Appendix M.
- 27. There should not therefore be any doubt that the late night disturbance which occurs in Broad Street in the vicinity of Bodrum is as a direct result of provision of late night refreshment late into the night. If the premise was not open to such a late hour there would be no reason for people to congregate in this area of Broad Street for such long periods, furthermore based on the monitoring exercises carried out, there would appear to be a significant reduction in the number of persons passing along Broad Street if Bodrum were not open.
- 28. While I acknowledge the financial implications upon the licence holder of closing earlier in the evening, this should not come at the cost of exposing neighbouring residential properties to disturbance which can occur on a nightly and weekly basis in the vicinity of Bodrum up until as late as 4:45am, at a time when a great majority of the population expect to be able to sleep.
- 29. In support of the request to modify the conditions of the licence the Environmental Protection Team has had regard to the Neighbourhood Environment Services Enforcement Policy and in particular the principles of consistency, inspection, transparency and accountability in considering this action. Regard has also been had to the Council's Statement of Licensing Policy and in particular paragraph 36.2 which states, "Licensed premises have a significant potential to adversely impact on communities through public nuisances that arise from their operation. The licensing authority intends to maintain and protect the amenity of residents and other businesses from the potential adverse consequences of the operation of licensed premises whilst recognising the valuable cultural, social and business importance that such premises provide."
- 30. The Environmental Protection Team therefore respectfully submits that the licensing sub committee consider the serious nature of the evidence before them and exercise their power under section 52 of the Licensing Act 2003 to modify the conditions of the licence as follows:

Late Night Refreshment

Friday and Saturday

23:00 - 02:00

Sunday to Thursday 23:00 - 24:00



- 31. The hours requested above are based on the evidence that has been gathered in relation to noise disturbance which has been monitored by myself and the experiences of the complainants living in close proximity to Bodrum. Typically, the disturbance in the immediate vicinity of Bodrum is at its worst after 2:00am. In addition, by this time the majority of licensed premises in the immediate vicinity have closed. The Pig and Fiddle which is the closest licensed premises to Bodrum is licensed to sell alcohol until 2300 hours Monday to Thursday, until 12:30am on Friday and Saturday and until 10:30pm on Sunday. Belushi's are licensed to sell alcohol until 1:00am Monday to Saturday and 11:00pm on Sunday. However the Saracen's Head has the latest licensing hours on the street and are licensed to sell alcohol until 1:00am Monday to Thursday, until 2:00am on Friday and Saturday and until 11:00pm on Sunday. There are also two restaurants on Broad Street, namely Ask and La Tasca, both of which are licensed to sell alcohol until midnight, Monday to Saturday and until 11:30pm on Sunday. I also appreciate that all of these premises could be open an additional half hour until closing.
- 32. It is the Team's view that hours requested above are reasonable and are broadly similar to the hours permitted for other licensed premises in the immediate vicinity of Bodrum. It is also important to note that despite later licensed hours at other premises, the rest of Broad Street in the vicinity of Bodrum becomes very quiet shortly after midnight as was found by my monitoring visit on Friday 18 February 2011 from 12:10am until 3:25am. Given the close proximity of residential premises in the immediate vicinity of Bodrum such as the Milsom Place development, it is the Team's view that a terminal hour of 12:00am Sunday to Thursday is a reasonable request that reflects a balance between the rights of the business to operate and the expectations of neighbouring residents to be able to sleep undisturbed.
- 33. It is generally found that from midnight until approximately 2:00am that there is a relatively slow build up in the level of noise disturbance, however from 2:00am until 4:30am and beyond the disturbance can escalate in a rapid and sporadic manner. It is therefore the Team's view that a terminal hour of 2:00am on Friday and Saturday is a necessary request as this time does represent a watershed in terms of the noise disturbance which arises. On Friday 18 February 2011 and again on Sunday 20 February 2011, it was found that beyond 2:00am an increasing number of people on Broad Street were visiting Bodrum, a number of which caused significant disturbance. This is also the period in which the greatest disturbance was observed. It can therefore be interpreted from these findings that if Bodrum was not open beyond 2:00am that these people would have no reason to visit Broad Street. It then follows that such high levels of disturbance currently experienced would not occur.

Re Early hours noise outside Bodrum Kebab Shop, Broad Street

I have been a tenant at the above property since July and have rarely had a complete night's sleep without some disturbance.

The problem stems from the Bodrum Kebab Shop which stays open until around 4am. Most mornings, but particularly Friday, Saturday and Monday crowds gather outside the shop in the early hours. Whilst I do sleep with ear plugs in I am typically woken about 2am or 3am by drunks shouting or screaming, often at the tops of their voices.

I have politely asked the owners of the shop to ask their customers to be quieter but this has had no effect. Frankly they would have trouble controlling the 20 or 30 drunk young people who gather there so I can't imagine they have tried.

After the crowds leave around 3.30am there is normally the screeching sound of seagulls for a time as they descend to eat the food that has been dropped on the street.

Bodrum clearly provides a magnet for party goers after the pubs and clubs shut. This concentration makes the noise much worse than would come from any single drinking establishment.

I do find it unacceptable that the shop is allowed to stay open after midnight. The noise is much worse than from any pub so I do feel they should have similar restrictions placed upon them as would be the case for a pub.

I look forward to hearing from you and really hope you can do something about this.

I write to you with reference to the letter you will have received from my neighbour. I strongly support their comments about Bodrum Kebab Shop and am hoping that with my input on this, something will be done to restrict its opening hours.

Since I have lived in Milsom Apartments, Broad Street, I am continually woken by alarming and disturbing noise caused by patrons using the Bodrum Kebab Shop. For example, most nights-mornings particularly Monday, Thursday, Friday and Saturday around 1am to 4am; is violent abusive behaviour in the form of screaming, shouting, swearing, fighting, banging into things, cars collecting people playing loud music including loud bass, which sounds as though it could be playing in my apartment. All of this concentrated, uncontrolled noise from lots of people is extremely distressing, and interrupting my sleep.

It is unacceptable that Bodrum Kebab Shop is allowed to operate this late, attracting drunk people from clubs. It is a disgrace to Bath. I feel restrictions need to be put into place, similar to that of shops and pubs.

This Service has received a complaint concerning noise nuisance coming from your premises. It is alleged that you are allowing people to behave rowdily at your premises.

Although I cannot say if the complaint is justified or whether the information I have been given is accurate I would ask you to review your activities and ensure you take reasonable steps to prevent customers causing a noise nuisance to nearby residents.

At this stage the complainant has been asked to keep a written log of any further disturbances. If further complaints are made, noise monitoring equipment may be installed at the complainant's premises to record the events being complained of. Recordings may be used to justify formal action. In most cases you will not be notified of when the system will be present.

I would like to point out that where a nuisance is proved, the Council is obliged to serve a notice under the above Act requiring abatement of the nuisance and prohibiting a recurrence. It is an offence to fail to comply with a notice and a maximum fine of £20,000 may be imposed on conviction.

I have lived in Broad Street since 2005 and the period of disturbance is now at the point where it is unacceptable. I accept that when living in a city centre one has to be prepared for some noise, but it is now extending to beyond 04:00 AM at weekends.


From my bedroom window I often observe crowds of people outside the Bodrum takeaway, which stays open well beyond a reasonable time and often well beyond 03:00 AM. We have had countless problems associated with gangs of drunks shouting and fighting, including our door being kicked open and 2 broken windows. I have attached a map from the police website which shows Broad Street as the second highest problem area in the city based on police statistics so there is clearly a real issue which BANES is not addressing.

As a small vibrant city, Bath has a lot to offer and is a place for people to rightly enjoy in the evenings, but it is also home to many city centre residents who should be able to feel safe at night and expect things to quieten down at a reasonable hour.

My name is Carlie Dent, I have lived at 5 Milsom Place, Bath since May 2010. My home is on the opposite side of the street to Bodrum Take Away. I have experienced noise disturbance from Bodrum since moving in, however it took me some time to understand where the noise was coming from and why I was being awoken in the early hours of the morning. I complained to the Environmental Protection Team at Bath & North East Somerset Council on 2 December 2010 concerning the noise disturbance that I had been experiencing. I was contacted by an Environmental Health Officer and asked to complete a noise log sheet over the next few weeks detailing specific incidents of disturbance from Bodrum. I am able to see the front of Bodrum from my flat and so kept a log of incidents of noise disturbance from premises from 14 December 2010 until 12 January 2011. I recorded a number of incidents of noise disturbance over this period, which on several occasions lasted until approximately 3.45am. On one occasion on 20 December 2010, I experienced disturbance from 2.25am until 3.45am from shouting randomly, swearing

On the 4 January 2011, I was unable to get to sleep until 4.30am. An Environmental Health Officer installed noise monitoring equipment in the bedroom of my home from 13 to 17 January 2011. I received instruction on how to operate the equipment and made a number of recordings of noise disturbance once I verified the source as Bodrum. On the 14 January 2011 I was disturbed between 2.40am and 3.30am by intermittent shouting, arguing, crying and someone being sick. I noticed the next morning that my doorstep was covered in sick, lettuce and take away boxes. An Environmental Health Officer installed noise monitoring equipment in the bedroom of my home again from 4 to 7 February 2011. I received instruction again on how to operate the equipment and made a number of recordings of noise disturbance once I verified that the source as Bodrum. At 2.50am on Sunday 6 February 2011 I was disturbed by a man aggressively shouting at a girl, then I heard a loud bang on the shop window next door to Bodrum. I visited the Council Offices on 21 February 2011 to listen to the sound recordings that were made in my flat and can verify that they are representative of the noise that I experience in my home. The disturbance that I experience from Bodrum not only prevents me enjoying my home as I would wish but also deprives me of much needed sleep especially when I have to get up early for work. The disturbance occurs regularly and is sustained over several hours on a given night. I have resorted to wearing 3M ear fit plugs to try and get to sleep at night, however these have a limited effect and



The George Street area that runs at the northern end of Broad St. has a considerable number of licensed outlets. Takeaway premises experience has shown, coupled with persons who have consumed large amounts of alcohol provide a catalyst for crime and disorder and acts of anti social behaviour. The review applied for by the environmental protection team deals with the prevention of public nuisance. The Police have joined this review to give a perspective on the crime and disorder in and immediately outside of these premises. The Brief overview of incidents (Fig 1.) gives a breakdown of calls received, made by, day and time and recorded crimes that have resulted. The charts (Fig 2.) shows the days of the week Page 57

	Police receive calls relating to Bodrum, and the time of day calls are made. The log summaries are the calls that have been made and show a consistent number of calls and type of calls during the period the logs cover. The crime and disorder related to the premises is fuelled by persons who have been drinking in city centre venues, with some drinking to excess. It can be seen from the breakdown at (Fig 1.) that Bodrum staff make calls in respect of 50% of the incidents, this may show that they have difficulty in controlling their own customers. There is evidence to show that most incidents occur between 0300 and 0400 and the committee may feel that a reduction of the hours may be the only option to further the crime and disorder objective, as well as a requirement to have SIA registered staff to maintain good order at and immediately outside of the premises.





The Abbey Residents Association has about three hundred members including a number in the vicinity of the Bodrum Takeaway and seeks to improve conditions for those living in the city centre

.We were very pleased to see the excellent work that Environmental Protection done in gathering detailed evidence about the nuisance associated with these premises. Broad Street has a long history of noise and disorder associated with crowds moving down form the clubs and bars in George Street. The Bodrum Takeaway adds to this by:

- -attracting drinkers to walk through the increasingly residential Broad Street in preference to other less residential routes
- encouraging crowds to gather and loiter near residential units
- encouraging crowds to loiter on relatively narrow pavements on a street which is a well-used route for cars leaving the city

We do not as an association have the resources to undertake the sort of evidence gathering that Environmental protection have done but we are in receipt of regular expressions of concern by residents. As part of a regular programme of city centre reviews we did visit the area just after 12:30 am on the 14th March and 1:00 am on the 20th March.

On the 14th there were approximately 6 people sitting and standing on and around the barrier outside these premises eating food and making considerable noise until two PC arrived to talk to them

On the 20th we saw a man putting a ground sheet in the doorway of the premises next to Bodrum were he sat and fed his takeaway purchase to his dog. While we continued to watch a party of 20 to 25 revellers came down the street, both in the road and on the pavement, from George Street shouting loudly. The entire party then packed, or at least tried to, into the Bodrum Takeaway.

We entirely support Environmental Protection's call for the hours of these premises to be restricted. Indeed we would ask the committee to consider whether in the light of their evidence their recommendations on closing times go far enough
