RESOLVED that the minutes of the meeting of Tuesday 7th February 2012 be confirmed as a correct record and signed by the Chair(person).

42 LICENSING PROCEDURE - APPLICATIONS FOR LICENCES, PERMITS AND CONSENTS (EXCLUDING HACKNEY CARRIAGE, PRIVATE HIRE AND SEX ESTABLISHMENT MATTERS)

RESOLVED that the procedure for the meeting be noted.

43 APPLICATION FOR PERMISSION TO PROVIDE FACILITIES ON THE HIGHWAY FOR RECREATION/REFRESHMENT AT MOLES BATH LTD, 14 GEORGE STREET, BATH.

The Sub-Committee considered the report which sought consideration of an application for permission to provide facilities on the highway in respect of Moles Bath Ltd., 14 George Street, Bath, BA1 2EN.

The applicant was present. He confirmed he had read and understood the procedure for the meeting. A representative of one of the objectors was also present.

The Licensing Officer presented the report. He confirmed the application was for 5 tables and 10 chairs. He stated that there had been 3 objections in relation to public nuisance.

The applicant put his case and was questioned. He stated that the hours of operation should be every day 11.00 - 21.00 to be in line with the planning consent, not 22.00 as stated on the application form. He informed the meeting that having spoken to 2 of the objectors they had now withdrawn their objections. He assured the meeting that he was committed to helping residents and wanted to encourage responsible behaviour in his patrons.

Dee Moss, spoke on behalf of Sheila Lamble, one of the objectors and put her case and was questioned. She concluded by stating that Ms Lamble would be happy to support the application if the applicant honoured his responsibilities in respect of his licence.

The applicant made his closing statement.

Following an adjournment it was

RESOLVED that the application for permission to provide facilities on the highway in respect of Moles Bath Ltd., 14 George Street, Bath, BA1 2EN, be granted subject to the standard conditions.

Reasons for decision

Members have determined an application for permission to place tables and chairs on the highway at Moles, 14 George Street, Bath.

Members took into account the Local Government (Miscellaneous Provisions) Act 1982, Part VIIA Highways Act 1980 and the Human Rights Act 1998.

Members considered the application and noted that two of the objections had been withdrawn. They considered the remaining written objection and the letter in response to the objections from the applicant. They listened carefully to the oral representations and balanced the interests of the applicant, the objector and the general public.

Members noted that the objection had been made on the basis of alleged anti-social behaviour and littering in association with the premises when it was being operated as a nightclub. They considered that these were issues that fell under the provisions of the Licensing Act 2003 and, if the objector had concerns with the way that the premises were run, they should complain to the Licensing Authority.

Members listened to what the applicant said as regards the operation of the tables and chairs permission. They also noted that, if permission was granted, the applicant would have to adhere to Standard Condition 9 which requires that the

holder of the permission shall not do or suffer anything to be done in or on the highway which, in the opinion the Council, would cause nuisance, annoyance or cause damage or inconvenience, to the Council, or owners or occupiers of any adjacent or neighbouring premises or to members of the public. Members also noted that there had not been any objections to the application from Highways.

Members were assured by what the applicant had stated as to how the premises would operate and that he had adequately addressed the objector's concerns. They therefore granted the permission in the terms set out in the application with the amendment to the terminal hour of 9.00pm (21.00) each day in accordance with the planning permission.

Licensing (Taxis, Street Trading & Miscellaneous) Sub-Committee Procedure for Applications for Licences, Permits and Consents (excluding Hackney Carriage, Private Hire and Sex Establishment matters)

- 1. The Chair will introduce Members of the Sub-Committee, introduce the Officers present, explain the procedure to be followed and ensure those present understand that procedure.
- 2. The Licensing Officer will outline the nature of the matter to be considered by the Sub-Committee.
- 3. The Applicant (or his/her representative) addresses the Sub-Committee.
- 4. The Applicant may be asked questions by the Sub-Committee and other interested parties.
- 5. The Applicant (or his/her representative) may call witnesses in support of their case and each witness may be asked questions by the Sub-Committee and other interested parties.
- 6. The Chair will ask the Licensing Officer whether they have any comments to make and invite any statutory consultee present to address the Sub-Committee. The Sub-Committee may ask questions of Licensing Officers and or consultees.
- 7. (i) Any objectors will take it in turn to address the Sub-Committee and may be asked questions by the Sub-Committee, the Applicant and other interested parties.

 (ii) Objectors may call witnesses in support of their representations and each witness may be asked questions by the Sub-Committee, the Applicant and other interested
- 8. Objectors and any other parties making representations will be invited to make a closing statement.
- 9. The Applicant will be invited to make a closing statement.
- 10. The Sub-Committee withdraw to private session to consider their decision. The Sub-Committee may reconvene to resolve any points of uncertainty on matters already raised. The Sub-Committee will be accompanied for advice only by the Legal Adviser and Democratic Services Officer.
- 11. The Sub-Committee will return to the meeting room and the Chair will announce the Sub-Committee's decision with reasons and advise that the decision will be released in writing within the statutory time limits.
- 12. Where the Sub-Committee attach conditions to the licence the Sub-Committee will detail those conditions.

PLEASE NOTE:

parties.

- Where the Sub-Committee considers it necessary the procedure may be varied.
- In circumstances where any party fails to attend the Sub-Committee will consider whether to proceed in that party's absence or defer to the next meeting on notice to all parties that the matter may proceed in a parties absence on the next occasion. In

deciding whether to proceed all notices and representations will be considered.

- Only in <u>exceptional circumstances</u> will the Sub-Committee take into account any additional late documentary or other information produced by an existing party in support of their application/representation. This will be at the discretion of the Chair and with the agreement of all the other parties. No new representations will be allowed at the hearing.
- The Sub–Committee will disregard any information or representation given by a party they consider not to be relevant to an Application.
- The hearing will take the form of a discussion and the Sub-Committee will allow all parties to ask questions of other parties present. However, formal cross examination will be discouraged although supplementary questions may be asked for clarification purposes.
- If any person has special needs regarding access, hearing or vision, this should be brought to the Licensing Authority's attention prior to the hearing in order that reasonable adjustments can be made.
- Parties will be allowed an equal maximum period of time to make representations.
 Although time limits will be at the discretion of the Chair, in the interests of costs and efficiency, this will not normally exceed <u>twenty minutes</u> and will include both case presentation and summing up. The time limit will not include the time taken for questions.

N.B.

- 1. Where there is more than one party making relevant representations the time allocated will be split between those parties and it is therefore recommended parties arrive early to discuss the application with other interested parties.
- 2. Where several parties make the same or similar representations one representative should be appointed to make the representations.
- 3. Where an objection is made by an association or local residents group, a duly authorised person as notified to the Licensing authority may speak on behalf of that association or local residents group.
- The Chair may require any person attending the hearing who is behaving in a disruptive manner to leave the hearing and refuse to allow that person to return, or only allow them to return subject to certain conditions. Any person so excluded will however be entitled to submit to the Sub-Committee any information which they would have been entitled to give orally had they not been required to leave.
- Bath & North East Somerset Council is committed to taking decisions in an honest, accountable and transparent fashion, but on occasion may find it necessary to exclude members of the press and public based upon the legal framework given in the Local Government Act 1972 Schedule 12 (a). On these occasions decisions based on the above framework will be given.

1 THE ISSUE

1.1 An application has been received for permission to provide facilities on the highway in respect of Searcy's Restaurant, Pump Rooms, Abbey Churchyard, Bath.

RECOMMENDATION 2

2.1 That the Licensing (Taxis, Street Trading and Miscellaneous) Sub Committee determines the application.

3 FINANCIAL IMPLICATIONS

3.1 There are no financial implications arising from this report.

4 THE REPORT

- 4.1 An application has been received for permission to provide facilities on the highway in respect of Searcy's Restaurant Pump Room Abbey Churchyard Bath (Annex A).
- 4.2 The application is for permission to place 8 tables on the highway outside the premises, along with appropriate seating (site plan attached at Annex B).
- 4.3 The size of the area applied for is 19 m x 3 m (which includes a chalet - D 2 m x W 4 m x H 1.95 m).

- 4.4 The times applied for are:
 - Every Day from 09:00 to 22:00 hours.
- 4.5 Sections 115 A-K were inserted into the Highways Act 1980 by the Local Government (Miscellaneous Provisions) Act 1982 and relate to the provision of Amenities on certain highways.
- 4.6 Upon application the Council may grant permission to provide, maintain and operate facilities for recreation and/or refreshment on a highway.
- 4.7 A grant of permission under Section 115E of the Highways Act 1980 is not to be unreasonably withheld but permissions may be given subject to any reasonable conditions that the Council thinks fit, Section 115J of the Highways Act 1980.
- 4.8 The Council's standard conditions for permission to place tables and chairs on the highway are attached at Annex C.
- 4.9 This report has not been sent to the Trades Union because they would have no involvement in this application.
- 4.10 A notice was placed on the highway on 22 February 2012 (Annex D). The application was also placed on the Council's website.
- 4.11 Six objections have been received. Some of the allegations are that the tables and chairs "have hindered artists from performing in the Abbey Churchyard", and that "there are thousands of places in England where people can eat and drink sitting outside" (copies attached at Annex E).

5 RISK MANAGEMENT

5.1 A risk assessment related to the issue and recommendations has been undertaken in accordance with the Council's decision making risk assessment guidance.

6 EQUALITIES

6.1 An Equality Impact Assessment (EqIA) has been completed. No adverse or other significant issues were found.

7 CONSULTATION

7.1 In accordance with current Bath & North East Somerset Council policy, the Licensing Service consulted with the Police, the Council's Highways Maintenance Services, Property Services and Development Control Services, Ward Councillors and affected frontagers.



LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1982 PART VIIA HIGHWAYS ACT 1980 PERMISSION TO PLACE TABLES AND CHAIRS ON THE HIGHWAY

CONDITIONS

- The holder(s) of this Permission shall not exercise privileges granted by this Permission otherwise than strictly in accordance with this Permission.
- The holder(s) shall produce this Permission on demand when so required by a Police Officer or a duly authorised Officer of the Bath & North East Somerset Council.
- The holder(s) shall return this Permission to the Office of the Head of Environmental and Consumer Services, 9/10 Bath Street, Bath, BA1 1SN immediately on revocation of this Permission.
- The holder(s) shall not cause any unnecessary obstruction of the highways or danger to persons using it and shall not permit persons to gather so as to cause a nuisance or annoyance or danger to any persons lawfully using the highway.
- The holder(s) shall not use or suffer or permit any music playing music reproduction or sound amplification apparatus or any musical instruments, radio or television receiving sets whilst exercising privileges granted by this Permission.
- The holder(s) shall not make any excavations or indentations of any description whatsoever in the surface of the highway or place or fix any equipment of any description in the said surface.
- The holder(s) shall not use the highway for any other purpose whatsoever nor at any time other than during the permitted hours, other than lawfully passing or re-passing thereover as (a) member(s) or the public.
- The holder(s) shall not place on the highway any furniture or equipment or advertisement other than as permitted by the Council and must maintain the same in a clean and tidy condition and not place them so as to obstruct the entrance to or exit from any premises.
- Notwithstanding the specific requirement in Condition 5 above the holder(s) shall not do or suffer anything to be done in or on the highway which in the opinion of the Bath & North East Somerset Council may be or become a danger, nuisance or annoyance to or cause damage or inconvenience to the said Council or to the owners or occupiers of any adjacent or neighbouring premises or to members of the public.
- The holder(s) shall not assign, underlet or part with any interest or possession given by this Permission or any part thereof but the holder(s) may surrender it at any time.
- The holder(s) shall observe and comply with any directions in relation to the use of the highway given by the Head of Environmental and Consumer Services, or the Head of Engineering Services for the time being of the Bath & North East Somerset Council.
- The holder(s) shall maintain the area shown on the plan attached to this Permission and edged in red, and the immediately adjacent area, in a clean and tidy condition during the permitted hours and shall leave the same in a clean and tidy condition and unobstructed, which shall include washing down the area, at the end of each daily period of use and on revocation or surrender of this Permission.

- The holder(s) shall provide litter bins or similar receptacles for the deposit of cartons, wrappers, containers and similar discarded items if required by the Head of Engineering Services and ensure that the same are emptied daily.
- The holder(s) shall remove all furniture or equipment, litter bins or other articles placed on the highway in accordance with this Permission at the expiry, surrender or revocation of the Permission.
- The holder(s) shall indemnify and save harmless the Bath & North East Somerset Council their agents, servants and workmen from and against all proceedings, claims, damages, costs or expenses in respect of any injury (including personal injury) in damage or loss which may be sustained by the Council or any person or persons, body or company whatever arising out of or in any way connected with the provision or use of facilities under this Permission, accept where such injury, damage or loss is attributable to the negligence of the Council.
- This Permission may be revoked by the Bath & North East Somerset Council at any time and the Bath & North East Somerset Council shall not in any circumstances whatsoever be liable to pay any compensation to the holder(s) in respect of such revocation.
- Nothing herein contained shall be construed as the granting or purported granting by the council of any tenancy under the Landlord and Tenant Act 1954 or any permission under the Town and Country Planning Act 1971 or any statutory modification or re-enactment thereof for the time being in force.
- The holder shall, whilst members of the public are using the facilities provided for the consumption of intoxicating liquor, provide and maintain in a prominent position, to the satisfaction of the Council's Head of Environmental and Consumer Services, notices in the form approved by him concerning the provisions of the Byelaw made by the Bath City Council on 30th January 1991 relating to the consumption of intoxicating liquor in public places.

Notes:

- 1 Section 115K of the Highways Act 1980 provides as follows:-
 - (1) If it appears to a council that a person to whom they have granted a permission under section 115E of this Act has committed any breach of the terms of that permission, they may serve a notice on him requiring him to take such steps to remedy the breach as are specified in the notice within such time as is so specified.
 - (2) If a person on whom a notice is served under sub-section (1) of this Act fails to comply with the notice, the council may take the steps themselves.
 - (3) Where a council have incurred expenses in the exercise of the power conferred on them by sub-section (2) of this Act, those expenses, together with interest at such reasonable rate as the council may determine from the date of service of a notice of demand for the expenses, may be recovered by the council from the person on whom the notice under sub-section (1) of this Act was served.

I refer to the application made by Searcy's Restaurant to put tables and chairs outside the Pump Rooms in the Abbey Churchyard. Since 1984 this has been a prime venue for street entertainers whose professional interests Equity represents. I understand that the restaurant has previously made this application and that local performers objected to it, as it prevented them for performing in what is a very lucrative spot. A compromise was reached through your good offices that the tables and chairs would not be placed more than two metres from the property, thus allowing sufficient performancespace remaining in the church yard. However the owners of the restaurant last summer extended that radius without permission to nearly twice the agreed distance thus curtailing the performance space almost entirely. They did this in a very unfriendly manner by employing security gurads to protect their extended boundary.

Given the lack of respect by the restaurant owners to the decision made by the Licensing Section I have been asked to contact you this year to raise a formal objection to this application. We have severe misgivings about any compromise in this matter, as it is clear the restaurant cannot be trusted to keep to it. If you are minded to agree the application on the same basis as last year we would have to ask, how would it be policed and what remedy will the performers have if their "stage" area is invaded as it was in 2011.

I am happy to come and talk to you about this if necessary as the professionals I represent feel very strongly about this matter.

I object most strongly to this application for tables and chairs. I can not put my objections any clearer than to echo a letter of objection already submitted which is copied below.

All I have to add to this letter is that I was one of the very few who struggled to perform in this space last year and found it unworkable. I tried to persevere with a smaller scale show as a matter of principle and to attempt to protect this very unique performance space. Added to the problem of lack of space was the aggressive policing of the placement of the advertising barrier erected around the tables and chairs by the restaurant management and the pump room security staff. I only managed to carry on through the season due to a passion for the genre and this rare performance space. Add to this the advertising boards put out by the establishments opposite I felt like I had to struggle through against strong disapproval and was exceedingly drained by the experience. This with a much reduced scale show.

I now copy the letter already submitted:

These tables and chairs have hindered artists from performing in the Abbey Churchyard by taking up the area in which they perform.

Artists have been performing in the Abbey Churchyard for more then 25 years.

These performances are a valuable asset to Bath especially as a tourist attraction.

The golden era of St performing in Bath was when there were no tables and chairs outside the Pump Room. Bath used to enjoy having the best artists in the world coming to perform here as well as the best in local talent.

Since the Pump Room have extended the restaurant outside, the best in the world no longer came here and while some of the local talent have struggled to perform in a constricted space much of that talent have moved away.

Originally the restaurant was given an area of up to 2 metres from the Pump Room building in which to put their furniture. Studs were put into the paving slabs to show the boundary point. The studs are still there to see.

Last year in July the restaurant moved their tables and chairs a distance of 3.54 metres from the building and put a barrier around them effectively stopping anyone from performing in the Abbey Churchyard.

There are thousands of places in England where people can eat and drink sitting outside. There are only a few places, maybe half a dozen where you can enjoy and experience a quality Street show. One of these places, the best outside of Covent Garden is Bath Abbey Churchyard, if the artist has space in which to perform.

Bath has a rich history of street performing and the licensing of tables and chairs will cover what is considered to be one of the best "pitches" in the country. I know full well that there are many people opposed to it being used for such a purpose but the number of spectators at each show can only show the huge demand that there is for such entertainment from the majority.

Street performing helps to enliven the environment and create a unique atmosphere, which can only help to differentiate Bath as a 'destination' City when it comes to making a choice between shopping town centres. In these days of the homogenisation of the look of High Streets across the country with the same chains stores, retail outlets and branded restaurant appearing almost in the same configurations, *everything* that can help Bath look different and more attractive to shoppers and visitors must be of benefit.

It saddens me that a City that is home to two internationally recognised and acclaimed street performing groups in the shape of The Natural Theatre Company and Bizarre Bath, many of whose performers first performed and busked on the streets of Bath, is effectively eliminating one of the areas where street performing can take place in the City.







Licensing (Taxis, Street Trading & Miscellaneous) Sub Committee Hackney Carriage (taxi) and Private Hire Drivers Hearing Procedure

- 1. The Chair will introduce Members of the Sub-Committee, introduce the Officers present, explain the procedure to be followed and ensure those present understand that procedure.
- 2. The Licensing Officer will outline the nature of the matter to be considered by the Sub-Committee.
- 3. The Applicant is asked to leave the room while the Sub-Committee consider the CRB check, references and statement.
- 4. The Applicant (or his/her representative) addresses the Sub-Committee.
- 5. The Applicant may be asked questions about the matter by the Sub-Committee.
- 6. The Applicant (or his/her representative) may call witnesses in support of their case and each witness may also be asked questions.
- 7. The Chair will ask the Licensing Officers present whether they wish to make any comments. If the Officers makes comment they may be asked questions.
- 8. The Applicant will be invited to make a closing statement.
- 9. The Sub-Committee withdraw to private session to consider their decision. The Sub-Committee may reconvene to resolve any points of uncertainty on matters already raised. The Sub-Committee will be accompanied for advice only by the Legal Adviser and Democratic Services Officer.
- 10. The Sub-Committee will return to the meeting room and the Chair will announce the Sub-Committee's decision with reasons and advise that the decision will be released in writing within the statutory time limits.
- 11. Where the Sub-Committee attach conditions to the licence the Sub-Committee will detail those conditions.

PLEASE NOTE:

- Where the Sub-Committee considers it necessary the procedure may be varied.
- In circumstances where any party fails to attend the Sub-Committee will
 consider whether to proceed in that party's absence or defer to the next
 meeting on notice to all parties that the matter may proceed in a parties
 absence on the next occasion. In deciding whether to proceed all notices and
 representations will be considered.
- Only in <u>exceptional circumstances</u> will the Sub-Committee take into account any additional late documentary or other information produced by an existing

party in support of their application/representation. This will be at the discretion of the Chair and with the agreement of all the other parties. No new representations will be allowed at the hearing.

- The Sub-Committee will disregard any information or representation given by a party they consider not to be relevant to an Application.
- The hearing will take the form of a discussion and the Sub-Committee will allow all parties to ask questions of other parties present. However, formal cross examination will be discouraged although supplementary questions may be asked for clarification purposes.
- If any person has special needs regarding access, hearing or vision, this should be brought to the Licensing Authority's attention prior to the hearing in order that reasonable adjustments can be made.
- Parties will be allowed an equal maximum period of time to make representations. Although time limits will be at the discretion of the Chair, in the interests of costs and efficiency, this will not normally exceed <u>twenty</u> <u>minutes</u> and will include both case presentation and summing up. The time limit will not include the time taken for questions.

N.B.

- Where there is more than one party making relevant representations
 the time allocated will be split between those parties and it is therefore
 recommended parties arrive early to discuss the application with other
 interested parties.
- 2. Where several parties make the same or similar representations one representative should be appointed to make the representations.
- 3. Where an objection is made by an association or local residents group, a duly authorised person as notified to the Licensing authority may speak on behalf of that association or local residents group.
