1 EMERGENCY EVACUATION PROCEDURE

The Democratic Services Officer read out the procedure.

2 ELECTION OF VICE-CHAIR (IF DESIRED)

RESOLVED that a Vice-Chair was not required on this occasion.

3 APOLOGIES FOR ABSENCE AND SUBSTITUTIONS

There were none.

4 DECLARATIONS OF INTEREST

There were none.

5 TO ANNOUNCE ANY URGENT BUSINESS AGREED BY THE CHAIR

There was none.

6 MINUTES: 15 SEPTEMBER 2011

These were approved as a correct record and signed by the Chair.

7 LICENSING PROCEDURE

The Chair drew attention to the licensing procedure, copies of which had been made available to those attending the meeting.

8 APPLICATION FOR A PREMISES LICENCE FOR TEMPLE INN, MAIN ROAD, TEMPLE CLOUD, BRISTOL BS39 5DA

Applicant: Duncan Sheen

<u>Responsible Authorities</u>: Avon and Somerset Police, represented by Martin Purchase (Liquor Licensing Officer)

Interested Parties: Mr and Mrs Osborne, Mr and Mrs Dean

The Licensing Officer summarised the application. The licensable activities and hours applied for were set out in paragraph 4.2 of her report. The Police had proposed additional conditions, to which the applicant had agreed in writing.

Mr Sheen stated his case. He said that he had taken over the management of the Temple Inn in October 2010. He was the owner of the business that operated the premises, but he did not own the premises. The premises owner had gone into administration and he was considering purchasing the building. Before making his application he had had talks with the Police, Licensing Officers, the Fire Authority and other agencies. A new licence was required rather than a variation because of the number of changes he wished to make. The hours on the current licence were very restricted and the sale of alcohol was permitted only in the main pub building and not in the detached function room. The ordinary operation of the pub was losing money, but he had found that he made money with special events. However, he had used his full quota of Temporary Event Notices. There was a black and white CCTV system, but the Police had recommended the installation of a new colour system, which would cost £2,000. He could retain the old CCTV system if events only took place occasionally. However, to be financially viable, the pub needed to provide regulated entertainment as a standard feature. There were two local skittles teams and three pool teams who used the premises. Because skittles matches were held in the function room, which was not covered by the current licence, members of the skittles teams had to purchase drinks in the main pub and then carry them to the function room, which was inconvenient. There had been no complaints made by residents when events had been held at the premises, though when this application had been advertised someone had said that he thought that he had been disturbed by noise on one night. In fact there had been no event on the night he mentioned.

In response to a question from Mr Purchase, Mr Sheen said that he would accept the suggestion from the Police that the non-standard times for Christmas Eve, Christmas Day and Boxing should be deleted from the application, though by an oversight he had failed to state this in his letter to Mr Purchase of 28th September 2011.

Mr Dean asked whether it would be possible to stop customers going outside to smoke from taking drinks with them. The Licensing Officer drew attention to the condition proposed by the Police that prohibited alcohol being sold or consumed in the garden and all outside areas beyond 11pm each day.

Mrs Osborne asked Mr Sheen why he wished to change the character of a quiet village pub. Mr Dean replied that he had no intention of changing the character of the pub. The fact was that Temple Cloud once had four pubs and now had only one, which at present was dying on its feet. He had found that people came to the premises in sufficient numbers to make it profitable when events were held. When a petition in favour of the application had been placed in the bar, it had been signed by 100 people in one week, whereas the petition against the application had only received 9 signatures in a month. Since he had been running the premises most customers came from Temple Cloud and Farrington Gurney, though people from other villages came as well.

Mr Dean asked why the local bingo club had been locked out of the premises, leaving people knocking at the door for an hour. Mr Sheen said that this was not the case. The bingo club had been organised by the wife of the previous landlord.

People attending bingo sessions had been charged 25p for a cup of tea, producing an income of not more than £4.50 from a session, which was completely uneconomic. He had spoken to the lady who was running the club and given her notice that it would be discontinued. Under the previous landlord there were other uneconomic activities, such as providing the Carnival Club with free tea and coffee. He submitted that these issues had no relevance to the current application.

Mr Osborne asked why the premises needed later hours. He said that people dispersed slowly after closing time, sometimes lingering for up to an hour, which meant that residents faced the prospect of disturbance until 2.30-3.30am. Mr Sheen replied that other licensed premises in the area already had the hours for which he was applying.

A Member asked Mr Sheen whether the additional activities and hours for which he was applying would give him a chance of running a viable business. Mr Sheen replied that he thought they would. He had already used the maximum number of Temporary Event Notices he was permitted, and on each occasion he had made money. There had been live music, recorded music, discos and karaoke without any complaints being received. He also submitted there was more noise at night in the vicinity than many people might think. The A37 ran past the front of the pub, and he had counted that between 1am and 2am a lorry passed the premises on average every 4 minutes. Another road licensed for use by articulated lorries ran along the side of the pub. Nearby there was a site operated by BT, which was very busy at night.

The Interested Parties stated their cases.

Mrs Dean said that she thought the hours proposed for licensable activities were unreasonable in a small village like Temple Cloud. She thought that the hours should be in line with those of the other pubs. Mr Sheen responded that the Temple Inn was the only remaining pub in Temple Cloud and that pubs in neighbouring villages already had the hours and activities for which he was applying.

Mr Osborne said that he did not wish to deny the applicant the opportunity of making a living. However, Temple Cloud was a small village. He thought that customers would be more likely to come from other villages than from Temple Cloud and was concerned about the potential for disturbance and interrupted sleep for local residents.

A Member asked him how many times he had been disturbed when events had been held under Temporary Event Notices. He replied that he did not know how many events had been held under Temporary Event Notices.

A Member asked Mr Osborne whether he thought that the applicant might be able to control smokers outside the premises so that they did not create a disturbance. Mr Osborne replied that he thought that the best solution would be reasonable hours.

Mr Purchase asked Mr Osborne whether he seen the conditions agreed between the Police and the applicant. Mr Osborne said that he had not, and Mr Purchase provided him with a copy. The Senior Legal Adviser advised Mr Osborne that the Sub-Committee had the power to impose restrictions on the hours for consumption

of alcohol outside the premises. Mr Osborne commented that making rules was one thing, enforcement another.

Mr Sheen noted that Mr Osborne had stated in his written representation that he had not suffered disturbance since the premises had changed hands. Mr Osborne agreed that he had not suffered disturbance since Mr Sheen had taken over, though he had done when the premises had been under the previous landlord.

Mr Purchase stated the case for the Police. He invited the Sub-Committee to give careful attention to the proposed conditions agreed between the applicant and the Police. He believed that they addressed many of the concerns expressed by residents.

The parties were invited to sum up.

Mr Sheen said that the statements made by Interested Parties revealed ignorance that were once 4 pubs in the village and that 3 of them had closed. The premises needed this application to survive and there were many residents who wanted it to survive. There had been no complaints since he had been running the premises, as confirmed by one of the Interested Parties in his written representation. He had used all the Temporary Event Notices available to him, yet one of the Interested Parties had been unable to say how many events had taken place at the premises.

Mr Dean said the main concern of residents were the proposed hours. People did not always disperse quickly after closing. There was sometimes disturbance at 2am. It was not always easy to identify the source, but he did not think that he had ever heard a lorry late at night. He believed that a terminal hour of 1.30am was just too late for a village pub.

Following an adjournment it was **RESOLVED** to grant the licence as applied for subject to the modifications relating to the non-standard timings proposed on the application, by the removal of any timings relating specifically to Christmas, together with the mandatory conditions (related to the sale of alcohol, the exhibition of films, door supervisors, the prevention of irresponsible drinks promotions, the dispensing of alcohol directly by one person directly into the mouth of another, free tap water, age verification policy, and the availability of alcohol in smaller measures) conditions consistent with the Operating Schedule and all conditions proposed by the Police, namely:

- 1 A CCTV system will be installed and maintained at the premise in consultation with the police. The images will be of evidential standard and recordings will be kept for 31 days and made available to the police on reasonable request. Notices are to be displayed at the premises stating that cctv is in operation.
- 2 The garden and all outside areas will not be used for the sale or consumption of alcohol beyond 11pm each day.
- 3 All staff to receive training related to alcohol sales and refresher training to be given at 6 monthly intervals. A record will be maintained of all persons trained. This record will be kept at the premises and made available to the police and licensing authority on request.

- 4 All refused sales are to be recorded together with the reasons for their refusal. This record to be kept at the premises and made available to the police and licensing authority on request.
- 5 At the written request of the police or following a risk assessment by the DPS, SIA door supervisors will supervise all patrons entering the premises, ensure good order and ensure patrons leave in a quiet and orderly manner. They will wear yellow reflective jackets at all times whilst on duty.
- 6 Noise shall not emanate from the premises so as to cause a nuisance at the façade of the nearest noise sensitive premises.
- 7 The function room will only be used for pre-arranged functions and activities and will not operate for licensable activities after midnight each day.

Authority was delegated to the Licensing Officer to issue the licence accordingly.

REASONS

Members have today determined an application for a new Premises Licence for Temple Inn, Main Road, Temple Cloud, Bristol. In doing so they have reminded themselves of the Licensing Act 2003, Statutory Guidance, the Council's Statement of Licensing Policy and the Human Rights Act 1998.

Members are aware that the proper approach under the Licensing Act is to be reluctant to regulate in the absence of evidence and that they must only do what is necessary and proportionate to promote the licensing objectives based on the evidence before them.

Members listened carefully to the oral representations made by the applicant, the Police and the Interested Parties. They also took account of the written representations and were careful to balance the competing interests of all the parties.

Members noted that representations had been made with regard to fire safety. They noted that such representations do not fall to be considered under the Licensing Act but are governed by The Regulatory Reform (Fire Safety) Order 2005. They therefore disregarded these representations.

They also noted that representations were made on traffic, noise and antisocial behaviour in the street away from the premises. These are also matters which do not fall within the Licensing Act and they therefore disregarded them.

Members noted that representations had been made on disorder, public safety, public nuisance and the protection of children from harm.

Members noted that no representations to the application had been made by Environmental Health, Health and Safety or the officer responsible for the protection of children.

The Members considered that the proposed measures contained in the Operating Schedule, together with the additional conditions proposed by the Police and agreed to by the applicant, would promote the licensing objectives.


They also noted that the Police had requested that the days for non-standard timings for the sale of alcohol and regulated entertainment were reduced, to which the applicant agreed at the hearing.

The applicant made much of the economic reasons as to why the application had been made, but Members acknowledged that market forces are not a licensing objective.

LICENSING ACT 2003

LICENSING COMMITTEE HEARING PROCEDURE ALCOHOL, LATE NIGHT REFRESHMENT AND ENTERTAINMENT

- 1. The Chair will introduce Members of the Sub-Committee and Officers present and explain the procedure to be followed.
- 2. The Licensing Officer will outline the nature of the matter to be considered by the Sub-Committee.

In the following paragraphs where the term "party" or "parties" is used in addition to other terms this will mean anyone to whom notice of this meeting has been given.

- 3. (i) The Applicant/Licence Holder ("the Applicant"), or representative, addresses the Sub-Committee. The Applicant may be asked relevant questions about the matters before the Sub-Committee by the other parties and the Members.
 (ii) The Applicant, or representative, may call witnesses in support of the application and each witness may be asked relevant questions by the other parties and the Members.
- **4. (i)** Any interested parties [defined in s.69(3)] making relevant representations, or representative, will take it in turn to address the Sub-Committee. You may be asked relevant questions by the other parties, the Applicant and the Members.
 - (ii) You (or your representative) may call witnesses in support of your representations and each witness may be asked relevant questions by the Applicant, the other parties and the Members.
- 5. Any Responsible Authority [defined in s.69(4)] making a representation will address the Committee. The Responsible Authorities may be asked relevant questions by the Applicant, other parties and the Members.
- **6.** The Applicant will then be invited to briefly summarise the application.
- 7. The other parties will then be invited in turn to briefly summarise their points if they wish in the same order as before.
- 8. The Chair will invite the Sub-Committee to move into private session to enable the Sub-Committee to deliberate in private in accordance with Paragraph 14(2) of the Hearings Regulations 2005. The Sub-Committee will only reconvene to resolve any points of uncertainty on the evidence already given. During their deliberation the Sub-Committee will be accompanied *for advice only* by the Legal Advisor and the Committee Administrator. The Sub-Committee may retire to a private room or alternatively require vacation of the meeting room by all other persons.
- **9.** When the Sub-Committee resumes, the Chair will announce the decision in public; this will include the reasons (or advise that the decision will be released in writing with reasons within the statutory time limit in this instance 5 working days).

PLEASE NOTE:

- Where the Sub-Committee considers it necessary to do so, it may vary this procedure.
- Decisions will generally be taken regardless of whether the Applicant is present. All notices and representations received from absent parties will be considered.
- Only in <u>exceptional circumstances</u> will the Committee take into account any
 additional late documentary or other information produced by an existing party
 in support of their application/representation. This will be at the discretion of
 the Chair and with the agreement of all the other parties. No new
 representations will be allowed at the hearing.
- The hearing will take the form of a discussion However, the Council will allow all parties to ask questions of another party present, as set out above, but formal cross examination will be discouraged.
- The Authority will disregard any information or representation given by a party which is not relevant to the Application and the Licensing Act 2003.
- The Chair will allow the parties an equal maximum period of time in which to make representations. The amount of time will be at the discretion of the Chair, but in the interests of costs and efficiency will not normally exceed twenty minutes. This will include the time taken for the presentation and the summing up, but not the time taken for questions.
 - N.B. Where there is more than one party making relevant representations the time will be split between those parties. It is recommended that they arrive early to discuss the application with the other interested parties.
- The Chair may require any person attending the hearing who is behaving in a disruptive manner to leave the hearing and refuse to allow that person to return, or only allow them to return subject to certain conditions. Any person so excluded will however be entitled to submit to the Sub-Committee any information which they would have been entitled to give orally had they not been required to leave.
- Bath & North East Somerset Council is committed to taking decisions in an honest, accountable and transparent fashion, but on occasion may find it necessary to exclude members of the press and public based upon the legal framework given in the Local Government Act 1972 Schedule 12 (a). On these occasions decisions based on the above framework will be given.

THE ISSUE

1.1 An application has been received for the Variation of an existing Premises Licence under Section 34 of the Licensing Act 2003 in respect of The Greyhound, 1 High Street, Midsomer Norton, BA3 2LE (Annex A).

3) **Regulated entertainment** by way of **Other Entertainment** within the Act between the following hours:

Monday to Wednesday

11:00 - 00:30

Friday and Saturday

11:00 - 01:00

Sunday

11:00 - 00:30

Non standard timings:

A further additional hour into the morning following every Friday, Saturday, Sunday and Monday for each May Bank Holiday, Spring/Whitsun Bank Holiday and every August Bank Holiday Weekend.

A further additional hour into the morning following every Thursday, Friday, Saturday, Sunday and Monday for the Easter Bank Holiday Weekend.

A further additional hour every Christmas Eve and Boxing Day.

From normal activity start time on New Year's Eve until normal activity finish time on New Year'

4) The **opening hours** for the premises are as follows:

Monday to Wednesday

11:00 - 00:30

Thursday to Saturday

11:00 - 01:00

Sunday

12:00 - 01:00

Non standard opening times:

A further additional hour into the morning following every Friday, Saturday, Sunday and Monday for each May Bank Holiday, Spring/Whitsun Bank Holiday and every August Bank Holiday Weekend.

A further additional hour into the morning following every Thursday, Friday, Saturday, Sunday and Monday for the Easter Bank Holiday Weekend.

A further additional hour every Christmas Eve and Boxing Day.

From normal opening time on New Year's Eve until normal closing time on New Year's Day.

- 5) The licence is subject to the **conditions** detailed in Annex 1 and Annex 2 of the current premises licence which is appended at Annex B of this report.
- 4.3 The variation applied for seeks:
 - •to extend the terminal hour for the sale of alcohol on a Friday and Saturday from 01:00 hours the following morning **to** 02:00 hours the following morning
 - •to maintain 30 minutes drinking up time following the last permitted sale of alcohol;
 - to permit the premises to open at 08:00 hours every day;
 - •to remove the following duplicate condition:

"There shall be no discounted prices on drinks, no drinks promotions and no "Happy Hours"".

All other hours, licensable activities and conditions are to remain the same.

- 4.4 A site plan is attached at Annex C.
- 4.5 The Licensing Act 2003 (Section 4) states that it is the duty of all Licensing Authorities to carry out their functions under the Act with a view to promoting the licensing objectives.

 The licensing objectives are:
 - a) The Prevention of Crime and Disorder.
 - b) Public Safety.
 - c) The Prevention of Public Nuisance, and
 - d) The Protection of Children from Harm.

Each objective is of equal importance; there are no other licensing objectives so these four are of paramount consideration at all times. When considering applications/representations /notifications the Licensing Authority will have regard to these licensing objectives.

- 4.6 The Licensing Authority may vary and grant the application with or without additional conditions.
- 4.7 The Licensing Authority can refuse the variation or part of the variation as it considers necessary for the promotion of the licensing objectives.
- 4.8 The Licensing Authority may not however do anything to reduce the effect of the rights guaranteed by the existing premises licence.
- 4.9 The Licensing Authority should also have regard to the Council's Licensing Policy, the Statutory Guidance issued under Section 182 of the Licensing Act 2003, and the Licensing Act itself, and in particular to:-

a) Paragraphs 3, 5, 6, 9, 10, 15 - 20, 23.5, 24, 28, 30, 33, 35 – 37 & 41 - 44 of the policy.

- b) Chapters 8, 9 and 10 of the Statutory Guidance (as revised on 28 June 2007)...
- c) Sections 4, 9, 10, 13, 34, 35, 36, 182 and 183 of the Act.
- 4.10 If the application is refused the applicant may appeal within 21 days of the notification to the Magistrates Court.

If the application is granted the person making the relevant representation may appeal within 21 days of the notification to the Magistrates Court.

On appeal the court may either dismiss the appeal; substitute the decision appealed against for any other decision which could have been made by the Licensing Authority, or remit the case to the Licensing Authority to dispose of it in accordance with the direction of the court. The court may make such order for costs as it thinks fit.


- 4.11 In accordance with the requirements of the Act the applicants served copies of the application upon the Police, the Fire Authority, Environmental Health, Development Control, Trading Standards, and the Child Protection Agency.
- 4.12 The applicant is required to place a notice at the premises for a period of 28 days starting the day after the application is made and place an advert in a local newspaper within 10 days for submitting the application to the licensing authority.
- 4.13 A representation has been received from the Police in relation to the prevention of crime and disorder objective (Annex D). The representation proposes that the following condition be added to the premises licence should it be granted:

- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability). NB THIS CONDITION DOES NOT APPLY TO OFF SALES.
- 3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available. NB THIS CONDITION DOES NOT APPLY TO OFF SALES.

From 1 October 2010:

- 4. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol. 

I write in opposition to the above application. As a Midsomer Norton Town Councillor I have been approached by many local residents that would be adversely affected by the increase in the operating hours of these premises.

I would firstly like to draw the Licensing Teams attention to the fact that although the notice may have been placed in the window of the premises when stated, the premises were covered in scaffolding until Friday 25th November and a pressure washer was being used to clean the exterior of the building. The notice was not easily visible until the scaffolding was removed and the spray of water ceased. I would expect the notice period to now be extended to allow local residents to be able to make proper representation.

I object to the application on the grounds as follows:-

Crime, disorder and anti-social behaviour. The level of late night drinking in the town is already unacceptable and recognised to be so by both the town and B&NES council. The town council has just begun a new initiative along with B&NES council to try and find ways to reduce this. An increase in late night drinking in the town will only increase the already very high levels of drunk and disorderly behaviour that blights the town during the weekends. Drug taking and violence has occurred in the vicinity of the premises on a regular basis. Local residents have witnessed this on numerous occasions and they have found the police presence unable to cope with the situation even now let alone increasing it any further. Increasing the operating hours will just compound the problem and encourage a greater number of people into the town. I have been informed by a local resident that on a recent occasion the ambulance service refused to attend an incident until police were there as they felt that Midsomer Norton High Street was not safe for the ambulance crew on a Saturday night.

ANNEX E

Public Safety. The pavement area outside the Greyhound is narrow and right on a roundabout and the main road through the town. Groups of drunks trying to cross the road often play 'chicken' with the traffic outside the premises. This causes great danger to motorists as well as the participants. There is no safe crossing to the other side of the road and this area of the town is difficult to access as the pavement and road is narrow. There is no suitable place to pull in by car or taxi without holding up the flow of traffic.

The Prevention of Public Nuisance. Residents throughout Midsomer Norton are already affected by late night noise and anti-social behaviour from drunk and disorderly people returning home through residential areas after a late night drinking. This issue needs to be reduced and not increased. I have been contacted by residents all over Midsomer Norton in Priory Close, Withes Park and Charlton Park who are woken up in the early hours of the morning by noisy drunks returning home after a night partying. Litter is thrown into residents gardens, drunks urinate on their front doors and vomit is a regular sight on an early Sunday morning. Midsomer Norton does not have the infrastructure to cope with an increase in late night drinking. A further venue offering late night drinking will only encourage more people to come into the town and return home later. The venue is close to a large number of residential properties as well as right next door to the main parish church.

I trust that the above will clearly show why this application should be refused.

Please can you inform me of the date and time this application will go before the licensing committee.

As a ward councillor I speak to residents on their doorsteps, and a consistent topic ofconcern in Midsomer Norton is the loutish behaviour and unpleasant atmosphere in the town in the evenings. A number of people say they would not feel comfortable venturing into the public space of the town centre at this time.

Before the recent closure of the facility at the Greyhound for refurbishment I spent an evening observing the rowdyism and loutish behaviour for myself, from the vantage point of the Town Hall: people with beers in their hand holding up the traffic to chat (actually to shout) to their mates in a car; shouting to each other in language laced with obscenities which intimidates any sober and decent passers-by; scantily dressed women reeling along making screeching noises and pulling plants out of the planters; an idiot banging his head on the plate glass of Barons the Estate Agents; frequent public urination at Mansfield House and Hobbs the Gunsmiths . A lot of the unpleasantness in the public space was caused by pedestrian traffic between Moonjuice and the Wunderbar (Greyhound).

As a ward councillor I have found myself sympathising with Michael Goulds Estate Agents next to The Greyhound after their plate glass was smashed in. As a resident living just off the High Street I used to be woken regularly at 2.30 am by loud drunks making their way home.

While some of this behaviour continues, it has diminished of late, probably because we have enjoyed the services of only one night club for a couple of months. Meanwhile the Town Council is trying to do something about the whole situation, and a Community Alcohol Partnership is being set up led by the B&NES Community Safety department, with the cooperation of the Town Council and the police. If the pilot scheme in Midsomer Norton is successful, it may be rolled out across the Authority. This proposed extension in licensing hours would be a major setback to these efforts.

If we had a sophisticated clientele for nightclubs in Midsomer Norton this extension into the small hours in our town might be acceptable. We do not. The latest custom for homegoing revellers, for instance, is to push each other into hedges, damaging people's gardens and making their lives that bit more miserable.

You will hear representations from neighbours with details about the effect of the existing small hours licence, to 1am plus 30 minutes drinking up time. The proposed extension will push the disruption further into the middle of the night. At present I understand the police find it efficient to work with the staggered closing times of the local venues, with an hour's gap between The Greyhound and Fat Sams. The extension would make the exit more difficult to manage, I believe.

The evidence of the police will be crucial to this application, so I want to make public the fact that I had a conversation with the Beat Manager for Midsomer Norton, Tony Rogerson, on the morning of Sunday 27th November, and for whatever reason, the fact is that he had only just heard about the application. Because of the time constraint it may be that the police do not make an objection at this stage, so it is vital that a hearing occurs so that they have time to make a considered submission, if they wish and assuming the rules allow that.

I regret feeling compelled to make this objection, since in an ideal world this extension of licensing hours would be a simpe economic boost for its projectors and for the community. Unfortunately, we have a culture which means that alcohol is accompanied by bad behaviour, and the downside of this application in my view easily outweighs the up.

I suppose the rules don't allow it, but from the public order point of view and in the interests of residents, if there is a competition issue, it would far better to take an hour off the closing time of Fat Sam's, than to extend by a further hour the supply of alcohol at the Wunderbar.

Midsomer Norton is a small rural town of 10,000 souls and the last thing it needs is another extension of alcohol supply into the middle of the night.

With regard to the application made by The Greyhound, Midsomer Norton, to extend their licensing hours, I wish to make a formal representation as I am objecting primarily to prevent public nuisance.

I apologise for the lateness of this objection but we were only made aware of the application a few days ago as the notice was not clearly displayed at the venue, therefore I am sure you can understand we have not had much time to prepare.

I am both a local business located in Midsomer Norton High Street, and a local resident of Midsomer Norton, I also operate the Norton Radstock & District Pubwatch Scheme whose aims are to protect patrons and local residents from issues of anti-social behaviour and risk to public safety.

Therefore my objections are based of the following issues:

Prevention of crime and disorder.

We experience issues of anti-social behaviour in the High Street on a weekly basis, these issue is compounded by the lack of Police presence in the area, particularly on Friday and Saturday nights when there is often no Police presence and in the case of an incident officers need to be drafted in from Keynsham or further afield, it can often take more than 1 hour for officers to attend. Due to a lack of Police presence a large amount of these incidents go unreported.

This issue will increase with the patrons exiting two High Street venues at 2:30am.

Public Safety.

The venue in question has converted the first floor to a Dance Floor, this does not meet current fire regulations, according to licensing has a capacity of 200 people and has only a single stairway access and therefore would endanger public safety, there have been no checks by planning to ensure meeting building regulations.

Prevention of public nuisance.

The venue has a large amount of residential properties and a Hotel located all within 20 metres of the building, my own property is in close proximity to this venue, there have been no noise reports or tests produced to measure ambient noise levels and the impact on local residents, there are no provisions for noise leakage such as sound insulation of windows, door sound control, and no provision for noise metering. In summary no attempt to meet the requirements of the Environmental departments regulations on Noise Control.

Local residents in close proximity to this venue regularly experience disturbances from people exiting this venue in the early hours.

As you are aware our venue has been required to meet building, fire and noise regulations to ensure that we operate in these hours safely and without impact on local residents, none of which have been applied in this application.

We the undersigned wish to make representations regarding the requested application to extend the Friday and Saturday licence times to 2 am with 30 minutes additional drinking up time.

There is residential housing close to the premises and on the nearby routes taken by customers making their way home.

The principal reason for our representation is that residents already suffer problems of nuisance and disorder which cause disturbance late into the night as listed below, which deprives residents and their children of sleep and causes risks to health. The suggested extension of the opening hours would extend these problems into the early hours of the morning, 4 am and beyond, as customers gradually disperse. We regard this as totally unacceptable.

- 1. Excessive noise as customers leave the premises, shouting, singing, abusive language which may well constitute statutory nuisance.
- 2. Frequent fights and scuffles creating excessive noise and sometimes collision risking damage to private property and causing stress to residents
- 3. Urinating in the car park and in the residential areas



1 THE ISSUE

1.1 An application has been received for the variation of an existing Premises Licence under Section 34 of the Licensing Act 2003 in respect of Mix Grill (aka Flames), 4 Cleveland Place East, Walcot, Bath, BA1 5DJ (Annex A).

2 RECOMMENDATION

2.1 That the sub committee determine the application to vary the licence.

3 FINANCIAL IMPLICATIONS

3.1 There are no financial implications arising from this report.

4 THE REPORT

- 4.1 An application has been received for the variation of a Premises Licence.
- 4.2 The current Premises Licence permits the following licensable activities:
 - 1) Late Night Refreshment between the following hours:

Sunday to Thursday 23.00 to 01.00

2) The **Opening Hours** for the premises are as follows:

Sunday to Thursday

23.00 to 01.00

Friday and Saturday

23.00 to 03.00

- 3) The licence is subject to the following conditions:
- Staff shall arrange for a taxi service if requested.
- Free drinking water shall be available.
- CCTV cameras shall be in operation at the premises.
- Customers shall not be permitted to bring bottles or glasses into the shop.
- A prominent sign shall be displayed telling customers to leave the shop in a quiet manner.
- The premises shall have an extract system which is designed to prevent noxious smells.
- Any individual employed to carry out a security activity must be licensed by the Security Industry Authority.
- 4.3 The **variation** application seeks to extend the permitted hours for the provision of late night refreshment and to include the sale of alcohol. The proposed activities and timings are as follows:

Every Day

00.00 to 00.00 (24 hours)

2) Late Night Refreshment between the following hours:

3) The proposed **Opening Hours** for the premises are as follows:

00.00 to 00.00 (24 hours)

- 4.4 A site plan is attached at Annex C.
- 4.5 The Licensing Act 2003 (Section 4) states that it is the duty of all Licensing Authorities to carry out their functions under the Act with a view to promoting the licensing objectives.

 The licensing objectives are:
 - a) The Prevention of Crime and Disorder.
 - b) Public Safety.
 - c) The Prevention of Public Nuisance, and
 - d) The Protection of Children from Harm.

Each objective is of equal importance; there are no other licensing objectives so these four are of paramount consideration at all times. When considering applications/representations /notifications the Licensing Authority will have regard to these licensing objectives.

- 4.6 The Licensing Authority may vary and grant the application with or without additional conditions.
- 4.7 The Licensing Authority can refuse the variation or part of the variation as it considers necessary for the promotion of the licensing objectives.
- 4.8 The Licensing Authority may not however do anything to reduce the effect of the rights guaranteed by the existing premises licence.
- 4.9 The Licensing Authority should also have regard to the Council's Licensing Policy, the Statutory Guidance issued under Section 182 of the Licensing Act 2003, and the Licensing Act itself, and in particular to:
 - a) Paragraphs 3, 5, 6, 10, 16, 17, 18, 19, 20, 23(5), 24, 28, 30, 33, 35, 36, 37, 41 to 44 of the policy.
 - b) Chapters 8, 9 and 10 of the Statutory Guidance (as revised October 2010)
 - c) Sections 4, 9, 10, 13, 34, 35, 36, 182 and 183 of the Act.
- 4.10 If the application is refused the applicant may appeal within 21 days of the notification to the Magistrates Court.

If the application is granted the person making the relevant representation may appeal within 21 days of the notification to the Magistrates Court.

On appeal the court may either dismiss the appeal; substitute the decision appealed against for any other decision which could have been made by the Licensing Authority, or remit the case to the Licensing Authority to dispose of it in accordance with the direction of the court. The court may make such order for costs as it thinks fit.

- 4.11 In accordance with the requirements of the Act the applicants served copies of the application upon the Police, the Fire Authority, Environmental Health, Development Control, Trading Standards, and the Child Protection Agency. No representations have been received from any of the Responsible Authorities.
- 4.12 The applicant is required to place a notice at the premises for a period of 28 days starting the day after the application is made and place an advert in a local newspaper within 10 working days of submitting the application to the licensing authority.
- 4.13 A representation has been received from Avon and Somerset Constabulary in relation to the licensing objective of the prevention of crime and disorder (Annex D). The representation states that the Police are strongly opposed to the application.
- 4.14 The Police representation goes on to say that, in the event the Committee are minded to grant the application, then they would wish to see conditions imposed to ensure the promotion of the licensing objectives. The following steps have been recommended:
 - 1. Alcohol will only be sold by way of delivery to the customers' residence after 23.00 hours and not to customers attending at the shop premises.
 - 2. All deliveries which include alcohol must only be received by a person aged 18 years or over.
 - 3. Photographic identity will be required for any person who appears under the age of 21 years.

3

- 4. A refusals register is to be maintained recording the details of any sales or deliveries that were fused. The register is to be kept at the premises and be made available for inspection to any Police Officer or authorised person at all reasonable times.
- 5. Alcohol will only be sold over the counter at the premises with a food order of £5 minimum.
- 6. A digital CCTV system will be fitted to the premises in consultation with the Police. The system will be maintained and images retained for 31 days and made available to the authorities on request.
- 4.15 Relevant representations have also been received from local residents and businesses in relation to the licensing objectives of the prevention of crime and disorder and the prevention of public nuisance (Annex E).
- 4.16 This report has not been sent to the Trades Union because they would have no involvement in this application.



- 5.Alcohol will only be sold over the counter at the premises with a food order of £5 minimum.
- 6. A digital CCTV will be fitted to the premises in consultation with the Police, the system will be maintained and images retained for 31 days and made available to the authorities on request.






The area has a number of late night takeaways and late night establishments – it is possible to purchase alcohol in two nearby outlets, until 2200 hrs (Morrisons and London Road Stores), and I would describe these outlets as well run and well managed.

It has been my experience, both here and in Bristol, that serving alcoholic beverages in late night takeaways is downright dangerous. Many pedestrians walking home from the City Centre, especially on weekends, will have consumed a lot of alcohol. At the moment, they will stop off at a Takeaway and order a meal; I have had complaints from residents that matters have got out of hand whilst late night revellers are waiting for their food — I have witnessed this myself in the City Centre, where fights can break out at a moments' notice, over spurious reasons.

The presence of alcohol on the premises, in my opinion, would only serve to exacerbate the issue – at present there are no premises on this side of Bath that have a late night licence, and, again in my opinion, the presence of alcohol would serve as a catalyst for people to meet and linger and drink in the street outside; the potential for Public disorder, road traffic collisions, noise, anti social behaviour and disruption to local residents would be increased massively.

I would like to register my formal objection to the published application to serve food at the above premises until 5 am every day and to sell alcohol for 24 hours every day.

My grounds for objection areas follows:

Prevention of Crime and Disorder. Prevention of Nuisance.

There is ample evidence that late night and early hours food and alcohol premises often attract the attention of people who are already fuelled up on alcohol. The government has voiced its concerns over the late night binge culture evident in so many of our cities, and the local authority in Bath has already had to address this problem in the city centre by enforcement of more strict licensing on some premises and an almost total ban on street drinking in the city centre. The city has also found it necessary to employ city centre marshals to maintain order.

Although Cleveland Place is not classed as city centre, it is at the junction of the London Road and Bathwick Street, both are major public thoroughfares, both are main routes for revellers on their way hom. from the city centre and both are residential streets. Unfortunately, without the benefit of city centre marshals, residents have little protection against the low level disorder and petty crime and occasional more serious crime that affects the area in the early hours.

We already have late night food outlets at Dominoes and at Megabites. Neither is permitted to sell alcohol over the counter, although Megabites does offer a delivery service, which has recently drawn adverse comment.

The proposal at Flames to sell alcohol over the counter will only serve to increase a supply that is already amply served elsewhere during the day and early evening. The proposal to also supply alcohol in the early hours is really an invitation to those who most probably should not be consuming alcohol at all.

In recent press reports, the applicant representing Flames said that his staff are able to keep order on the premises. Whilst I do not doubt their abilities, these requirements stop at the front door of the premises. Once in the street, the licensee has little or no legal responsibility for the behaviour of their customers.

Some years ago, I drew the attention of Social Services to the number of vagrants who live in the woods across the river from Grosvenor. They remain there to this day. Since that time a second group has found a home under the arches on the northern approach to Cleveland Bridge.

Whilst fully acknowledging the plight of these individuals, the London Road is frequently treated to the spectacle of members of this group drunk on the pavements. It is both irresponsible and unkind for the authorities to consider the introduction of a facility to allow these unfortunates to acquire even more alcohol at every hour of the day and night.

On a more general point of comment: I am aware that local residents have found the staff at Flames quite uncooperative in providing the identity of the owner and or the manager. Whilst I am aware that the 2003 Licensing Act takes a somewhat open view of who can apply for both a personal and a premises licence; I would suggest that the B&NES licensing team satisfy themselves that the applicant, Mr Jamie Bryan, can demonstrate a sufficiently close interest in the premises to ensure that he can meet his responsibilities within the terms of the Act.

This is a largely residential area, and despite the London road is relatively quiet at night. Bath is not a 24 hour city.

I wish to make representation on the premises licence variation application 11/04000 to extend the hours for the sale and supply of alcohol and late night night refreshment to permit 24-hour operation of these premises.

My concerns in regard to this application relate to the public nuisance and crime and disorder licensing key objective. I am concerned that this will result in a precedence being set, in that no other premises in this immediate area are current permitted to operate during this period. The late night atmosphere of the immediate area having been significantly improved following closure of both The Long Acre Tavern and Burdalls Yard.

The location is primarily residential, whilst I accept there is high traffic flow and commercial activity during the day, after midnight the location is a low background noise area, which permits these residents to have a acceptable balance of quiet enjoyment of their dwellings. By extending this premises licence this balance would be significantly tilted towards the commercial use and residents would in my opinion be negatively impacted.

I consider that the premises, due to its later operation would become a destination premises, attracting persons, who would not normally come to this area. This would result in persons loitering outside the premises, additional cars being attracted, parking up outside my property and other residential areas, as it can be difficult to park close to the premises at night. The premise in question is located in a residential area and the encouragement of late night eating and drinking will only increase the level of disorder in this location. Anyone who is seeking to acquire alcohol in the early hours of the morning is likely to have been drinking at pubs and clubs already and therefore more likely to cause trouble and noise and disturbance. Even at other hours the provision of alcohol is only going to encourage the hanging around the premises causing a general nuisance.

There is already a tendency to hang around in the shelter of the toll houses on Cleveland Bridge which means that it can be intimidating for pedestrians to pass by and also leads to damage and litter. Provision of alcohol is only likely to increase this problem. Residents in the area surrounding *Flames Takeaway* at 4 Cleveland Place East, Bath, have to put up with high levels of noise from traffic, emergency vehicle sirens and arguments between pedestrians travelling along London Road and across Cleveland Bridge.

I object to the extension of a takeaway license until 05:00 and a 24-hour alcohol license on the following grounds:

- 1. Prevention of Crime & Disorder. When Flames first started operations at Cleveland Place East, they closed at 04:00 and at night there were often arguments and fights outside the premises. There were some incidents of serious crimes (grievous bodily harm) where groups of youths attacked customers who were waiting for food. Anything which increases the threat of alcohol-related crimes puts the residents of the area at risk.
- 2. Public Safety. In view of the above risk of Crime and Disorder, what precautions will be taken to prevent harm to members of the public? The levels of litter scattered around on the pavements, particularly if it is greasy, will put pedestrians at risk of falls. Large numbers of customers waiting to be served will increase the noise levels and the risk of aggression towards members of the public and cause congestion on the pedestrian area next to a busy road. There is still quite a high level of vehicle traffic on the A36 and A4, even in the early hours of the morning.
- 3. Public Nuisance. As in point 3. above.
- 4. Threat to young persons. The threat to young persons (particularly those of school age) at night might not be increased, but the risk of them having yet another means of access to alcohol at any time of day and night should not be granted. There have been incidents elsewhere in Bath of under-age persons buying alcohol from food outlets and it would be unwise of the Council to condone another threat to children. Those who wish to purchase alcohol to drink elsewhere than in licensed premises have sufficient other outlets in Bath during the daytime.

As a local resident I am pretty horrified by the application by FLAMES takeaway for a licence to sell food to 5am and alcohol for 24 hours a day.

Because London Road is much used by people returning home in particular from the city centre late at night/in the early hours, we already experience a good deal of nuisance and disturbance from such people. I have no problem with people enjoying themselves or even getting a bit tiddly on alcohol on a good night out, but it is important not to let that nuisance expand into something more serious and damaging for local residents. This is after all a dense residential area. Currently it is common for some revellers to drop their food wrappings, bottles and cans on the street, into doorways and even into the basement areas of local houses. So, another potential stopping place on the route home where alcohol can be purchased/consumed and food bought in takeaway form is bound to exacerbate this problem.

Noise is also a nuisance with revellers passing along London Road at night when there is no traffic noise. It is the nature of the terraced buildings which magnify and echo the sound, so that even slightly noisy conversations can be heard clearly word for word over a considerable distance. My feeling is that more alcohol/late night food, available from a site nearby, is liable to add also to that noise disturbance.

I suspect too that the site of FLAMES selling fast takeaway food, and near a street corner, would encourage little groups to form and stand around as they consumed their purchases. Such behaviour promises even more noise and a lot more litter. Heaven forbid! We should have the street around Cleveland Place swept virtually every morning now, to try to keep the dirty litter down, but it is actually the shopkeepers and residents who currently clear up the recurring mess.

We have seen an increase in street violence overall since 24 hr licencing became more common. Most responsible citizens accept that there is rarely a good case for granting a 24/7 alcohol license, so why would we support this application anyway?

In my view there is already plenty of provision for food and drink in that part of the London Road in any case. Are we going to allow over time, a proliferation of all-night bars/cafes in the area? This promotes the kind of negative image this area of Bath is trying to escape from, not endorse.

Dear Emma,

My further comments are below:

The sale of food and refreshment at *Mix Grill* is not a matter of concern for us, much as we would like ALL commercial premises in Bath providing food to be responsible for clearing their vicinity of the litter they have originated.

- Our concern over alcohol is based on years of noting the use made by drinkers and drug takers of the graveyards either side of our property. (It was originally the rectory for St. John's Church.) We and our neighbours have seen the use made of the graveyard as a place to urinate and to copulate.
- One rough sleeper is currently using the porch on Cleveland bridge as a
 base and he and others can already be seen drinking late there in the
 evening, without the addition of another nearby alcohol outlet.
- We and neighbours have contacted the police on several occasions, particularly when there have been alcohol-fuelled fights or altercations which impinge on passers-by or endanger the participants. On one occasion someone who was 'merely' dead drunk was taken to be dead, and reported as such by a panicking resident.
- Our immediate locality is a site for drug taking that is often linked with alcohol. We find broken bottles and used syringes on a regular basis and they constitute a major hazard for the young children who use the path behind our property as a route to school. On one occasion the council workers clearing the graveyard found a concealed knife with a six-inch blade.
- In recent months the vacant site at the top of St. John's Road has become the place of preference for local drinkers and at times the elderly and infirm residents of Bridgemead House have had to run (well...zimmer!) the gauntlet of drinkers on the path by the graveyard.
- The memorial graveyard at the top of Henrietta Street is a popular drinkers' venue, particularly in the summer months.

I hope that these concerns will be taken into account when reaching a decision and will be sending a copy of this email to local councillors. Regards,

I wish to make representation on the premises licence variation application 11/04000 to extend the hours for the sale and supply of alcohol and late night night refreshment to permit 24-hour operation of these premises.

My concerns in regard to this application relate to the public nuisance and crime and disorder licensing key objective. This application will result in a precedence being set, in that no other premises in this immediate area are current permitted to operate during this period.

The location is primarily residential, whilst I accept there is high traffic flow and commercial activity during the day, after midnight the location is a low background noise area, which permits these residents to have a acceptable balance of quiet enjoyment of their dwellings. By extending this premises licence this balance would be significantly tilted towards the commercial use and residents would in my opinion be negatively impacted.

I consider that the premises, due to its later operation would become a destination premises, attracting persons, who would not normally come to this area. This would result in persons loitering outside the premises, additional cars being attracted, parking up outside my property and other residential areas, as it can be difficult to park close to the premises at night. This would extend the noise footprint from the premises closer to my property and result in car stereos blaring, slamming of car doors and loud voices in the street, i would add that the later this occurs the greater the intrusion residents like myself will experience, especially if we have bedrooms overlooking the street. I also have concerns at the availability of alcohol on a 24-hour basis. Whilst I appreciate a condition that alcohol sales can be ancillary to a substantial take away meal can be attached to the varied licence, this I still find unacceptable. I would add that especially during the weekends, my front area is usually littered with the uneaten remains of takeaway meals, mostly kebabs. The packaging confirms that they have been purchased from these premises. In my view the extension of the operation of the premises would only exacerbate the problem and the crime and disorder issues that currently exist.

I consider that if the hours are extended as proposed in this application, this problem would become more prominent and have a severe detrimental impact on our area would arise. I consider this application is wholly inappropriate for the late night residential ambience of this area and would request that the application is refused.

I object to the application by Flames Take Away for all-night alcohol licensing for the follwing reasons:

1. Crime.

- 1A) A laptop computer was stolen from my shop. This was a situation where someone must have been hanging around the vicinity and seen a very brief opportunity to run in and take it. If these sort of incidents happen in daylight, I dread to think what may ensue if late night alcohol were to be available in this area late at night.
- 1B) I have had two bicycles stolen despite having padlocked them to the adjacent bike stands provided by the council.

2. Vandalism

- 2A) This area is already subject to high levels of vandalism. On one occasion 6 shop windows were smashed in one night, to be followed by another 5 two nights later; the five included two where the glass had already been replaced, and my own shop window.
- 2B) On several other occasions shop windows have smashed. The Police were informed.
- 2C) I had a bicycle damaged severely; I had secured it with a very robust lock including both wheels, so my guess is that the would-be thief, frustrated at being unable to steal it, kicked in the wheels instead.
- 2D) It is not uncommon to see drunks and or drug addicts in a terrible condition staggering around in this part of town. I feel that late night alcohol is the last thing we need here.

As a footnote, I would like to suggest that it may be helpful if the Police could make their presence known more frequently in this part of town.

RE EXTENSION OF LICENSING HOURS AND OPENING HOURS AT FLAMES 4 CLEVELAND PLACE EAST BATH

I strongly oppose the application for Flames to sell alcohol 24 hours a day and food until 5 am. I live in and plan to let out my house as a large self catering premises for families and groups. I have already noticed a tendency for drunk people to wander around London Road at the junction of Cleveland Place and gather around Nexus Methodist Chapel. I object on the following grounds:

- 1. Prevention of Crime and Disorder. If Flames becomes a place for 24 hour alcohol sales it is clear that people wanting to buy alcohol in the middle of the night are very likely to have already consumed a considerable amount and are quite possibly going to consume what they buy near the premises. As this is a high population residential area, it is very likely that 24 hour alcohol sales will result in drunken disorder throughout the night disturbing residents.
- 2 Public Nuisance The shop being open all night for sales of alcohol and til 5 am for food will certainly attract people who wish to stay up all night drinking or who are returning from parties or clubs in the early hours of the morning. Inevitably this will cause noise which will affect nearby residents. As flames is not a restaurant with large seating capacity it is very probably the takeaway food will be eaten in the area immediately outside the premises. In order for the business to be successful, they must be expecting fairly constant customers and as there is no other late night food outlet, it will certainly draw people to the area increase noise nuisance to residents.
- 3. Threat to young people Excessive alcohol consumption often leads to aggressive behaviour. If this area becomes known as one of the few places in BAth where alcohol can be bought 24 hours it will certainly draw people who need to drink throughout the night. Drunkeness very frequently leads to aggressive behaviour. Many young people live in this area and if there is a point known for selling alcohol 24 hours a day which attracts drunken behaviour, young people returning home late could be put at risk having to pass this area on their way home.

I strongly oppose this application as it is not providing a necessary service to the locality and will only attract and encourage excessive alcohol consumption in the immedaite vicinity.

Frankly, this proposal fills me with horror. On a more general note, there are too many foul smelling fast food takeaways in this area which do nothing to improve living conditions for the residents. In fact, they actually make life somewhat unpleasant as we are the ones who have to clear up the mess and listen to screaming and yelling. It also makes it feel unsafe to walk home at night.

More specifically, I wish to object to this application on the grounds of:

- 1. Adding to the already unacceptable levels of noise late at night from rowdiness in this area which are clearly the result of too much to drink. People don't realise the decibel level as they carry out screaming conversations and have alcohol fuelled arguments. This is regular, not occasional.
- 2. The litter of both the wrappings and half eaten contents (it would seem that the drunks have difficulty hanging on to their purchases) are left for the residents to clear up.

1 THE ISSUE

1.1 An application has been received for a new Premises Licence under the Licensing Act 2003 in respect of Keynsham Memorial Park, Keynsham, Bristol, BS31 1DG.

2 RECOMMENDATION

2.1 That the sub committee determines this application.

3 FINANCIAL IMPLICATIONS

3.1 There are no financial implications arising from this report.

4 THE REPORT

- 4.1 An application has been received for a new Premises Licence (Annex A).
- 4.2 The application is for:
 - The Provision of Regulated Entertainment by way of Plays, Films, Live Music, Recorded Music, Dance, Similar Entertainment and Provision of Facilities for Making Music and Dancing both Indoors and Outdoors between the following hours:

Every Day

09.00 to 21.00

- 2) The Opening Hours are not specified as the premises is an open public space.
- 4.3 A site plan is attached at Annex B.
- 4.4 The Licensing Act 2003 (Section 4) states that it is the duty of all Licensing Authorities to carry out their functions under the Act with a view to promoting the licensing objectives. The licensing objectives are:
 - a) The Prevention of Crime and Disorder
 - b) Public Safety
 - c) The Prevention of Public Nuisance
 - d) The Protection of Children from Harm.

Each objective is of equal importance. As there are no other licensing objectives, these four are of paramount consideration at all times. When considering applications, representations or notifications, the Licensing Authority will have regard to these licensing objectives.

- 4.5 The Licensing Authority may grant the application with or without additional conditions.
- 4.6 The Licensing Authority should also have regard to the Council's Licensing Policy, the Statutory Guidance issued under Section 182 of the Licensing Act 2003, and the Licensing Act itself, and in particular to:
 - a) Paragraphs 3, 5, 6, 9, 10, 15 20, 23, 24, 28, 33 37, 41 to 44 of the 2008 policy.
 - b) Chapters 8, 9 and 10 of the Statutory Guidance (as revised on 28 June 2007).
 - c) Sections 4, 9, 10, 11, 12, 13, 16, 17, 18, 23, 182, 183, and Schedule 2 of the Act.
- 4.7 If the application is refused the applicant may appeal within 21 days of the notification to the Magistrates' Court. If the application is granted the person making the relevant representation may appeal within 21 days of the notification to the Magistrates' Court.
 - On appeal the court may either dismiss the appeal, substitute the decision appealed against for any other decision which could have been made by the Licensing Authority, or remit the case to the Licensing Authority to dispose of in accordance with the direction of the court. The court may make such order for costs as it thinks fit.
- 4.8 In accordance with the requirements of the Act the applicants served copies of the application upon the police, the fire authority, environmental health, development control, trading standards, and the child protection agency.
- 4.9 The applicant is required to place a notice at the premises for a period of 28 days starting the day after the application is made and place an advert in a local newspaper within 10 days for submitting the application to the licensing authority.

- 4.10 A representation has been received from Environmental Health in relation to the licensing objective of public safety (Annex C). The representation requests that two of the conditions proposed within the operating schedule are reworded in order to clarify the meaning and ensure the promotion of the licensing objective.
- 4.11 The representation recommends that, <u>in respect of events with an estimated 500 persons or more</u>, the following statements should be reworded and placed as conditions on the premises licence:

1. Original wording:

2 months' notice of each event shall be given to the Police and Licensing Authority and site visits shall be undertaken should the Responsible Authorities feel it necessary. Responsible Authorities have the right to veto should they be satisfied that any of the four licensing objectives would be breached if the event were to go ahead. In such circumstances it is expected that negotiations will take place between the Licence Holder and the Responsible Authority to resolve the matter.

Suggested rewording:

2 months' notice of each event should be given to the Licensing Authority and all Responsible Authorities. If deemed appropriate by one of the Responsible Authorities, the event may be referred to Bath & North East Somerset's Safety Advisory Group for consultation.

2. Original wording:

Provision of Council staff as attendees at all events.

Suggested rewording:

Provision of Keynsham Town Council staff as attendees at all events.

- 4.12 The applicant has submitted a written statement which confirms they are in full agreement with the Environmental Health Officer and happy to accept the proposed changes as above (Annex D).
- 4.13 This report has not been sent to the Trades Union because they would have no involvement.


