1 THE ISSUE

- 1.1 In 2011 Bath's Business Improvement District (BID) was launched by Future Bath Plus to strengthen the management of the city centre. The scheme works in partnership with the Council and Police to deliver a high quality Bath night time economy that is safe and enjoyable for all.
- 1.2 This report invites the Panel to hear about how the BID consolidates work already underway with the Taxi and Street Marshals, Police, CCTV and radio links.
- 1.3 The Police will also provide a 2011/2012 performance update to highlight the progress made over the last twelve months in particular; improved victim satisfaction, reduction in crime and results on the work with prolific offenders.
- 1.4 The Panel will be invited to an open question and answer session at the end of the presentation.

2 RECOMMENDATION

2.1 The Panel is asked to agree that it receives and comments on a presentation setting out the progress made of the BID and Police performance over the last twelve months and, identify areas of support where the Panel can influence.

4 THE REPORT

- 4.1 Projects in the BID are managed by Future Bath Plus and funded by 620 Bath Businesses along with voluntary and in-kind contributions. The Panel will hear how some of these projects support and impact upon the night time economy.
- 4.1 The Panel will receive a presentation on the police performance 2011/2012 that will provide a local overview of overall service satisfaction and, reduction in serious acquisitive crime.

 - How the Police will continue to support the night time economy
 - How the BID will support local priorities and work with businesses in both the daytime and evening economy to reduce the number of thefts and anti-social behaviour issues.
