1 THE ISSUE

This briefing report updates the Panel on development of the draft Advice & Information Strategy 2014-17 and of the programme of consultation currently being undertaken with stakeholders. The report also represents an opportunity for officers to consult with members of the Panel on the draft Strategy.

2 RECOMMENDATION

The Health & Wellbeing Panel is asked to:

- 2.1 Note the contents of the briefing.
- 2.2 Consider the draft Strategy and provide feedback, particularly addressing the following questions, which are in line with those posed in the public consultation:
- Is the document of a good standard; is it clear and easily understood?
- Are there any factual inaccuracies that need to be addressed?
- Do the contents accurately reflect the Council's intentions and the resources it has available for delivery of advice & information services?
- Is the proposed model for delivering advice in the future appropriate and reasonable?

3 FINANCIAL IMPLICATIONS

3.1 The draft Strategy will support the delivery of the approved savings identified in the Medium Term Service and Resource Plan. The delivery and development of the Strategy is being met from within existing budget resources.

4 THE REPORT

- 4.1 The Council is not statutorily obliged to ensure that generalist advice services are provided. However, it is recognised that timely and accurate advice has a strong role to play in improving and extending independent living and reducing spending on statutory services. Bath & North East Somerset has a diverse advice sector, providing a wide range of specialist and generalist services. To date, commissioning of advice services has been based on a sector review undertaken in 2006 and developed in response to emerging trends. The draft Strategy has been informed by the review of current advice and information provision undertaken over the past 12 months and by listening to people's feedback about current and future provision. The document aims to set out a coherent and rational approach to provision of advice that is based on both local needs and available resources.
- 4.2 Consultation on the draft Strategy began on 9 December 2013 and will conclude on 24 January 2014.
- 4.3 The following table sets out the actions taken so far to publicise the draft document, how feedback will be gathered and, where appropriate, closing dates or dates of specific events.
