THE KEYNSHAM HIGH STREET AIR QUALITY MANAGEMENT ORDER 2010

NOTICE IS HEREBY GIVEN that on 7 June 2010 Bath and North East Somerset Council made an Order under section 83 (1) Environment Act 1995.

The effect of the Order is to make the following area an Air Quality Management Area.

The area is described as "An area, which extends north encompassing the facades of the buildings within the area on both sides of the road from the point where Temple Street meets the Town Hall car park access junction as far as and including the junction of Bristol Road with Old Vicarage Green, Bath Hill as far east as Back Lane, Charlton Road as far west as number 13 including the junction with Ashton Way and Station Road including the buildings on the west side of the bypass."

The Order will come into operation on 31 July 2010. A copy of the Order and its associated plan have been deposited and may be seen, free of charge, at the under mentioned offices during office hours and at Northgate House, Bath, Riverside, Keynsham and Bath Central, Keynsham and Midsomer Norton public libraries during normal office hours. Copies of the Order and map may be purchased at the price of £3.50.

**THE KEYNSHAM HIGH STREET AIR QUALITY MANAGEMENT ORDER

The Bath and North East Somerset Council is satisfied that, as a result of its air quality survey and assessment dated August 2008, the air quality objective for nitrogen dioxide (NO₂ annual average) contained in the Air Quality (England) Regulations 2000 ("the Regulations) in the area described below exceed the objective levels set by the Regulations.

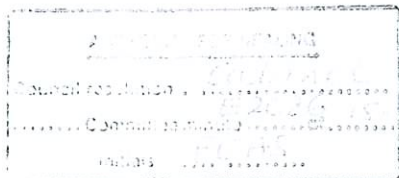
The Bath and North East Somerset Council, in exercise of the powers conferred on it by Section 83(1) of the Environment Act 1995, hereby makes the following order:-

1. This Order may be cited as the Keynsham High Street Air Quality Management Order 2010.
2. The Air Quality Management Area will be an air quality management area in relation to nitrogen dioxide only.
3. The area is described as "An area, which extends north encompassing the facades of the buildings within the area on both sides of the road from the point where Temple Street meets the Town Hall car park access junction as far as and including the junction of Bristol Road with Old Vicarage Green, Bath Hill as far east as Back Lane, Charlton Road as far as west as number 13 including the junction with Ashton Way and Station Road including the buildings on the west side of the bypass and for the purpose of identification only shown outlined in red on the map, prepared and sealed with the Common Seal of Bath and North East Somerset Council and marked "Keynsham High Street Air Quality Management Area".
4. The order will come into operation on 31 July 2010 and shall remain in force until varied or revoked by subsequent Order.
