Dear Maria,

At the October Parish Council meeting dated 11th October 2017, Cameley Parish Council discussed and considered the Parish Council Name Consultation which included results from a previous Parish Questionnaire and recent engagement with residents at a Coffee Morning on 30th September 2017. During this meeting, the Parish Council resolved to apply to the secretary of state to request the name of the Parish Council be changed to: **Temple Cloud with Cameley Parish Council**. Minute reference 135/17-18 of the attached minutes refer.

This name recognises the larger village of Temple Cloud which makes up the Parish of Cameley whilst retaining reference to the smaller settlement from which the name of the Parish originates. The minutes from the meeting have since been approved.

I have since written to Sajid Javid – the Secretary of State for Communities and Local Government on two occasions to request this name change as set out in Section 75 Local Government Act 1972.

The Parish Council have a number of projects which are at present on hold pending agreement of the name change. I have now received the attached response stating that the request must come through the District Council and am hoping you are best placed to assist us in progressing this request. I have attached the minutes of the meeting where the resolution was passed and original letters but would like to request that B&NES Council now write to the Secretary of State to request this change be actioned, as proper process.

Are you able to assist with this process or are able to identify someone within the Council who may support us with this endeavour?
