### 1 THE ISSUE

1.1 This report deals with the evidence relating to 26 alleged public footpaths in Weston ward, Bath and seeks Committee approval to make a Definitive Map Modification Order (DMMO), to record the paths on the Definitive Map and Statement for the City of Bath.

### 2 **RECOMMENDATION**

2.1 That the Head of Transportation and Highways be granted delegated authority to take all action to make an Order to Modify the Definitive Map and Statement by adding the public footpaths as shown on the plans at Appendix 1, and to confirm the Order if no duly made objections are received to the Order.

### **3** FINANCIAL IMPLICATIONS

3.1 Financial implications are not a relevant consideration which may be taken into account under the provisions of the Wildlife and Countryside Act 1981. The costs associated with making an Order and any subsequent Public Inquiry would be met from the PROW budget.

### 4. LEGAL FRAMEWORK

- 4.1 Bath and North East Somerset Council, as Surveying Authority, is under a statutory duty, imposed by Section 53(2) of the Wildlife and Countryside Act 1981, to keep the Definitive Map and Statement of Public Rights of Way under continuous review.
- 4.2 Section 53(2)(b) states:

"As regards every definitive map and statement, the surveying authority shall:

...... keep the map and statement under continuous review and as soon as reasonably practicable after the occurrence ...... of any of those events, by order make such modifications to the map and statement as appear to them to be requisite in consequence of the occurrence of that event".

4.3 The 'events' referred to in subsection (2) are set out in section 53(3). The event relevant to this report is set out in section 53(3)(c)(i) as follows:

"The discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows –

"that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist....."

- 4.4 Anyone may apply to the Council for an Order to modify the map and statement, and such application must be determined in accordance with the provisions of Schedule 14 of the Act. The Council must also make an Order on its own initiative if it discovers evidence which justifies the making of an Order.
- 4.5 Documentary evidence is often considered in determining applications for Definitive Map Modification Orders. Section 32 of the Highways Act 1980 states:

"A court or other tribunal, before determining whether a way has or has not been dedicated as a highway, or the date on which such dedication, if any, took place, shall take into consideration any map, plan or history of the locality or other relevant document which is tendered in evidence, and shall give such weight thereto as the court or tribunal considers justified by the circumstances, including the antiquity of the tendered document, the status of the person by whom and the purpose for which it was made or compiled, and the custody in which it has been kept and from which it is produced."

### 5. THE REPORT

### **Background**

- 5.1 In 1957 the City and Waterworks Engineer's Department of Bath City Council completed a survey of public rights of way in the city. The document produced is titled 'Survey of Public Rights of Way: For the Purpose of Part IV of the National Parks & Access to the Countryside Act 1949'. A foot note on the schedule states "All footpaths walked by R.F. Little between June 1<sup>st</sup> & 30<sup>th</sup> 1955".
- 5.2 The 1949 Act established that public footpaths and bridleways that were in existence at that time were maintainable at public expense. It is assumed that the paths that were surveyed in 1955 were already in existence in 1949.
- 5.3 No 'official' action was taken on the above Act but the 1957 survey was a fairly comprehensive survey of the footpaths. A 6" scale map was produced showing footpaths within the city boundary. Four of the footpaths in Weston are shown on this map and statement. The map and list produced is available as a background paper.
- 5.4 Minute Item 22 from the Regulatory (Access) Committee Meeting, dated 12<sup>th</sup> December 2002 granted the Head of Transportation Access and Waste Management delegated authority to produce and consolidate a Definitive Map and Statement for the City of Bath.
- 5.5 The method of research is described in the document 'Definitive Map Plan (Working Document)' which is available as a background paper. The research began in the Weston ward in July 2004.
- 5.6 The City of Bath boundary expanded in 1966 to incorporate newly developed areas into the City. A Definitive Map and Statement had been prepared for the area surrounding Bath in the 1950s and so these additional areas are not included in the scope of this project. The boundary for the project is therefore taken to be the boundary of the City pre-1966.
- 5.7 A convention for classifying paths has been adopted. Whilst not always rigidly applied the following prefixes to a path number normally indicates:

"AQ": the path was recorded on the 1957 Survey, or there is good evidence that the path was in existence at that time, or the path is included in the Council's List of Streets maintainable at public expense.

If a right of way was in existence in 1949, by virtue of the National Parks and Access to the Countryside Act 1949, it became publicly maintainable.

"BQ": Paths established or identified since the 1957 Survey.

"CQ": Other paths identified for research as part of the project. The maintenance liabilities of these paths are unclear. Paths with a 'CQ' prefix have either been

identified by members of the public, from map based research or from a walking survey undertaken around the ward. Some of these paths have been included because a public right of way must start and finish on a highway and documentary evidence shows their existence as a continuance of an 'AQ' or 'BQ' path.

- 5.8 Section 36(6) of the Highways Act 1980 requires every highway authority to make, and keep up to date, a list of streets within its area. The list must contain all footpaths, bridleways and carriageways which are highways maintainable at public expense, whether or not they are shown on the definitive map.
- 5.9 Several of the 'AQ' paths are in two or more distinct parts, each part having been allocated the same reference number during the 1957 Survey. To avoid confusion during research, new numbers were allocated where there was duplication. The consequence of this is that historic information held on file for the path will refer to the old reference number whilst the new number has been used for advertising and consultations. Where applicable, the actual path reference number is listed in brackets. The paths affected are: AQ569 (part of AQ104); AQ559 and AQ560 (both part of AQ16). Any Orders made will be made using the reference number given during the 1957 Survey.
- 5.10 During research, paths were classed as routine or non-routine, as defined in the Bath Definitive Map Plan (Working Copy). Non-routine paths were put aside to be researched at a later date, outside of the scope of this project. A list of all paths included in the research at the beginning of the project is shown at Appendix 2. Only routine paths were included in the consultations with adjacent property holders and the general public. None of the paths consulted on were found to be non-routine.
- 5.11 A new reference number will be allocated to each path that has an Order made and confirmed. The numbering convention complies with British Standards and is described in the document 'Bath Definitive Map Plan (Working Document). Where a path has several distinct branches, a different path number will be allocated to each branch. This follows the convention used in the rural areas.

### **Landowners**

- 5.12 Attempts have been made to contact all landowners of land crossed by paths being considered in this report. A list of landowners is available as a background paper.
- 5.13 The majority of the paths in Weston are on land owned by Bath and North East Somerset Council and Somer Community Housing Trust.
- 5.14 A meeting was arranged on 26<sup>th</sup> October 2004 with Mr Bob Jones, Estate Services Team Manager for Somer Community Housing Trust. He was given a map of the City of Bath showing the paths on land owned by Somer Community Housing Trust.
- 5.15 A Land Registry search was carried out for all paths which are on land not completely owned by the Council or Somer Community Housing Trust.

- 5.16 Five paths are on land which is wholly unregistered and 6 paths are on land which is part unregistered. Where it is not practicable to ascertain the name or address of an owner or occupier, the authority can serve the notice of the making of an Order by affixing it to some conspicuous object(s) on the land. The notice may be addressed to the 'owner' or 'occupier'.
- 5.17 AQ165 crosses a tiny piece of privately owned land. 22 Cranwells Park owns a small section of land at the northern end of the path. From the deeds, it appears as though 21 Cranwells Park owns a tiny section of the verge. Both households received Public Rights of Way Evidence Forms during the consultation with adjacent property holders. Neither household stated that their land was crossed by the path, or indicated that they would object to the path being recorded as a public right of way.

### **Consultations**

### Ward Councillors and Interested Groups

- 5.18 In July 2004, the Councillors for Weston were sent a map and list of the paths to be included in the research. They were invited to comment on the list and to add any paths they felt were missing. No additional paths were added and none were removed.
- 5.19 In August 2004, the Councillors for Weston were sent another map showing the paths now classified as routine and non-routine and the reasons behind the classification. The list is shown at Appendix 2.
- 5.20 Consultation was made with the Councillors for the surrounding wards and other interested groups in August 2004. A map of the paths to be included in the research was sent and all parties were invited to add any paths which they felt to be missing and to comment on the ones to be included. The map included all of the paths classified as routine on the list shown at Appendix 2. A 10 week consultation period was given.
- 5.21 The Councillors for Weston were sent another map and list in December 2004 following the end of the consultation period with the interested user groups, the adjacent property holders and the general public. The map and list showed the paths to be put forward to the Regulatory (Access) Committee for inclusion on the Definitive Map and Statement for the City of Bath. It also showed those not to be included at this time along with the reasons for non-inclusion.

### **Adjacent Property Holders**

5.22 Consultation was made with all property holders living adjacent to the public rights of way being researched. The property holders were invited to complete a Public Rights of Way Evidence Form and to mark any sections of the path they used on the map attached. The information received can help ascertain the reputation of the route.

### **The General Public**

- 5.23 An exhibition was held in Weston Library from 22<sup>nd</sup> June to 10<sup>th</sup> July 2004 to display information about the project along with a map of the public rights of way to be included in the project. The public were invited to comment on the map.
- 5.24 At least one consultation notice was placed on each path, inviting the general public to write in with their comments within a response time of two months. The notices were checked regularly and replaced if necessary. The dates on which the notices were checked can be found as a background paper.

### Evidence of use of the path

### Ward Councillors and Interested Groups

5.25 The responses given by the Councillors for Weston, the Councillors for the surrounding wards and the interested groups consulted are shown at Appendix 3. No additional paths were added as a result of consulting these groups.

### **Adjacent Property Holders**

5.26 The evidence collected includes 108 signed Public Rights of Way Evidence Forms concerning 19 of the paths included in this project. Of these, 102 of the respondents had used the path they were consulted on. A précis of the information given on the forms is available as a background paper.

### The General Public

- 5.27 No comments were received as a result of the library exhibition.
- 5.28 A summary of the responses to the notices posted on each path is available as a background paper. Thirty two responses were received about 14 paths.

### Documentary Evidence

5.29 Apart from the 1957 Survey and the Section 36(6) Highways Act 1980 List of Streets, other documentary sources researched include:

A summary of the historical evidence for each path is shown at Appendix 4.

### Weston Tithe Map (1846)

5.31 Published by J.H. Cotterell - no public rights of way are shown on the map or mentioned in the apportionment.

### Assessing the Evidence

- 5.32 The council has collected both user and documentary evidence concerning each of the paths. Taken together, it is possible to make an Order under section 53(3)(c)(i) of the Wildlife and Countryside Act 1981 provided the relevant tests are met.
- 5.33 The Regulatory Committee has to decide what it considers are the correct facts and on the basis of those facts, whether, on <u>the balance of probabilities</u>, dedication of the path as a public footpath has been established.
- 5.34 Evidence has been collected from the general public and also from adjacent property holders to ascertain the nature of the use of the path and its reputation. It has not been possible to collect significant volumes of user evidence but all of the paths appear to be well used by the public. The information gathered will not be used as user evidence, but as information regarding the local reputation of the path.

### <u>Widths</u>

5.35 The widths of the paths have been determined by what appears to have been used by the public and by reference to historic maps. Where the paths are on adopted highway, we are seeking to record the public right of way across the whole width of the adopted section. Where there is no clear indication of the width used by the public, a standard width of 1.8m will be used.

### 1. Landowner

The land is not registered under the Land Registration Act and Rules.

## 2. Evidence of use of the path

**Comments from adjacent property holders** Two responses were received. Both used the path on foot and believed it to be a footpath. The length of path usage was 8 and 16 years.

The frequency of use was approximately 250 times a year and 'lots' of times a year.

# Comments from the general public (in response to notices posted on site)


- 'I have lived on the Estate for over 40 years and this path has always been used by most of the people living at Greenacres, as well as walkers'.
  - 'It gives an alternative way home avoiding walking along the main road'.
- 'I wish to express my belief that as the paths (AQ104 and AQ569) have been recognised as Public Rights of Way for so long this should continue.'

## 4. Surface Condition

The steps are concrete and the surface of the path is tarmac. It is in a good condition.





### 5. Decision


The path appears on OS Maps, at least as early as 1903. It was included on the 1957 City Engineer's Survey and is on the List of Streets.

Few responses were received regarding use of the path but this does not mean that the path is not well used by the public.

## 6. Officer Recommendations

Officers are satisfied that the evidence gathered about AQ104 is sufficient to make an Order under section 53(3)(c)(i) of the Wildlife and Countryside Act 1981.

The recommendation is that this path is recorded as a public footpath and added to the Definitive Map and Statement for the City of Bath.

### 5.37 Summary of Evidence for Path AQ165 – Refer to the path shown as A-B at Appendix 1, AQ165

### 1. Landowner

The majority of the land is not registered under the Land Registration Act and Rules. A small section of the land is owned by:

- 1. JR & KM Slater of 22 Cranwells Park, Bath, BA1 2YD.
- 2. AWJ & KP Simpson of 21 Cranwells Park, Bath, BA1 2YD.

Neither landowner indicated that they would object to an Order being made.

### 2. Evidence of use of the path

### Comments from adjacent property holders

Five responses were received, although only 4 respondents had used the path. All respondents used the path on foot and believed it to be a footpath. Length of path usage ranged from 3 years to 33 years. The frequency ranged from at least 20 times per year to daily.

One respondent remembered being given a plan of the estate showing the paths when they bought the house. This path was included on the plan. Another makes the comment of '*regular usage, apparently for* 40+ years'.

### Comments from the general public (in response to notices posted on site)

 'I have used this footpath for over 20 years since 1983. No one has ever objected to my use of the path and the surface has been maintained from time to time'.

- *...we use the above rights of way as routes to Weston Lane and return for the school run'.*
- The family used the path at least twice a week for about 10 years from 1966. 'Now as a retired couple we frequently use the path'.

### 3. Documentary Evidence

**OS Maps:** Not shown on any of the maps checked.

Bath City Engineer's Survey: Not included. List of Streets: Adopted Highway. Previous Orders Made: None.



### 4. Surface Condition

The surface of the path is tarmac. In some places the tarmac has been renewed but in others potholes are forming.

### 5. Decision


The path does not appear on the OS Maps checked. However, it was included on the 1957 City Engineer's Survey and is on the List of Streets.


### 5. Decision

The path appears to have been in existence since the 1960s and was probably created as part of the housing estate development. There is insufficient evidence to determine whether or not the path was created for use by the general public or just for those living on the housing estate.

### 6. Officer Recommendations

Officers are not satisfied that the evidence gathered about CQ15 to date is sufficient to make an Order under section 53(3)(c)(i) of the Wildlife and Countryside Act 1981.

The recommendation is that a Dedication Agreement is sought with the landowner to record this path before it can be added to the Definitive Map and Statement for the City of Bath.

### 1. Landowner

5.56

Part of the land is not registered under the Land Registration Act and Rules. The rest is owned by Somer Community Housing Trust.

# 2. Evidence of use of the path

**Comments from adjacent property holders** Four responses were received. All respondents used the path on foot and believed it to be a footpath. Length of path usage ranged from 20 years to 53 years. The frequency ranged from daily to approximately 1500 times per year.

### Comments from the general public (in response to notices posted on site) None Received.

## 3. Documentary Evidence

OS Maps: The path is shown on the 1966 map in its current position. Bath City Engineer's Survey, 1957: Not included. List of Streets: Not included. Previous Orders Made: None.

## 7. Surface Condition

The steps are concrete and the surface of the path is tarmac. It is generally in a good condition but vegetation is growing through in places.

### 6. Officer Recommendations Officers are not satisfied that the evidence

Officers are not satisfied that the evidence gathered to date about CQ21 is sufficient to make an Order under section 53(3)(c)(i) of the Wildlife and Countryside Act 1981.

The recommendation is that a Dedication Agreement is sought with the landowner to

record this path before it can be added to the Definitive Map and Statement for the City of Bath.





### 6 RATIONALE

- 6.1 The surveying authority must make an Order on its own initiative if it discovers evidence which shows that a right of way which is not shown on the map and statement subsists or is reasonably alleged to subsist.
- 6.2 After analysis of the submitted evidence, officers are satisfied that the relevant legislation (Wildlife and Countryside Act 1981 section 53(3)(c)(i)) has been met and that an Order should be made for all paths except CQ14, CQ15 and CQ21, for which a Dedication Agreement will be sought.

### 7 HUMAN RIGHTS IMPLICATIONS

- 7.1 The Human Rights Act incorporates the rights and freedoms set out in the European Convention on Human Rights into UK law. So far as it is possible, all legislation must be interpreted so as to be compatible with the convention.
- 7.2 The Committee is required to consider the application in accordance with the principle of proportionality. The Committee will need to consider the protection of individual rights and the interests of the community at large.
- 7.3 In particular, the convention rights which should be taken into account in relation to this application are Article 1 of the First Protocol (protection of property), Article 6 (the right to a fair hearing) and Article 8 (right to respect for family and private life).

### 8 OTHER OPTIONS CONSIDERED

8.1 Local Authorities are under a statutory duty to consider evidence and make Orders within the provisions of section 53 of the Wildlife & Countryside Act 1981. The Regulatory (Access) Committee is required to make a decision whether or not to make any DMMO.

### 10 CONCLUSIONS

10.1 Officers are satisfied that, on the balance of probabilities, the evidence gathered for AQ104, AQ165, AQ172, AQ305, AQ306, AQ307, AQ308 & CQ20, AQ309, AQ551,

AQ553, AQ554, AQ558, AQ310, AQ313, CQ19, AQ340, AQ559 (AQ16), AQ560 (AQ16), AQ569 (AQ104), BQ4, CQ18 & CQ22, BQ22, BQ25 and BQ26 is sufficient to conclude that they should be recorded as public footpaths and that DMMOs should be made to that effect. It may be that higher rights exist, but these have not been proved at this time.

10.2 Paths CQ14, CQ15 and CQ21 have only been recorded on maps from the 1960s and later. The decision has been made to seek a Dedication Agreement with Somer Community Housing Trust to record these paths as public footpaths.
