1. I am the person who has signed the application Form 30.
2. The facts set out herewith are to the best of my knowledge and belief fully and truly stated and I am not aware of any other fact which should be brought to the attention of the registration authority as likely to affect its decision on the application, nor of any document relating to the matter other than those attached to Form 30 or attached herewith.
3. The plan now produced and shown to me marked "B" is referred to in part 3 of the application, describing the land claimed to have become a town or village green.
4. The plan now produced and shown to me marked "C" is referred to in part 3 of the application, describing the neighbourhood within the locality.

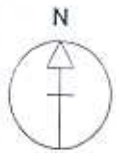

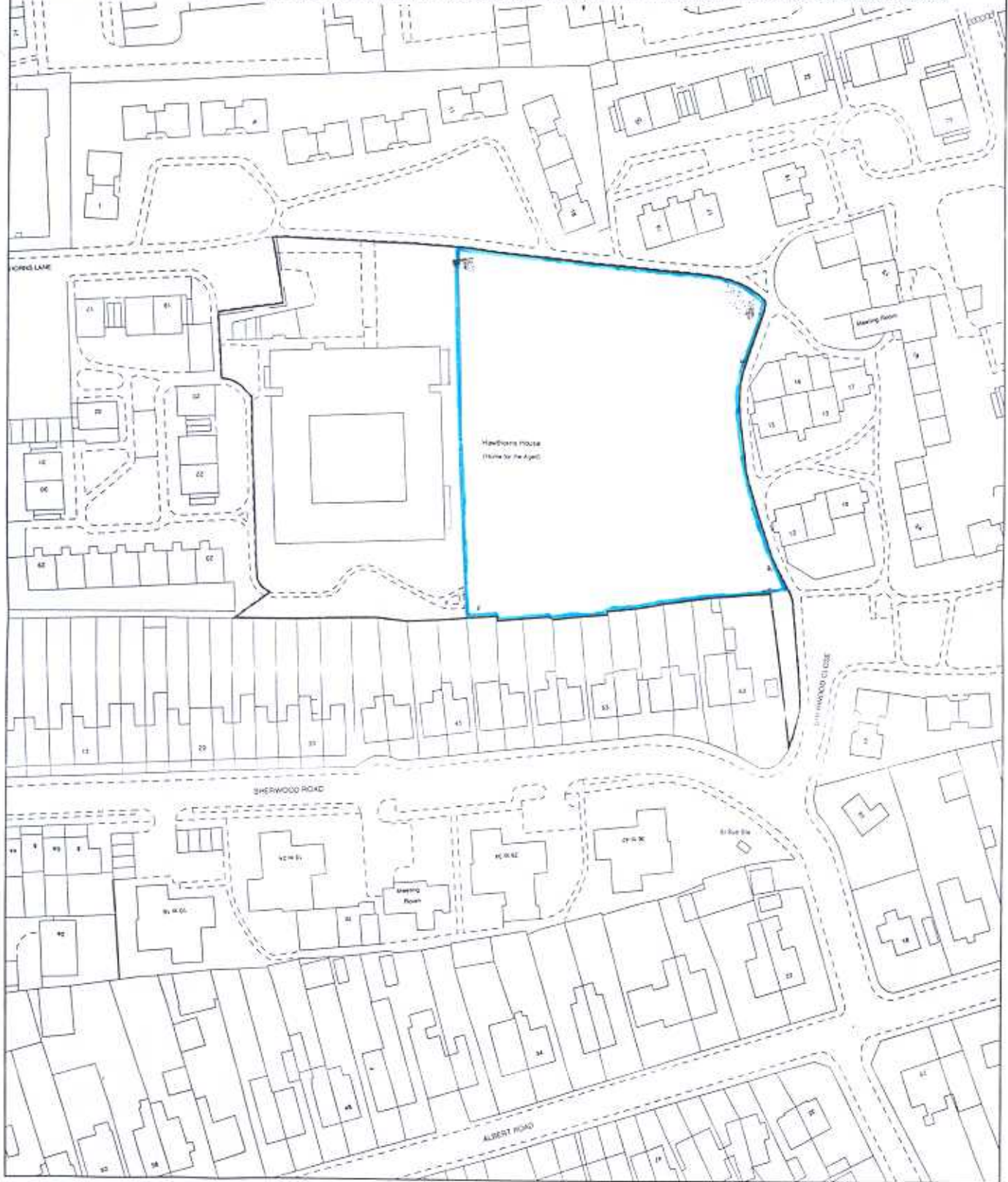
BATH AND NORTH EAST SOMERSET
