Agenda Item 8 - Amendments to the Constitution

- 1.4 On a recommendation from Group Leaders, amend the Constitution to formalise the position that political group motions continue to be taken as the last items on the agenda, as described in paragraphs 3.6 – 3.8;
- 1.5 On a recommendation from Group Leaders, agree to remove the Petition scheme from the Constitution, as described in section 3.9 – 3.14.

Agenda item 12 - initiatives to improve children's wellbeing

Liberal Democrat Amendment to Conservative Group Motion

Council **acknowledges that:**

1. This Council notes that the COVID-19 pandemic will have **has** had some detrimental effects on the wellbeing of children **a devastating impact on the wellbeing of many of our young people living both here** in B&NES **and across the UK**. Being isolated from friends and having to learn from home ~~have been~~ **are** significant challenges for young people and their parents **and carers** over the past 12 months.
2. This Council notes that Bath BID Company (Business Improvement District) is planning to run a 'Summer Sundays' programme from June to August to improve children's wellbeing. The programme will see various family activities take place in local parks and the city centre.
3. This Council recognises the positive impact this programme could have on the wellbeing of children and parents following a year of isolation.

4. All children have suffered from the repeated closure of schools, clubs and associated support services and many have also experienced ill health and loss within their own families.
5. Those children from disadvantaged backgrounds and those with disabilities have been impacted the most. Disabled children have been “incarcerated” in their homes and some have “barely had any formal education since lockdown began” according to Christine Lenehan, Director of the Council for Disabled Children.
6. Despite the very best efforts of our schools, health professionals and third sector organisations working here in B&NES, many in this generation of children have seen their education impacted heavily and regularly we are reminded about the increases in the mental health issues that have arisen.
 - a. In January this year the Princes Trust reported that “more than half of young people were always or often feeling anxious - the highest level ever recorded”.
 - b. The Office of National Statistics study showed a significant increase in mental illness, in their study girls aged 11-16 who are struggling with their mental health increased from 13.9% to 20.1% whilst boys aged between 5 - 10 years increased from 11.5% to 17.9%.
 - c. Child loneliness increased by 10% in this period according to the NSPCC.
 - d. Councils across the country between April and September 2020 reported that there were 285 incidents of child death and severe harm, a rise of a quarter from the same period in 2019.
7. On numerous occasions during the pandemic the Government has failed to provide the support, guidance and funding to enable key services, such as schools, health professionals and third sector organisations, to meet the needs of children throughout the pandemic thereby directly increasing the harm suffered by this generation.

Council therefore:

8. Praises those working in schools, health care settings and third sector organisations who have strived to support our children and their parents and carers here in B&NES throughout the pandemic.
9. Calls upon Government to make addressing the legacy of the pandemic on our children a priority. This must include ensuring that very significant funds are made available to support children, their families, schools and those organisations supporting them.
10. Wishes to support initiatives such as that being run by the Bath BID Company to run a ‘Summer Sundays’ programme from June to August to improve children’s wellbeing. The programme will see various family activities take place in local parks and the city centre.
11. ~~Praises Bath BID for developing the programme and requests~~ **Requests** that the Leader of the Council takes steps to organise within the next three months an online symposium of relevant local groups, charities, schools, parent groups, cultural organisations and educational experts, to discuss strategies to help parents and children in Bath and North East Somerset overcome the challenges of the past twelve months.
