4. Declarations of Interest

Cllr Eleanor Jackson declared a personal interest in that the complainant in this case was a fellow member of the Labour Party and a personal friend.

5. Urgent business

On a point of information, the Chair informed the meeting of the changes to the Standards regime that were being proposed by the government as part of the Localism Bill. It was noted however, that should these changes take place, the bill would not become law until late 2011. In the meantime, the Standards Committee would continue to operate under the current Local Standards Framework.

8. <u>Minutes of the meeting of 25th November 2010</u>

Following a proposal by Cllr Jackson, seconded by Cllr. Roberts, both the public and exempt minutes of the meeting of 25th November were agreed as a correct record and signed by the Chair.

9. Dispensation – Combe Hay Parish Council.

The Corporate and Community Law Manager drew the Committee's attention to an error in Paragraph 4.3(c) of the report. It should be noted that the relevant date was

May 2007, not 2011. A further dispensation had been granted by the Standards Committee to six members of the Parish Council on 24th May 2007. If the Committee decided to grant the current application, the wording should be agreed as in May 2007.

The Committee had received an application for a dispensation by Councillor Frank Davis of Combe Hay Parish Council to enable him to speak on matters connected with the site of the former Fullers Earth works and surrounding fields, hillside and woodland. The Chair invited the Clerk to Combe Hay Parish Council, Mr Duppa-Miller, to inform the Committee of the reasons for the request for dispensation.

Mr Duppa-Miller explained that, of the present 7 members of the Parish Council, 5 have dispensation. Due to the nature of their occupations, many of the parish councillors had to send apologies for attendance at short notice. This caused meetings to be cancelled or postponed on a regular basis due to the fact that the agenda at meetings could typically involve up to11 items relating to the Fullers Earth site and so it was difficult to attain quoracy. Therefore, in order for parish business not to be impeded, it was important that the dispensation for the latest member, Mr F Davis, was granted.

Following a proposal by Cllr Roberts, seconded by Cllr. Palmer, it was agreed to grant the dispensation to Cllr Frank Davis of Combe Hay Parish Council; the dispensation to run until the next parish elections in May 2011.

10. Standards Committee Hearing Procedure

The Chair informed the meeting that the hearing would be conducted using this procedure.

11.<u>Consideration of an Investigating Officer's Report about Allegations of Breaches of the Code of Conduct by a Councillor</u>

The Committee considered the factors for and against disclosure as contained in Appendix 1 to the report in order to determine whether the information contained in Appendix 2 should be exempt. Following discussions, the Chair put the issue to the vote. It was decided by a majority that the session be held in private and so the decision was taken to exclude the public.

After submissions from the Investigating Officer and the subject councillor and questions from the Committee, the Committee members withdrew to consider their decision.

The Committee re-convened and the Chair announced their findings as follows:

FINDINGS

The Standards Committee has considered the Investigating Officer's report and the discussion preceding these deliberations. It has concluded that on 22nd April 2010, Councillor Cray has breached Paragraph 4 (a) of the Code of Conduct by revealing the identity of the complainant who had been granted anonymity by the Standards Committee at their meeting on 30th March 2010.

SANCTIONS

The subject councillor must apologise in writing to the Standards Committee.

He must also undertake training in the Code of Conduct; both actions to be undertaken within three months of the date of this hearing.

The Committee wishes the Monitoring Officer to report when the training has taken place to his satisfaction.

The Chair added that it would be timely to remind all councillors of their responsibility to observe confidentiality when required and asked that the Monitoring Officer examine that way that information about the Standards Committee decisions is disseminated.

She thanked everyone for their contributions.

4 THE REPORT

4.1 This report is presented by the Council's Monitoring Officer to enable the Committee to consider the Investigating Officer's Report which is attached at Appendix 1.

- 4.2 The investigation has been carried out in accordance with the Council's approved procedure. A copy of the Investigating Officer's Report, and the agenda for this meeting has been sent to the Councillor against whom the allegation was made, the person who made the complaint and the Clerk to the relevant Parish Council.
- 4.3 The Committee's role at this stage is to decide whether, based on the facts set out in the report, it agrees with the Investigating Officer's finding that there has been no breach of the Code or believes there is a case to answer. The Committee should simply consider the report; it should not seek to interview witnesses or take representations from the parties.
- 4.4 If the Committee agrees that the Code of Conduct has not been breached, arrangements will be made for a notice to be published. The notice will state the Committee's findings and give reasons for it. The councillor involved is entitled to ask that the notice not be passed to local newspapers.
- 4.5 If the Committee decides that there is case to answer, it will be necessary to hold a hearing to make the final determination on whether the Code of Conduct was breached.

Appendix: Monitoring Officer's Report into Complaint Concerning Councillor X – 19-10 B&NES

The Report contains exempt information, according to the categories set out in the Local Government Act 1972 (amended Schedule 12A). The relevant exemption is set out below.

Stating the exemption:

- 1. Information relating to any individual
- 2. Information which is likely to reveal the identity of an individual

The public interest test has been applied, and it is concluded that the public interest in maintaining the exemption outweighs the public interest in disclosure at this time. It is therefore recommended that the Report be withheld from publication on the Council website. The paragraphs below set out the relevant public interest issues in this case.

Factors for withholding:

- The appendix takes the form of documents compiled on behalf of the Monitoring Officer in a form required by law. They contain confidential details of allegations made against the Councillor concerned, the evidence of those whom the Investigating Officer has spoken to and the conclusion of the Investigating Officer as to whether or not the Code of Conduct for Members has been breached. It is, however, no more than the opinion of the Investigating Officer. The only stage at which it will be known definitively whether or not the Code of Conduct has been breached is when a hearing takes place into the report. Such a hearing will not take place until after the meeting to which this report is presented - in other words, some weeks into the future. The role of the Committee at this stage is merely to consider whether or not the matter should be determined conclusively by another body, namely the Adjudication Panel for England. At this stage, there is no apparent public interest in disclosing details of the allegations and the conclusions about them, since there is no competent body at this stage to reach a definitive view of the facts as presented.
- If the Committee conclude that there was no breach of the Code there is an entitlement of the Member who has been exonerated by the investigation to prohibit any publication of information about the complaint if he or she so wishes. This right is contained in Regulation 17(4) of the Standards Committee (England) Regulations 2008, an absolute right for the Member where there has been a finding of no breach to prohibit publication either of the details of the allegations against him or her and the fact that it has not been proven. In such cases, public consideration of the report containing the allegations would render redundant the power of the Member concerned to prohibit publication of the unfounded allegation made against them.

Factors for disclosure:

• The Standards Board for England guidance states as follows:-

'Despite the ability of the subject Member to prohibit the publication of a notice, the decision as to whether to maintain an exemption does not always have to result in the public being excluded from a meeting. It also does not always have to result in excluding details of the complaint for the report sent out in advance of the meeting. In most cases, the public interest and transparent decision making by the Standards Committee will outweigh the subject Members interest in limiting obligation or an unproven allegation that has not yet been determined'.

Reasons why the public interest favours withholding the information:

- It is considered that the prejudice to the interests of the complainant and the member the subject of the complaint were the report to be discharged outweigh any benefit by way of openness.
- It is considered that the public interest is not served by having possible unfounded allegations entered into the public domain until such time as there is a body that is competent to deal with and decide on the allegations made.
