1 EMERGENCY EVACUATION PROCEDURE

The Democratic Services Officer read out the procedure.

2 ELECTION OF VICE-CHAIR (IF DESIRED)

RESOLVED that a Vice-Chair was not required on this occasion.

3 APOLOGIES FOR ABSENCE AND SUBSTITUTIONS

There were none.

4 DECLARATIONS OF INTEREST

Councillors Nicol and Batt both declared an Other Interest, in that they were acquainted with Mr Peter Morgan. They stated that they had not discussed the application with each other.

Mr Phipps said that he accepted that in a small town in was inevitable that Councillors would be acquainted with many residents and business people and that he had no objection to the two Members participating in the hearing.

5 TO ANNOUNCE ANY URGENT BUSINESS AGREED BY THE CHAIR

There was none.

6 MINUTES: 24 JULY 2012

These were approved as a correct record and signed by the Chair.

7 LICENSING PROCEDURE

The Chair drew attention to the licensing procedure, copies of which had been made available to those attending the meeting.

8 APPLICATION TO VARY A PREMISES LICENCE FOR THE TRINITY INN, 49 JAMES STREET WEST, BATH BA1 2DA

Applicant: Punch Taverns, represented by Peter Morgan (Abbey Ales) and Matthew Phipps (TLT Solicitors)

Responsible Authority: Avon and Somerset Police, represented by Martin Purchase (Liquor Licensing Officer)

The parties confirmed that they had received and understood the licensing procedure.

The Senior Licensing Officer summarised the application, which was for a variation of an existing premises licence. The details of current premises licence were set out in paragraph 4.2 of the report and the details of the variation application in paragraph 4.3. The premises were situated in the cumulative impact and that Police had proposed an additional five conditions to further the licensing objectives of the prevention of crime and disorder and the prevention of public nuisance. These conditions were listed in paragraph 4.14 of the report. The applicant had indicated through its solicitors its willingness to accept these conditions.

Mr Phipps stated the case for the applicant. He explained that the premises would be the fourth public house to be operated by Abbey Ales in the City of Bath. Abbey Ales had already turned round three failing public houses, which, he submitted, were now assets to the City, because they were successful and fully compliant with the licensing objectives. He stated that the applicant had given written notice of its willingness to accept the conditions proposed by the Police. However, it had been brought to his attention that the fourth condition proposed by the Police, namely that "there will be no live or recorded music after 12.00 midnight on any day" should have referred to all forms of regulated entertainment and that the applicant would accept the condition so amended. He believed that there were no outstanding issues between the applicant and the Police and urged the Sub-Committee to grant the application.

The Senior Licensing Officer pointed out that the condition referred to by Mr Phipps would, if imposed, reduce the non-standard hours for regulated entertainment permitted under the existing premises licence, for which the terminal hour was 01.00. Mr Phipps suggested that in that case the condition should not be imposed, but that instead the applicant would amend the application so that the standard terminal hour sought for all forms of regulated entertainment would be 12.00 midnight. In response to a question from the Senior Licensing Officer he confirmed that the applicant would withdraw that part of the application relating to non-standard timings for regulated entertainment, leaving the terminal hour for these as 01.00 as at present.

Mr Purchase said that he nothing to add and did not wish to make a statement.

The Sub-Committee adjourned and then reconvened to seek clarification from the applicant about the meaning of "new entry" in the third condition proposed by the Police, "there will be no new entry to the premises after 00.30 each day." Mr Phipps stated that he had always understood that there was a distinction between "entry" and "re-entry" and that the condition would permit the re-admission of customers who had temporarily left the premises to smoke.

Following a further adjournment, it was **RESOLVED** to grant the licence as applied for with modifications together with the conditions consistent with the Operating Schedule and the conditions proposed by the Police and agreed to by the applicant.

Authority was delegated to the Licensing Officer to issue the licence accordingly.

Reasons

Members have today determined an application for the variation of a premises licence for The Trinity Inn, 49 James Street West, Bath.

In doing so they have taken into account of the Licensing Act, Human Rights Act, the Council's Policy and the Statutory Guidance.

Members are aware that the proper approach under the Licensing Act is to do only what is appropriate, proportionate and justifiable to promote the licensing objectives in light of what is presented to them.

Members considered the relevant representations and took account of the evidence put before them. They were careful to balance the competing interests of the applicant and those of the Responsible Authority, i.e. the Police in reaching a decision.

Members noted that the Police had made representations on the basis that the premises were in the city centre and also fell within the area of cumulative impact as define in the Council's Policy.

The effect of adopting a cumulative impact policy is to create a rebuttable presumption that applications for new premises licences, club premises certificates or variations will be refused if relevant representations are received.

If the application is not to be refused then the applicant will have to demonstrate that the operation of the premises will not add to the cumulative impact already being experienced.

The Police had stated that the area suffered from crime, disorder and from revellers who behaved in an anti-social manner as they moved between licensed premises which included looking for the premises that may be open last.

It was said that the location, where the premises were based, could exacerbate tension in persons already fuelled by alcohol and, as the premises was based in the cumulative impact area, the later hours for the sale of alcohol and regulated entertainment could exacerbate the level of crime and disorder and anti- social behaviour in that area. Furthermore, as the area was residential, noise nuisance could be caused by the extension of the licensable activities.

The Police considered that the application did not sufficiently forward the promotion of the licensing objectives and mitigate the effects of such problems. In order to address this, the Police had proposed a number of conditions to which the applicant had agreed.

The Members considered that, if the proposed conditions were imposed on the Premises Licence, to grant the application would be unlikely to add to significantly to the cumulative impact having regard to the licensing objectives.


The Members noted that the applicant had amended the application to state that all regulated entertainment, the provision of facilities for dancing and the provision of facilities making music would cease at 00.00 (midnight) on a Thursday, Friday and Saturday.

They also noted that the applicant had withdrawn that part of the application related to the non-standard timings which concerned regulated entertainment, the provision of facilities for dancing and making music.

LICENSING ACT 2003

LICENSING COMMITTEE HEARING PROCEDURE ALCOHOL, LATE NIGHT REFRESHMENT AND ENTERTAINMENT

- 1. The Chair will introduce Members of the Sub-Committee and Officers present and explain the procedure to be followed.
- 2. The Licensing Officer will outline the nature of the matter to be considered by the Sub-Committee.

In the following paragraphs where the term "party" or "parties" is used in addition to other terms this will mean anyone to whom notice of this meeting has been given.

- 3. (i) The Applicant/Licence Holder ("the Applicant"), or representative, addresses the Sub-Committee. The Applicant may be asked relevant questions about the matters before the Sub-Committee by the other parties and the Members.
 (ii) The Applicant, or representative, may call witnesses in support of the application and each witness may be asked relevant questions by the other parties and the Members.
- **4. (i)** Any interested parties [defined in s.69(3)] making relevant representations, or representative, will take it in turn to address the Sub-Committee. You may be asked relevant questions by the other parties, the Applicant and the Members.
 - (ii) You (or your representative) may call witnesses in support of your representations and each witness may be asked relevant questions by the Applicant, the other parties and the Members.
- 5. Any Responsible Authority [defined in s.69(4)] making a representation will address the Committee. The Responsible Authorities may be asked relevant questions by the Applicant, other parties and the Members.
- **6.** The Applicant will then be invited to briefly summarise the application.
- 7. The other parties will then be invited in turn to briefly summarise their points if they wish in the same order as before.
- 8. The Chair will invite the Sub-Committee to move into private session to enable the Sub-Committee to deliberate in private in accordance with Paragraph 14(2) of the Hearings Regulations 2005. The Sub-Committee will only reconvene to resolve any points of uncertainty on the evidence already given. During their deliberation the Sub-Committee will be accompanied *for advice only* by the Legal Advisor and the Committee Administrator. The Sub-Committee may retire to a private room or alternatively require vacation of the meeting room by all other persons.
- **9.** When the Sub-Committee resumes, the Chair will announce the decision in public; this will include the reasons (or advise that the decision will be released in writing with reasons within the statutory time limit in this instance 5 working days).

PLEASE NOTE:

- Where the Sub-Committee considers it necessary to do so, it may vary this procedure.
- Decisions will generally be taken regardless of whether the Applicant is present. All notices and representations received from absent parties will be considered.
- Only in <u>exceptional circumstances</u> will the Committee take into account any
 additional late documentary or other information produced by an existing party
 in support of their application/representation. This will be at the discretion of
 the Chair and with the agreement of all the other parties. No new
 representations will be allowed at the hearing.
- The hearing will take the form of a discussion However, the Council will allow all parties to ask questions of another party present, as set out above, but formal cross examination will be discouraged.
- The Authority will disregard any information or representation given by a party which is not relevant to the Application and the Licensing Act 2003.
- The Chair will allow the parties an equal maximum period of time in which to make representations. The amount of time will be at the discretion of the Chair, but in the interests of costs and efficiency will not normally exceed twenty minutes. This will include the time taken for the presentation and the summing up, but not the time taken for questions.
 - N.B. Where there is more than one party making relevant representations the time will be split between those parties. It is recommended that they arrive early to discuss the application with the other interested parties.
- The Chair may require any person attending the hearing who is behaving in a disruptive manner to leave the hearing and refuse to allow that person to return, or only allow them to return subject to certain conditions. Any person so excluded will however be entitled to submit to the Sub-Committee any information which they would have been entitled to give orally had they not been required to leave.
- Bath & North East Somerset Council is committed to taking decisions in an honest, accountable and transparent fashion, but on occasion may find it necessary to exclude members of the press and public based upon the legal framework given in the Local Government Act 1972 Schedule 12 (a). On these occasions decisions based on the above framework will be given.

1 THE ISSUE

1.1 An application has been received for a new Premises Licence under s.17 of the Licensing Act 2003 in respect of The Coco Lounge, 55 High Street, Midsomer Norton BA3 2DQ.

2 RECOMMENDATION

2.1 That the sub committee determines this application.

3 FINANCIAL IMPLICATIONS

3.1 The costs of processing licences are covered by the fees charged. The fee for this application is £190.

4 THE REPORT

- 4.1 An application has been received for a new Premises Licence (Annex A).
- 4.2 The application is for:
 - 1) The Sale of Alcohol for consumption both on and off the premises:

Monday - Thursday

11:00 to 18:00

Friday – Saturday

11:00 to 22:30

2) Opening hours

Monday – Thursday

08:00 to 18:00

Friday – Saturday

08:00 to 22:30

- 4.3 A site plan is attached at Annex B.
- 4.4 The Licensing Act 2003 (Section 4) states that it is the duty of all Licensing Authorities to carry out their functions under the Act with a view to promoting the licensing objectives. The licensing objectives are:
 - a) The Prevention of Crime and Disorder
 - b) Public Safety
 - c) The Prevention of Public Nuisance
 - d) The Protection of Children from Harm.

Each objective is of equal importance. As there are no other licensing objectives, these four are of paramount consideration at all times. When considering applications, representations or notifications, the Licensing Authority will have regard to these licensing objectives.

- 4.5 The Licensing Authority may grant the application with or without additional conditions.
- 4.6 Section 4(3)Licensing Act 2003 states that the Licensing Authority should also have regard to the Council's Licensing Policy, the Statutory Guidance issued under Section 182 of the Licensing Act 2003, and the Licensing Act itself, and in particular to:
 - a) Paragraphs 3, 5, 6, 9, 10, 15 20, 23, 24, 28, 33 37, 41 to 44 of the 2011 policy.
 - b) Chapters 8, 9 and 10 of the Statutory Guidance (as revised in April 2012).
 - c) Sections 4, 9, 10, 11, 12, 13, 16, 17, 18, 23, 182, 183, and Schedule 2 of the Act.
- 4.7 The Licensing Authority recognises that Licensing and Planning are separate regimes. Where an application is granted by the Licensing Authority which would require planning permission this would not relieve the applicant of the need to obtain that permission. It will still be necessary for the applicant to ensure that he/she has **ALL** the necessary permissions in place to enable them to run the business within the law.
- 4.8 If the application is refused the applicant may appeal within 21 days of the notification to the Magistrates' Court. If the application is granted the person making the relevant representation may appeal within 21 days of the notification to the Magistrates' Court.

On appeal the court may either dismiss the appeal, substitute the decision appealed against for any other decision which could have been made by the Licensing Authority, or remit the case to the Licensing Authority to dispose of in accordance with the direction of the court. The court may make such order for costs as it thinks fit.

- 4.9 In accordance with the requirements of the Act the applicants served copies of the application upon the police, the fire authority, environmental health, development control, trading standards, health authority and the child protection agency.
- 4.10 The applicant is required to place a notice at the premises for a period of 28 days starting the day after the application is made and place an advert in a local newspaper within 10 days for submitting the application to the licensing authority.
- 4.11 Representations have been received from the Stanley Court Residents' Association, two Stanley court residents, the PEOPLE charity and Midsomer Norton Town Council. They express concern that the applicant's proposals shall undermine both the crime prevention and the prevention of public nuisance objectives (Annex C).
- 4.12 The following condition has been proposed by the Stanley Court Residents' Association:

"No alcohol to be served to the terrace area after 9:00pm"

In response, the applicant has agreed in writing to the following condition as detailed in Annex D:

"The terrace area will not be used after 9pm"

4.13 This report has not been sent to the Trades Union because they would have no involvement.

5 RISK ASSESSMENT

5.1 A risk assessment related to the issue and recommendations has been undertaken, in compliance with the Council's decision making risk management guidance.

6. EQUALITIES

6.1 An Equality Impact Assessment (Eq1A) has been completed. No adverse or other significant issues were found.

7 CONSULTATION

7.1 In accordance with the Licensing Act 2003 (Premises Licence and Club Premises Certificate) Regulations 2005, the applicant has given notice of the application to all the relevant Responsible Authorities and has advertised the application in the manner prescribed, both at the premises and within a local publication.

8 ISSUES TO CONSIDER IN REACHING A DECISION

- 8.1 When reaching a decision, the Licensing Authority must carry out its functions with a view to promoting the four licensing objectives.
- 8.2 Consideration must be given to the Human Rights Act 1998 and the "convention rights".

9 ADVICE SOUGHT

9.1 The Council's Monitoring Officer (Divisional Director-Legal & Democratic Services), section 151 Officer (Divisional Director-Finance) and the Divisional Director have had the opportunity to input to this report and have cleared it for publication.



It is accepted that most of these premises are to the bottom end of the High Street it is our concern that if Coco Coffee Lounge is granted a licence to serve alcohol this will cause a movement of patrons further up the High Street and may also be used as a stopping off point for drinkers heading towards the Stones Cross.

The premises has a patio area at the front of the premises where customers will consume alcohol. Clientele of Coco Coffe Lounge have to cross the front of PEOPLE in order to access this premises. PEOPLE carry out a number of activities in their premises next door involving people with disabilities. We are concerned that the presence of people on the patio would affect those entering our premises and make them reluctant to approach the site.







The building is a terraced property situated at the top end of the High Street and is located within the main town centre.

This application relates to the change of use of the tea rooms/kitchen showroom (mixed use class A1 & A3) to cafe (class A3) incorporating ramped access and new shop front with canopy. To the front of the building is a small terrace area with proposed seating that would be enclosed by a small boundary wall.

The site falls within the Conservation Area and Housing Development Boundary.

Officer Assessment:

The key issues in the consideration of this proposal relate to the impact of the change of use on the viability of local shops, amenity of surrounding buildings and the impact on the Conservation Area.

Impact on the viability of local shops

The building is located within a row of shops that provide local amenities to the area of the city that is primarily in A1 use. In this row there is a vacant shop florists, a second hand shop and a number of takeaways. An officer assessment of town centre uses in Autumn, 2010 demonstrated that overall it was estimated that approx. 53% of town uses were A1 (retail) which was evident upon site inspection. Furthermore the existing premises has a split use which includes A3.

Policy S.8 of the Local Plan states that the change of use away from A1 in district, local and village centres will only be supported when it does not adversely impact the vitality and viability of the

centre. As a good proportion units remain in A1 use it is not considered that the proposed change of use will adversely affect the vitality and viability of the centre and the proposal would comply with Local Plan policy S.8.

Impact on residential amenity

To the rear and side of the building are residential properties and whilst no comments or objections have been raised consideration has been given to the level of potential noise and nuisance an A3 use may cause. Comments received from our Environmental Health officer has raised no objection. Noting the amenity issues that may arise it is relevant that conditions are attached to this permission to ensure that hours of operation are between 0800 - 1800 Monday to Saturday and that the use relates to a cafe only. The installation of any ventilation system at the premises would also need to be subject to a separate planning application and are not included within this proposal. It is also considered relevant to attach a condition that requests an operational statement for the running of the cafe.

It is considered that the nature of the business and the hours within which it will operate subject to conditions would not have a significant adverse impact on neighbouring properties and is considered to be acceptable.

Impact on the Conservation Area and World Heritage site

The proposed alterations to the shop front would remove an unsightly fascia board with new signage and canopy. This would be viewed alongside the side projection of the adjoining property no. 55a. Other minor alterations include replacement windows and the reinstatement of a low boundary wall with side ramped access. The proposal would not cause harm to the character or appearance of the Conservation Area.

The proposal is therefore recommended for permission subject to conditions as it would accord with Local Plan policies D2, D4, ES10, ES12, BH6, S1 and S8.
