#### 5 MINUTES OF THE MEETING OF 25TH MAY 2017

These were approved as a correct record and signed by the Chair.

**RESOLVED** that the Committee having been satisfied that the public interest would be better served by not disclosing relevant information the public shall be excluded from the meeting in accordance with the provisions of Section 100(A)(4) of the Local Government Act 1972 for agenda item 8 and the reporting of that part of the meeting shall be prevented under section 100A(5A) of the Act, because of the likely disclosure of exempt information as defined in paragraphs 1, 2 and 3 of Part 1 of Schedule 12A of the Act, as amended.

# 8 APPLICATION FOR HACKNEY CARRIAGE/PRIVATE HIRE DRIVER'S LICENCE - MR WRW

Mr WRW, who was accompanied by his wife, confirmed that he understood the procedure to be followed for this hearing.

The Senior Public Protection Officer presented the report. He then circulated a DBS statement in respect of the applicant and a statement submitted by him. The Sub-Committee adjourned to allow Members time to study these documents.

When the hearing resumed, Mr WRW stated his case and was questioned by Members. He did not wish to make a closing statement.

Following a further adjournment, the Sub-Committee **RESOLVED** that Mr WRW was a fit and proper person to hold a combined Hackney Carriage/Private Hire Driver's Licence. Authority was delegated to the Public Protection Officer to grant the licence, subject to satisfactory completion of the required tests.

#### Reasons

Members have had to determine an application for a Combined Hackney Carriage/Private Hire Driver's Licence. In doing so they took account of the Local Government (Miscellaneous Provisions) Act 1976, Human Rights Act 1998, case law and the Council's Policy.

Members had to decide whether or not the applicant was a fit and proper person to hold a licence considering all relevant circumstances.

Members took account of the applicant's written statement the oral representations made by him and his partner and balanced these against the information disclosed by Disclosure and Barring Service checks.

The applicant indicated that his previous convictions followed the death of his mother during a period when he went off the rails and did not have the support of his father and the most recent offences, albeit over 30 years ago, were a case of being "in the wrong place at the wrong time". He has had a stable home life and been conviction free ever since.

Members noted that Mr W R W's convictions were historic and that he had remained conviction free for the period anticipated in the Council's Policy. Members found Mr W R W is a fit and proper person to hold a Combined Hackney Carriage/Private Hire Driver's Licence.

Authority delegated to the Public Protection Officer to grant the licence subject to satisfactory completion of the required tests.

#### 10 STREET TRADING PROCEDURE

The Chair drew attention to the procedure to be followed for the next item of business.

#### 11 APPLICATION FOR STREET TRADING - PITCH 6C UNION STREET, BATH

Applicant: Mr Levente Hadnagy and Mr Daniel Balica

<u>Interested Parties:</u> Louise Prynne (Chief Executive, Bath Business Improvement District) (present), Gemma Haines, Yvonne O'Neil, Daniel Carter and Peter Adlington (not present).

The parties confirmed that they understood the procedure to be followed for the hearing.

The Senior Public Protection Officer presented the report. He explained that the application was for a change of use of an existing street pitch from selling non-alcoholic hot drinks to Hot Food (Burgers).

Mr Balica stated the case for the applicant. He explained that the pitch was operated by HAVE!, a small family business. The business wanted to offer burgers at the pitch, using locally-sourced meat, cheese and bread buns. He summarised the letter of support from the applicant (agenda pages 56-60). He drew attention to the great similarity between the five representations. The first two were actually identical. The third contained a verbatim extract from the Council's terms and conditions. He summarised the applicant's response to the objections as set out in the letter of support, and emphasised that the applicant would have to abide by the terms and conditions of the Street Trading Consent.

Mrs Prynne stated the case for the Interested Parties. She said that she had not attended one of these hearings before, but she did not apologise if some the letters of objection were the same. She and her colleague, John Raby, had consulted a number of businesses, who had all said that they were concerned about this application. One of the reasons for objecting to the application is that there is an ongoing review by B&NES Economic Development Team of market provision in Bath, and it is important that the right strategy should be found. The business rate revaluation poses a significant challenge for local businesses. There are a number of businesses in very close proximity who are facing business rate increases; they are concerned about the potential impact of this application on their trade. There was significant footfall in the area near the pitch; the street could be very congested and it could be difficult to get past. Cooking food in the street would give to rise to odours.

A Member commented that five representations were five representations, even if they were identical.

In reply to questions from Members Mrs Prynne said that BBID was currently involved in discussion about how street traders could complement shops. Some shops were paying £2,000 per week in rates compared with the much lower charges paid by street traders. She was not opposed to street trading, but it needed to be managed strategically.

A Member commented on the problem with seagulls in Bath. The Applicant responded that the problems of seagulls and street cleaning remained the same irrespective of whether people bought food from shops or a street stall.

Following an adjournment, the Sub-Committee **RESOLVED** to grant the application.

#### Reasons

Members have had to determine an application for a Street Trading Consent at existing pitch 6C Union Street. This application involves a proposed change of use from selling non-alcoholic hot drinks to selling hot food (burgers). In determining the application members have taken into account the Local Government (Miscellaneous Provisions) Act 1982, the Council's Policy on Street Trading and the Human Rights Act 1998.

#### The Applicant

Mr Balica on behalf of his business Have! indicated that the business is a small, independent and enthusiastic family business already trading selling crepes and hot drinks at another pitch in BANES. He acknowledged that their operation of that pitch is relatively new but the company a background of 15 years working in the food and service industry. The burgers that they propose to sell will be made using quality produce from independent local retailers. The applicant cited what they believe to be the burgeoning street food market, alongside the feedback they have received as reasons for applying for the pitch.

#### **The Interested Parties**

The Chief Executive of Bath BID Mrs Prynne, expressed concerns that the proposed use would not satisfy BANES' vision for street trading as set out in the Policy and said that the proposal would not being in keeping with the quality of shops; would not promote healthy eating; would cause shops close to the pitch to suffer from the smell coming from the stall and suggested that there are many retailers in Union Street already serving food and beverages. Mrs Prynne expressed concerns relating to the congestion that could be caused by the street trading pitch in that location. Whilst Mrs Prynne was not against street trading in principle, she expressed the view that it should be managed in a strategic manner.

4 retailers made written representations citing smells; waste management issues; the proposed use not being in keeping with the quality of shops in the street and competition with existing food and beverage retailers; as reasons upon which they invited the Committee to refuse the application.

#### **Members**

Members were careful to only take into account matters of relevance and to disregard matters which were irrelevant. Members were mindful of the fact that they had to determine the application in accordance with the current legislative and policy framework and noted that the principle of a pitch in this location had already been established.

Members noted that there had been no objection to the application from the Highways Team or Environmental Services.

In reaching a decision Members took account of all the relevant oral and written representations and balanced the competing interests of the applicant and the interested parties.

Whilst they carefully noted the objections raised by the BID and 4 retailers they found, in the exercise of their discretion, that the proposed use of the pitch for the

sale of burgers using quality produce sourced from local, independent retailers would provide vibrancy and interest to the local environment and that they had the scope within the Policy to consider the goods to be sold on a pitch by pitch basis. Members noted that the standard conditions would ensure that a bin or similar was made available for the disposal of waste and the applicant would be obliged to keep the immediate adjacent area clean and tidy during the permitted hours, amongst other conditions. Accordingly, Members saw fit to grant the street trading consent as proposed.

Authority delegated to the Public Protection Officer to grant the consent subject to the Standard Conditions and with the additional specific conditions, such as are reasonable and necessary.

- allowing individuals and companies to understand decisions made by the Council affecting their lives and assist individuals to challenge those decisions.

However there is a real risk that the first Principle of the DPA will be breached by this disclosure, and that the individual/s concerned could bring a successful action against the Council if the disclosure occurred. Therefore it is recommended that exemptions 1 and 2 in Schedule 12A stand. 

The parties will be allowed an equal maximum period of time not normally exceeding <u>twenty</u> <u>minutes</u>. Where more than one party make representations the time should be split equally between them. Where several parties make similar representations one representative should be appointed avoiding duplication and making the best use of the available time





# LICENSING SUB COMMITTEE HEARING PROCEDURE SUMMARY REVIEW OF PREMISES LICENCE / CLUB PREMISES CERTIFICATE

The Chair will allow the parties an equal maximum period of time in which to make representations not normally exceeding <u>twenty minutes</u>. Where more than one party makes relevant representations time will be split between the parties and where several parties make similar representations it is suggested one representative is appointed to avoid duplication.

The term "party" or "parties" will mean anyone to whom notice of this meeting has been given.

- Responsible Authorities making representation will address the Sub Committee and may be asked questions by the Sub Committee, Applicant, Licence Holder, other parties.
- The Licence Holder (or their representative) will address the Sub Committee and may be asked questions by the Sub Committee, Applicant and other parties.
- 7 The other parties will be invited to summarise their representations.
  - Responsible Authorities will be invited to summarise their representations
  - The Licence Holder will be invited to summarise their representations
  - The Applicant will be invited to summarise the application.
- The Chair will invite the Committee to move into private session to enable the Members to deliberate in private. The Committee will reconvene publicly if clarification of evidence is required and/or legal advice is required. The Committee may retire to a private room, or alternatively require vacation of the meeting room by all other persons.

Whilst in deliberation the Committee will be accompanied by Legal and Democratic Service Officers for the purpose of assisting them in drafting their reasoning for the decision.

The Committee will reconvene the meeting and the Chair will announce the Committee's decision with reasons.

#### **PLEASE NOTE:**

- Where the Sub-Committee considers it necessary to do so, it may vary this procedure.
- In circumstances where a party fails to attend the will be determined in absence.
- The hearing will take the form of a discussion and parties will be able to ask questions as set out above. However, formal cross examination will be discouraged.
- The Authority will disregard any information or representation given by a party which is not relevant to the Application and the Licensing Act 2003.

#### 1 THE ISSUE

1.1 An application has been received from Mr Kenneth Jones for the Review of a Premises Licence under Section 51 of the Licensing Act 2003, in respect of Rising Sun, Church Street, Pensford, Bristol BS39 4AQ

#### 2 RECOMMENDATION

2.1 That the Licensing Sub-Committee determines the application for the review of the premises licence.

#### 3 RESOURCE IMPLICATIONS

The application for the review of the premises licence is free of charge under the Licensing Act 2003. The cost of processing this application is £1,500 and will be managed within the approved Licensing budget which contains an element that covers the cost of non-chargeable licensing reviews.

## 4 STATUTORY CONSIDERATIONS AND BASIS FOR PROPOSAL

- 4.1 An Equality Impact Assessment (Eq1A) has been completed. No adverse or other significant issues were found.
- 4.2 Consideration must be given to the Human Rights Act 1998 and the "convention rights".

- 4.3 The Licensing Sub Committee have been delegated authority to determine the application on behalf of the Licensing Authority in accordance with the Licensing Act 2003.
- 4.4 When reaching a decision, the Licensing Authority must carry out its functions with a view to promoting the four licensing objectives.

#### 5 THE REPORT

- 5.1 An application has been received for the Review of the Premises Licence (Annex A).
- 5.2 The application relates to the following licensing objectives:
  - the Prevention of Crime & Disorder; and
  - Public Safety.
- 5.3 The alleged grounds for the Review are:

The licensing objectives relating to Public Safety and the Prevention of Crime and Disorder are being undermined due to customers within the premises swearing, shouting and jeering on a near daily basis. Loud music regularly emanating from the garden and inside the premises, beyond midnight, which can be heard in residential premises with the windows and doors closed.

- The Licensing Authority may, having had regard to the application and any relevant representations, take any of the following steps (if any) as it considers necessary for the promotion of the licensing objectives:
  - a) Modify the conditions of the Licence;
  - b) Exclude a licensable activity from the scope of the Licence;
  - c) Remove the Designated Premises Supervisor:
  - d) Suspend the Licence for a period not exceeding three months;
  - e) Revoke the Licence

Where the Licensing Authority takes a step mentioned in 5.4 (a) or (b), it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.

Any determination made by the Licensing Authority does not have effect until the end of the period given for appealing against the decision, or, if the decision is appealed against, until the appeal is disposed of.

- 5.5 The Licensing Authority will also have regard to the Council's Licensing Policy, the Statutory Guidance issued under Section 182 of the Licensing Act 2003, the Licensing Act itself, and in particular to:
  - a) Sections 4, 9, 10, 13, 51, 52, 53, 182, and 183 of the Act.

- b) Chapters 1- 3 and 8 12 of the Statutory Guidance (as revised April 2017)
- c) Paragraphs 3, 4, 5, 6, 8, 20, and 33 43 inclusive, of the Policy.
- An appeal may be made to the Magistrates Court within 21 days of the notification of the decision by the Council to the applicant for the review, the holder of the premises licence or any other person who made relevant representations in relation to the application.

On appeal the court may either dismiss the appeal, substitute the decision appealed against, for any other decision which could have been made by the Licensing Authority, or remit the case to the Licensing Authority to dispose of it in accordance with the direction of the court. The court may make such Order for costs as it thinks fit.

- 5.9 A plan of the premises and a site plan are attached at Annex C.
- 5.10 In accordance with the requirements of the Act copies of the application have been served upon the Licence Holder, Police, Environmental Health, Development Control, Trading Standards, Home Office, the Child Protection Agency and the Public Health Authority. There have been no representations from any of the Resposible Authorities
- 5.11 Notices were displayed on the council website, at the premises and at the public area of the One Stop Shop, Lewis House, Manvers Street, Bath BA1 1JG, for a period of 28 days, commencing the day after the application was served on the Licensing Authority.
- 5.12 Representations in support of the review have been received alleging that the manner in which the premises operates undermines the Prevention of Public Nuisance licensing objective (Annex D).
- 5.13 Written representations of support for the premises have been submitted by 102 other persons professing that the premises is family friendly, professionally run and a community asset (Annex E).
- 5.14 This report has not been sent to the Trades Union because they would have no involvement in this application.

#### 6 RATIONALE

6.1 As a review application has been received the Licensing Sub-Committee must determine the application in accordance with the Licensing Act 2003.

#### 7 OTHER OPTIONS CONSIDERED

7.1 None.

#### **8 CONSULTATION**

8.1 In accordance with the Licensing Act 2003 (Premises Licence and Club Premises Certificate) Regulations 2005 a copy of the application has been given to the premises licence holder and to all the relevant Responsible Authorities. The application has also been advertised on the council website, at the premises, and in the public area of the Council's One Stop Shop, Lewis House, Manvers Street, Bath.

#### 9 RISK MANAGEMENT

9.1 A risk assessment related to the issue and recommendations has been undertaken, in compliance with the Council's decision making risk management guidance.

#### 10 ADVICE SOUGHT

10.1 The Council's Monitoring Officer (Head of Legal & Democratic Services and Council Solicitor), section 151 Officer (Chief financial officer) and the Group Manager Public Protection & Health Improvement have had the opportunity to input to this report and have cleared it for publication.





Hello I would like too address a few points in relation to complaints made about The Rising Sun Pensford Bristol.

From a personal perspective I have attended the free music events which are managed in a very professional manner. The events are few and far between i.e. 3/4 a year if that. When an event is held in the garden it is mostly finished at 10pm. The garden is situated at the rear of the pub which is a fair way from the complainant home. After 10pm the dj will move inside to continue and will finish around 12.

These events are always family friendly with with ages ranging from young children to OAP and great fun for the community.

On a bank holiday fri and sat they have a licence til 2am but restrict it to 12 to be respectful.

I have witnessed people leave the area very respectfully.

I have also attended the Sunday Sessions which involve a small band inside the pub. On these occasions I have witnessed the landlords close the windows and doors to respect the neighbours. The Sunday sessions start around 5pm and finish around 7pm it is always the last Sunday of the month.

The volume of the music is never too loud that you cannot hold a conversation. So it's completely comfortable.

I can confirm that very rarely, there is unsociable behaviour loud shouting and swearing on a near daily basis. In fact the people who live in the village are polite kind respectful people. So that doesn't make sense.

I can confirm that the land lord and lady have always operated within their licence. When neighbours have complained in the past they have changed their working practices i.e. Finishing music outside by 10pm. Music inside finishes at 12 even though their licence is 1 so allows for winding down.

I have also witnessed them picking up litter from outside their premises that clearly wasn't sold by them i.e. Ice cream wrappers to help keep the street tidy. The pub looks beautiful outside and is a pleasure to see.

We are writing regarding the complaint made that has resulted in a review of the license for The Rising Sun in Pensford.

The complaint makes reference to loud music; firstly there are perhaps up to six times a year when the pub has live music and these occasions are very much focused on the community. The music never goes on late, usually finishes by 11 o'clock (except perhaps New Year's Eve). Live music half a dozen times per year is not excessive and if anything we would welcome a few more occasions with music.

The complaint also makes reference to noise from those leaving the pub, including swearing. I imagine this has happened on a rare occasion, however, the pub is very much a family pub and Mike and Jo are very considerate of the local community and those leaving the pub are generally very considerate of the neighbours. The pub doesn't encourage excessive drinking, they don't have offers that some pubs have which encourages irresponsible drinking. It's a traditional local pub that focuses on good quality food and a good pint. Again I fail to understand what the complainant expected when they moved into a property near a pub. Mike and Jo have very young children and their family home is above the pub, they wouldn't tolerate excessive noise as it would impact on their own family.

There is reference to deliveries, funny enough pubs do need deliveries. It is a small street, however, it is possible to pass when there are deliveries. We have a Land Rover Discovery, not a small car and I have been able to pass with ease and without the need to mount the pavement.

We don't live on the street so I cannot comment on the timing of refuse collections, including the bottle recycling. However, if this is a genuine concern I would suggest the time of collection is reviewed and not the pub license.

I am a regular customer of the pub and have been for over 30 years and know the place and current landlord and owners and customers very well.

Since Jo Dury and Mike Radford bought the Rising Sun they've absolutely transformed it into a thriving family friendly establishment that attracts customer from outside of the village into what is now a thriving and very valuable community hub. I am extremely flabbergasted at the points raised in the review as I have certainly never witnessed any of them. In particular

1. Very loud music being played until midnight. On the occasional Sunday I have seen and heard bands playing within the afternoon and these sessions finish early in the evening, certainly well before closing time. The noise of the music is not particularly load. It's quiet enough to hear yourself think inside what is quite a small pub with very thick walls. I understand on occasion there is music in the garden however when I have been here this has typically been on afternoons and evenings on for example bank holiday weekends. These events are well attended by the community and take place at the back of the pub next to the river which in itself is quite noisy. I don't understand how this music would carry around the opposite side of the pub and into the street

2 loud voices shouting and jeering. The pub is actually a fairly quiet and peaceful place. At times it's bustling, for example after work on Friday and Sunday lunchtime. I often take our children to the pub and have never experienced loud/shouty behaviour and my children have never been exposed to any inappropriate behaviour from pub customers. A good example of positive noise outside the pub is the village Christmas Mummers Day festival when a group of Morris Dancers and village folk perform an annual Yuletide ritual outside the pub. This event is brief and finishes early evening with good supporting attendance from the village (this is not organised by the pub)

I cannot make much experience based comment on the final 3 points about delivery as I've not been there when such events have taken place. It is true to say that it's a one way street with little parking on it and with a garage, cafe, barbers and post office and many houses that would all need such delivery services therefore if this is indeed an issue then all residents would be contributing to it.

My final comment is that it should be pointed out that Miss Jury and Mr Radford have invested a significant amount of time effort and money into the business and surrounding area not just for the benefit of themselves But also for the benefit of the local community. The

pub, the garden and the surrounding small holding are testament to this as the access is kept clear for all to enjoy the riverside walk and a great many local people regularly tread this path and picnic with permission on the licensees land .Furthermore they support local business and small holdings in the area For example buying fruit and veg stock from the local post office and buying beer from the local brewery.

I write this letter in support and exasperation that it has even come to this stage. Having had 22 years experience in the licensed trade, I can quite honestly say that I have never come across two more professional and conscientious publicans in my life.

I moved to Pensford in October 2016, and took over the George & Dragon. I soon met Mike and Joe from the Rising Sun, who were only too happy to offer any support that they could, especially as we share a lot of the customers, with the clientele more than happy to frequent both establishments.

I have visited their premises on numerous occasions, both on week nights, some weekends, and on times their music nights, if any when they have them.

I have on each occasion NEVER found any cause or issue with any noise, or customer issues that in any way could cause any offence to the neighbourhood.

Yes of course of times you may hear the infrequent use of bad language, but this happens in every licensed premises, and in no way should be regarded as the norm, in fact it is actively discouraged by Mike and Joe.

On our first visit to the premises, when proceeding to go for a cigarette outside, we were politely requested to use the smoking area at the rear of the premises, as they felt was inconsiderate to their neighbours to have people smoking and making noise at the front of their premises.

It is famous for its location, tranquility and ambience and is an absolute treasure to those that know and use it.

Jo and Mike are experienced hosts from running other licensed premises in Bristol, here in Pensford they provide a high-end experience for anyone who wishes to eat, drink, listen to music or simply meet up with friends to socialise - they do not, never have, and never will tolerate drunken, loud or abusive behaviour from anyone and they make it clear that any person behaving in such a way will be escorted from the premises immediately. It simply isn't a place where shouting, jeering and swearing occurs with any regularity and to suggest otherwise is an injustice to the fine service that Jo and Mike provide, that said it is a public house not a library and a sizeable chunk of common sense also has to apply.

Occasionally, a handful of times a year, there is live music to enjoy which only adds to the vibrance of the buildings and garden, it attracts many locals and those from further afield which, in turn, brings more money into the village and directly into other local businesses, mine included, so any change in licensing will also affect the few, thriving businesses based in Pensford. I attend as many of the live music events as I can and have never known them to go beyond midnight, but would fully support them if they did as they provide so much fun and entertainment for local people on an occasional basis which greatly outweighs the short-term inconvenience that the great majority of villagers accept unconditionally.

We are aware that the Rising Sun publican's licence is under review owing to a challenge by one of her neighbours.

We find it absolutely astonishing that someone who bought a house directly opposite a public house would then try to revoke the licence of the pub, which has been trading since Shakespearian times, knowing full well that this action could deprive the current licensees of their livelihood and the locals of a place to meet friends and family? Even Hitler and the great flood of 1968 couldn't do that. It is like us seeking the river and the A37 to be diverted away from us.

Village pubs and shops are the heart of the community and they shouldn't be put in an industrial estate just to keep the odd person happy.

The current licensees of the Rising Sun, Jo and Mike, have developed a good trade and employ a lot of local people. We have lived in the village for almost 10 years and until a couple of years ago we lived two doors down from the complainant in this case. Therefore we have first hand knowledge of the effect the pub has had on Church street and the surrounding area. I can honestly say that we were never aware of excessive music regularly going on late or abusive and loud patrons. I live in ... with my Husband my 82 year old Mother, (who has recently come to stay with us following the death of my Father) and my 22 year old Son. My house is in an elevated position and my garden overlooks the pubs garden. We have lived here for almost 12 years and together we have discussed the complaints raised.

Jo Drury and Mike Radford have made a huge and positive difference on our village. They have in a very short space of time changed a very tired, limited drinking establishment into a vibrant, family orientated, pleasant hub for our village. The Rising Sun is now a valuable asset and offers an excellent menu, a warm welcoming atmosphere, family entertainment and pleasant surroundings.

As a neighbour we have an excellent relationship with Jo and Mike. They have always been courteous of our feelings and have always let us know if any events would be held in advance. On the few occasions when there has been music it has been kept to a reasonable hour and frankly if we haven't been able to go to the pub at such times we have enjoyed opening our windows and listening to it, such is the level that we cannot hear it clearly with the windows closed. My 82 year old mother goes to bed very early and has never mentioned being disturbed by entertainment or otherwise.

As far as general noise and foul language at closing time goes, we sleep with our bedroom windows open, which overlook Church Road. The Rising Sun is a public house selling alcohol so of course we expect to hear raised voices occasionally, however I cannot recall this continuing for any length of time, (high spirits usually as people make their way home), and it is never sufficient to cause us any concern. Jo and Mike have done everything they can to discourage inconvenience to neighbours, including asking patrons to use the smoking area they have provided at the rear of the pub to avoid hanging around outside and they have put a notice up to this effect.

In our opinion we do not believe that we could have a better village pub than we have now and it would be very sad to lose our licensees over the complaints of a disgruntled minority.

When we moved to Pensford, about a year prior to Mike and Jo taking ownership of the pub, the Sun was an uninviting, run-down pub; now, it is an asset to the community. Myself and my husband live just around the corner from the Rising Sun public house in Pensford, (no more than approx 60 metres door to door).

Since purchasing the Rising Sun the landlord and landlady have immersed themselves in village life, they have worked hard to provide a public house that has become a widely appreciated village asset and is seen by many as a community hub, a welcoming meeting place for all villagers, young or old. They themselves have a young family, and encourage other families in the village with young children to also frequent the pub.

On the very rare occasion when evening weekend events are held and music can be heard we have not known this to carry on any later than midnight, in fact, out of consideration for all local residents there has been a handful of music events held on a Sunday during the afternoon (for a couple hours at most) so that adults and children alike can all enjoy.

On a personal note we would welcome more planned events, further enabling the village to come together as a community.

As previously stated the pub provides a hub for the village community, when walking past on a warm day when the windows are slightly open it's nice to hear the chatter of daily village life, never have I heard any offensive remarks or, in our opinion, has there ever been an unacceptable level of noise.

The Rising Sun has been a focal point for the village for many many years, it seems absurd that anyone purchasing a property in such close proximity would do so without being prepared to accept the normal comings and goings of a business that not only enhances the community feeling, but is also a valuable addition to our local economy.

As residents that live in such close proximity to the pub we have no issues whatsoever with the day to day running of it, and feel that the landlord and landlady have made every effort to be considerate neighbours.

#### Good afternoon Ian,

Below are my comments regarding the Premises Licence Review for The Rising Sun. I would like these noted for the committee. If I understand the information correctly, I can speak as myself as well as put forward Cllr Mays views at the hearing.

#### The Rising Sun, Pensford

I would like to give my utmost support for the current owners of The Rising Sun at Pensford and hope the committee see fit to maintain their Premises Licence without any changes.

The pub is run in a responsible professional manner, retains capable friendly staff and is well used by the wide local community.

The owners take their role as landlords beyond just pulling a pint and offering excellent food (with the emphasis on sustainable locally produced food, they have excellent reviews on Trip Advisor and Facebook) - they are involved and active in the community. It is very evident when you talk to them that The Rising Sun is not just a business, it is their home, it is the place where they have chosen to settle and raise their family. They have wonderful events that are inclusive for all - from tiny babies to the very elderly. These are not rowdy unruly events, these are well planned and organised events centred around families having a great time. As an example they hold an annual "Regatta" which among the cakes and hog roast has a Homemade model Boat Racing in the River Chew! In addition, they run a monthly supper evening with a set 4 course menu of outstanding flavoursome local food, the people who go to this are not all local to The Rising Sun, they come to the evening because both the pub and the food have such an excellent reputation in the wider area.

I live within walking distance of The Rising Sun, just beyond the boundary of Publow with Pensford Parish and I was astounded when I heard that this license was being reviewed. I have never heard a bad word said about the landlord or her family, I have only ever heard complementary comments regarding how they run the pub. I have lived in my current home for just under 6 years and at the time I moved in The Rising Sun was under different ownership - very different ownership! To describe it then as "grotty" is probably a fair summary! It was dark and grimy, rather unfriendly and had a regular live music night that was geared towards rock music. The current owners moved in during 2012 and very quickly turned the place around into a thriving local business (that clearly employs many more people that the previous landlord). This ought to be applauded especially in a time when so many pubs are finding it hard to make a living, not only have they turned the place around, but they have not done so at the expense of other pubs in the area, each has a unique offering.

Finally, with regard to the details that have led to this license review, many people have homes near churches, schools, golf courses, shops, farms, railway lines, or under a flight path, etc all these things can cause regular irritations, however they must be measured with regard to the services they bring to a community or to a wider area - this pub is no different to many others in small villages set in the centre with cottages all around them. Common sense must prevail - busy thriving pubs have customers!

I estimate that there are at least 20 dwellings within 150ft of The Rising Sun, I also estimate that you will have had supporting comments from the vast majority of residents in these properties, as well as many more from residents of the Parish indicating how much the community value this local facility. So I would urge the committee to recognise that this is a successful responsible family business employing local people - offering a service in the heart of a rural village that is valued not just by Pensford residents, but by many from a bit further afield - please maintain the Premises Licence for The Rising Sun without any changes.

I have booked, once again, for the gourmet dinner scheduled every last Thursday of the month at The Rising Sun.

It is a fabulous event supported by many local residents and those from surrounding villages. The talented chef produces fantastic dining food. I am a discerning foodie and feel reasonably equipped to make this judgement. I applaud the use of local suppliers and that local staff are proud of their event and delighted to entertain their guests.

I am lucky to be going as there is always a waiting list of other hopeful diners.

It is quite remarkable that since 2012 when Mike and Jo took over the filthy dirty run down Rising Sun....a place I would not dare to tread....they have turned it into an authentic village pub serving a great range of beers etc and great value reliably excellent food. It doesn't have a clever contemporary interior, but is cosy and clean with a traditional feel.

The Rising Sun is a valuable community asset. Many villages would welcome the opportunity of such a business in their village.

I live within walking distance at Stanton Wick, although it is an easy walk for me to The RS. When I have visited or been passing I have never heard any noisy behaviour etc, although clearly the outside space is enjoyed (on the rare occasion the weather permits), and coming and going people talk and laugh. The RS is physically almost attached to its neighbours...as is the way with small village pubs...so living within the close vicinity I am sure there is some evidence of the existence of an active business. In much the same way as the A37 is audible because it is a major road, and as the School can be heard because it is full of children, and is the sky because Pensford is close to the flight paths of Bristol Airport.

Mike and Jo have integrated into the community and are valued supporters of the Pensford, Publow and the Stantons Community Trust (<a href="www.ppsct.org.uk">www.ppsct.org.uk</a>) which helps to raise £12K for the communities every year. They have become well known and are very popular.

I was disappointed to see that an application for a review of the above mentioned premises has been received by yourselves.

The Rising Sun has been part of the village scene for centuries. Pensford was an important staging post for stage coaches which stopped at the Rising Sun during the 17<sup>th</sup> and 18<sup>th</sup> centuries (Wikipedia)

In my experience it is a family friendly pub and restaurant with a Trip Advisor Certificate of Excellence. The Trip Advisor reviews speak for themselves. It can get busy but it is not a pub with loud music and noisy drinkers using abusive language. If it was I wouldn't go in there.

I have eaten in the Rising Sun. They serve food sourced from local suppliers. All game is sourced from the Chew Valley and some of the meat is produced from their own small holding. I was on the steering group for the recently adopted Publow with Pensford Parish Council Neighbourhood Development Plan 2016-2035 and so was the licensee. The licensee seems to be conforming to the wishes of residents within the Plan. 90% of residents replying to a Plan questionnaire stated that 'We should seek to …Support the supply of local products to local shops . Also, our Plan aims to maintain and extend local employment opportunities (p13) i. e one of my neighbour's teenage children works in the kitchen.

I am Chair of Pensford Tennis Club, a community club open to all members of the community. #### Hello

I am aware that there is an objection raised against the re-issue of a premises licence for The Rising Sun at Pensford. We have lived in the local area for nearly 40 years and have seen many landlords come and go at the local pubs. The Rising Sun occupies a rather special place in the village due to its age and consistency of tenancy. As long as I have known it, live music has been played there and mostly in aid of raising funds for local causes. The school benefits, the Memorial Hall benefits, the local sports amenities benefit and the villagers benefit.

I have never known the music events at The Rising Sun carry on later than the advertised time. I am sure that on the very odd occasion late revellers may not be as considerate as they should be when leaving the premises, but I would challenge anyone to show me a venue where people leaving are silent. People leaving a domestic home they have visited can be extremely noisy - and lets not forget the annoying 'beep beep' on the car horn they feel compelled to do as they drive away. However, private homes do not have licenses with specified times of music shut off which means that neighbours can be taken completely unawares of late night noise. A public house offering live music, on the other hand openly advertises the fact well in advance and neighbours can take avoidance action if wished, or come and join the fun - which I believe most of the near residents of The Rising Sun do. I question why anyone would buy a property near a pub if they are intolerant of typical pub activity. If one was on permanent night shift work, and slept during the day, it would be ridiculous to buy a house next to a school, wouldn't it?

If The Rising Sun ceased to be, Pensford would be a poorer place. We are proud of the hub of the village - the Post Office, the Pub, the Memorial hall and playing fields, etc. We are very lucky to have maintained a thriving village in this day of shopping malls and corporate, soulless public houses.

#### Dear Sir

I am writing to you regarding the application to alter the licence for the rising sun. Certain aspects of this review are beginning to cause me concern. To set the record straight regarding the parties to this application both Chris and ken and Mike and Joe are an active and continuing benefit to this community.

Ken sweeps church street for no charge, plants bulbs to beautify otherwise waste areas of public land and attends all our parish council meetings where we are very pleased to see him. He is a punchy and forthright individual, tackling dog fouling and fly tipping on the road when others shy away for fear of courting hostility. People who engage in this kind of work can be sneered at as busy bodies by less active neighbours but they are vital to a community whilst that kind of sniping is not.

Sadly for those in search of a villain the same can be said for Mike and Joe. They have turned the rising sun around form a moribund redevelopment in waiting into one of the best pubs in the valley. All are welcome, the food is excellent and they are improving the regard in which the village is held more generally. It should be noted that many of these changes have been complained about by near neighbours from the outset but the two of them have shown the grit required to force themselves on the establishment, to the benefit of all

This makes it all the more unfortunate that the two couples are at loggerheads.

#### The Current Situation.

Lam watching the course of this application with growing concern. The petitions and comments they contain, the letters and public notices are generating significantly more heat than light. It stands to reason that a well loved and patronised inn will attract a great deal more support than an elderly couple living nearby complaining of a noise nuisance. The commentary on line is particularly embarrassing and can be viewed as nothing short of bullying.

People living at a decent remove from the pub can add little to the question of whether it constitutes a noise nuisance to those in a house immediately opposite and even as the owner of the land adjoining the pub garden i would freely admit that i haven't the slightest idea what it sounds like in another persons living room.

The strength of feeling on this issue and the various altercations it has spawned are based on the long running nature of the disagreement. It has been a rolling irritant to both parties for years, the fact it has only reached you now should dispel any suspicions that ken is a curmudgeon who will complain about anything. You might say he is intransigent but only by applying that term equally to both sides.

#### The Root Cause.

The root cause of the application is the tendency of the suns regulars to open the windows and door facing out onto Church Street. This allows noise from within to spill out into the street and then into the living room of nelson house opposite. Its not deafening but it has a

Chinese water torture effect over the course of months, especially if the pub is hosting a band or a sports team.

The obvious solution is to shut the windows but then the pub can become quite hot and in a perfect world its nicer with a breeze.

Now a general annoying background hum may not seem like the end of the world for a resident but then neither is closing a window going to fatally undermine the commercial viability of the Sun.

I think it would be a mistake to dismiss the concerns of either party in your deliberations. Chris and Kens happiness IS being eroded by the noise from the pub across the road regardless of what others might think and say and that should not be allowed to continue. Mike and Joe run a great pub and should not be loaded down with unnecessary strictures. I can't help but feel that once we get past the confrontational aspect of this dilemma that the solution is obvious.

#### A tale of two Windows.

As you will see from the attached plans the sun and nelson house do not fully overlap. The window into the road opposite the house goes into the bar area of the pub given over to drinking and chatting where the noise levels are relatively high. The far windows open into the restaurant area of the pub where people eat and the noise levels are significantly lower. Both sections are part of the same open plan space so a window open in one is open in both, but only one of them reliably generates high levels of noise opposite a house.

The one window would provide an acceptable level of freshness and cooling in the bar. Whilst this would produce a degree of noise it could be argued that this is part of living next door to a pub. On the other hand the minimal discomfort caused by having only one of your windows open onto the street is the price of buying a pub surrounded by houses.

#### Curfew

There could be a mutually agreed shut off time in the evening after which the windows would be shut once the clientele have warmed up and the weather has cooled down. It should go without saying that both windows and the door should be shut without exception during live music. Mike and Joe are very good at shutting the music off at eleven in my experience and it would be a shame to lose the few nights of the year when they entertain the village outside to a later time such as their annual regatta.

#### In Closing.

This issue will persist and worsen if left as it is. I would urge you to ignore the hedge of thorns growing up around this and cut it all off at the stem. There must be mutually acceptable times and combinations of window opening into the bar so Chris and Ken can recover their domestic equilibrium whilst allowing Mike and Joe to carry on running their business with the minimum interference necessary to ensure a lasting peace.



# LICENSING SUB COMMITTEE PROCEDURE APPLICATIONS FOR MISCELLANEOUS LICENSES, PERMITS, CONSENTS

- 1. The Chair will introduce Members of the Committee, introduce the Officers present, explain the procedure to be followed and ensure those present have received and understood that procedure.
- 2. The Licensing Officer will outline the nature of the matter to be considered by the Committee.
- 3. The Applicant and or representative present their case and may be questioned by the Committee and other parties.
- 4. The Applicant may call witnesses in support who may be questioned by the Committee and other parties.
- 5. The objecting parties address the Committee and can be questioned by the Committee and other parties on matters relevant to the application. Any person presenting evidence for an objecting party may also be questioned by Members and other parties.
- 6. The Chair will ask the Licensing Officers present whether they wish to comment. If an Officer makes comment they may be questioned.
- 7. The parties are invited to make closing statements.
- 8. The Chair will invite the Committee to move into private session to enable the Members to deliberate in private. The Committee will reconvene publicly if clarification of evidence is required and/or legal advice is required. The Committee may retire to a private room, or alternatively require vacation of the meeting room by all other persons.
- 9. Whilst in deliberation the Committee will be accompanied by Legal and Democratic Service Officers for the purpose of assisting them in drafting their reasoning for the decision.
- 10. The Committee will reconvene the meeting and the Chair will announce the Committee's decision with reasons and advise that the decision will be released in writing within the statutory time limits.

#### **PLEASE NOTE:**

- Where the Committee considers it necessary the procedure may be varied.
- In circumstances where a party fails to attend the Committee will consider whether to proceed in absence or defer to the next meeting. Should a matter be deferred the deferral notice will state that the matter may proceed in a party's absence on the next occasion. In deciding whether to proceed all notices, communications and representations will be considered.
- Only in <u>exceptional circumstances</u> will the Committee take account of additional late documentary or other information and will be at the discretion of the Chair and on notice to all the other parties. No new representations will be allowed at the hearing.
- The Committee will disregard all information or representations considered irrelevant.
- The hearing will take the form of a discussion. The Committee will allow parties to the proceedings to ask questions. Formal cross examination will be discouraged and, should they be necessary, supplementary questions allowed for clarification purposes only.
- Parties will have an equal amount of time to present their cases. Whilst time limits
  are at the Chair's discretion, in the interests of cost and efficiency, presentations
  will not normally exceed <u>twenty minutes</u> to include summarising the case. Time
  limits will not include the time taken for questions.

#### N.B.

- 1. Where there is more than one party making relevant representations the time allocated will be split between those parties.
- 2. Where several parties are making the same or similar representations it is suggested that one representative is appointed to avoid duplication and to make the most efficient use of the allocated time.
- 3. Where an objection is made by an association or local residents group, a duly authorised person as notified to the Licensing authority may speak on behalf of that association or local residents group.
- The Chair may request that persons behaving in a disruptive manner should leave the hearing and their return refused, or allowed subject to conditions. An excluded person is however, entitled to submit the information they would have been entitled to present had they not been excluded.
- Bath & North East Somerset Council is committed to taking decisions in an honest, accountable and transparent fashion. On occasion however, it may be necessary to exclude members of the press and public pursuant to the Local Government Act 1972 Schedule 12 (a). In those circumstances reasons for such decisions will be given.
- If a person has special needs regarding access, hearing or vision, this should be brought to the Licensing Authority's attention prior to the hearing so that reasonable adjustments may be made.

#### 1 THE ISSUE

1.1 An application has been received for permission to provide facilities on the highway in respect of Caffe Nero, 11 Old Bond street, Bath BA1 1BP

#### 2 RECOMMENDATION

2.1 That the Licensing Sub Committee determines the application.

#### 3 RESCOURCE IMPLICATIONS

3.1 The costs of processing licences are covered by the fees charged. The fee for this application is £251.

#### 4 STATUTORY CONSIDERATIONS

4.1 Sections 115 A-K Highways Act 1980 give the Council discretion to grant permission to provide, maintain and operate facilities for recreation and/or refreshments on the highways subject to any reasonable conditions the Council thinks fit.

- 4.2 When making a decision consideration needs to be given to the Human Rights Act 1998.
- 4.3 An Equalities Impact Assessment (EqIA) has been completed. No adverse or other significant issues were found.

#### 5 THE REPORT

- An application has been received for permission to provide facilities on the highway in respect of Caffe Nero, 11 Old Bond Street, Bath Ba1 1BP (Annex A).
- 5.2 The application is for permission to place 3 tables on the highway outside the premises, along with appropriate seating (site plan attached at Annex B).
- 5.3 The Council's standard conditions for permission to place tables and chairs on the highway are attached at (Annex C).
- 5.4 The size of the area applied for is 3m x 1m 20cm. The times applied for are:
  - Every Day from 07:00 to 21:00 hours
- 5.5 A notice was placed on the highway on 7<sup>th</sup> June 2017 (Annex D). The application was also placed on the Council's website.



# LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1982 PART VIIA HIGHWAYS ACT 1980 PERMISSION TO PLACE TABLES AND CHAIRS ON THE HIGHWAY

#### CONDITIONS

- The holder(s) of this Permission shall not exercise privileges granted by this Permission otherwise than strictly in accordance with this Permission.
- The holder(s) shall produce this Permission on demand when so required by a Police Officer or a duly authorised Officer of the Bath & North East Somerset Council.
- The holder(s) shall return this Permission to the Office of the Head of Environmental and Consumer Services immediately on revocation of this Permission.
- The holder(s) shall not cause any unnecessary obstruction of the highways or danger to persons using it and shall not permit persons to gather so as to cause a nuisance or annoyance or danger to any persons lawfully using the highway.
- The holder(s) shall not use or suffer or permit any music playing music reproduction or sound amplification apparatus or any musical instruments, radio or television receiving sets whilst exercising privileges granted by this Permission.
- The holder(s) shall not make any excavations or indentations of any description whatsoever in the surface of the highway or place or fix any equipment of any description in the said surface.
- The holder(s) shall not use the highway for any other purpose whatsoever nor at any time other than during the permitted hours, other than lawfully passing or re-passing thereover as (a) member(s) or the public.

- The holder(s) shall provide litter bins or similar receptacles for the deposit of cartons, wrappers, containers and similar discarded items if required by the Head of Engineering Services and ensure that the same are emptied daily.
- The holder(s) shall remove all furniture or equipment, litter bins or other articles placed on the highway in accordance with this Permission at the expiry, surrender or revocation of the Permission.
- The holder(s) shall indemnify and save harmless the Bath & North East Somerset Council their agents, servants and workmen from and against all proceedings, claims, damages, costs or expenses in respect of any injury (including personal injury) in damage or loss which may be sustained by the Council or any person or persons, body or company whatever arising out of or in any way connected with the provision or use of facilities under this Permission, accept where such injury, damage or loss is attributable to the negligence of the Council.
- This Permission may be revoked by the Bath & North East Somerset Council at any time and the Bath & North East Somerset Council shall not in any circumstances whatsoever be liable to pay any compensation to the holder(s) in respect of such revocation.
- Nothing herein contained shall be construed as the granting or purported granting by the council of any tenancy under the Landlord and Tenant Act 1954 or any permission under the Town and Country Planning Act 1971 or any statutory modification or re-enactment thereof for the time being in force.
- The holder shall, whilst members of the public are using the facilities provided for the consumption of intoxicating liquor, provide and maintain in a prominent position, to the satisfaction of the Council's Head of Environmental and Consumer Services, notices in the form approved by him concerning the provisions of the Byelaw made by the Bath City Council on 30<sup>th</sup> January 1991 relating to the consumption of intoxicating liquor in public places.

#### Notes:

- 1 Section 115K of the Highways Act 1980 provides as follows:-
  - (1) If it appears to a council that a person to whom they have granted a permission under section 115E of this Act has committed any breach of the terms of that permission, they may serve a notice on him requiring him to take such steps to remedy the breach as are specified in the notice within such time as is so specified.
  - (2) If a person on whom a notice is served under sub-section (1) of this Act fails to comply with the notice, the council may take the steps themselves.
  - (3) Where a council have incurred expenses in the exercise of the power conferred on them by sub-section (2) of this Act, those expenses, together with interest at such reasonable rate as the council may determine from the date of service of a notice of demand for the expenses, may be recovered by the council from the person on whom the notice under sub-section (1) of this Act was served.

We acknowledge receipt of your letter dated 23rd March 2016 regarding the above.

We should like to repeat once again our concerns regarding this Permission:

- 1 The tables outside Café Nero are not serviced. Dirty crockery and full ashtrays are left to mount up all day on the tables, floor and bench seating opposite.
- 2 The chairs and tables are not confined to their specified area and creep out across the pavement during the day, eventually often sprawling across the entrance to our premises, unlike the shop selling pastles opposite which has barriers containing the tabled area. This should be applied to the Café Nero area.
- The pavement is left strewn with cigarette ends at the close of their business so that we are obliged to sweep up and often wash down their area which adversely affects the front of our premises.
- 4 All of the above presents a constant eye-sore in the centre of our City and we feel that permission should only be granted on the condition that the area is constantly, hygienically maintained by staff at Café Nero and that regular checks by yourselves are carried out to ascertain that this condition has been adhered to.

We trust that you will give your full attention to our valid and continued concerns.

The complaint comes in 3 parts:

- 2. That the Tables and Chairs are not being confined to the specified area of the permit and are allowed to creep outside of the permitted area during the day.

Whilst I do not have any direct evidence to show that this is happening I have no reason to dispute the complaint received is justified. All of the above issues are breaches of the conditions that are attached to the Permit that is issued.
