4. **Public Speaking at Meetings**

The Council has a scheme to encourage the public to make their views known at meetings. They may make a statement relevant to what the meeting has power to do. They may also ask a question to which a written answer will be given. **Advance notice is required not less than two full working days before the meeting.
