3.1	PC Peard gave an update on police matters.	
3.2	He explained that they had been a series of garage break-ins in Clutton over the weekend and one in Bishop Sutton. There were a number of travelling criminals who have been using the A39, A262 and A37. He urged people to be vigilant and report suspicious incidents.	
3.2.1	He reminded people not leave doors and windows open and emphasised that handbags, keys and wallets should not be left by the back door or open windows.	
3.3	PC Peard said that they had recently given hi-vis tabards to East Harptree School. This is an initiative that the police have supported for a number of years.	
3.4	He said that phone scams were on the increase and this was of particular concern to vulnerable people particularly older people in the Chew Valley, those with Dementia. It was important to report any concerns to the Police.	
3.5	Cllr Heaford commented that there were a number of break in in Pensford. He raised concern that there was a long gap between PC Lindow leaving and a new officer in place. PC Peard said that a new Beat Manager had been appointed and will be taking up post shortly.	
3.6	Cllr Warren referred to an incident in Hunstrete where a suspicious car had been identified by a number of residents following a break in. The car was intercepted in the garage. This was as a result of residents being vigilant and reporting suspicious activity.

increase in officer numbers can be achieved over the next few years as recruitment takes place. Sue explained that she would be looking to consult on raising the precept again this year to help with increasing resources. She said that staff were working extremely hard under very difficult circumstances. 5.1.4 Sue said that Crime had changed over the years and the police force had to respond to this and work in partnership with other agencies. 5.1.5 She explained that over 80% of the Police's work was non-crime. It is important that they protect vulnerable people. 13% of the crime is domestic abuse. They see increases in domestic abuse when particular events happen – eg the football. They have been working hard to look at working practices, an example given was people who had psychotic episodes were put into normal cells, which was not appropriate. They now have four beds allocated for people with mental health issues. 5.1.6 20 people go missing every day. There is over 8,000 missing people in BANES, 1,183 were recorded in June. 5,000 of them are children. 1,000 are older people who have dementia and Alzheimer's and vulnerable people. 5.1.7 There are 35 calls per week on scams. There is lots that can be done to protect yourself and it was important that local Beat Managers worked with the local community to get the messages out to local residents. 5.1.8 Sue explained that they work closely with Highways England to ensure the motorway traffic is free flowing and that they can respond to motorway incidents that impact on the district. 5.1.9 Their role is extremely varied with officers from Avon and Somerset working neighbouring authorities on special visits, incidents like Salisbury poisoning are just among a few examples. 5.1.10 She added that the 101 service had seen significant improvements over the last few years and continued investment is needed in this service so that it effectively supports the emergency line. 5.1.11 The Chair thanked Sue. 5.2 **Avon Search and Rescue** 5.2.1 Chris introduced Duncan Massey, Operational Lead/Incident Controller and Steve Rumney, Team Leader from Avon Search and Rescue. A presentation was given. Avon Search and Rescue has been in existence since 1976. In the early days it was set up as a cliff rescue to cover of Avon. In 1990, the amalgamation of the Avon and Somerset teams created Avon and Somerset Cliff Rescue team. They expanded further in the 90s and again in early 2000 and introduce search management capabilities including Water Margin search and renamed as Avon Search and Rescue. 5.2.2 Avon Search and Rescue is a registered charity, they currently have over 80 members, 50 of which are active 24 hours a day 365 days a year to help rescue people in the Avon & Somerset and surrounding areas. They work closely with the local police. They are all volunteers who receive technical training. They raise funds to buy equipment and run the service. 5.3.1	Chris introduced Daniel Noad and Stephen Bell from B&NES Emergency Planning. Daniel and Stephen gave a <u>presentation</u> to the group. The team respond to major incident in the district working with a range of partners including Emergency Services, Public Services, Military, Voluntary Agencies are among a few.	
5.3.2	The team is involved in a range of incidents including: Adverse weather (heat/cold/snow etc.); Flooding; Suspect packages/Explosive devices; Oil/Chemical/Diesel spills; Asbestos incidents; Fuel supply disruption; Evacuation of people from their homes; Landslips.	
5.3.3	They also responsible for identifying Community Places of Safety. The intention is to develop a network of community places that provide a safe environment if communities need to be evacuated by the emergency services when threatened with a risk. They are continuing to build a database of places, if you would like to check what places are listed in your community or would like to suggest a location contact: daniel_noad@bathnes.gov.uk .	
5.4	Joint Community Safety Plan	
5.4.1	Chris welcomed, Andy Thomas, Head of Strategy, Engagement and Marketing who spoke about the <u>Joint Community Safety Plan</u> . He explained that the plan had been based around localities. There was a commitment to support vulnerable people and to work with a range of agencies across the district to join up and focus on localised issues.	
5.4.2	Chief Inspector Kendall said that a key part of the plan was the neighbourhood teams and the commitment to retaining the local beat teams which was in response to local people's views.	
5.4.3	The consultation draft was circulated to the Forum. Andy explained how the issues and questions raised at Forum meetings have helped to shape the document. He encouraged the Forum to provide comments.	
5.5	Chris thanked all the speakers and opened questions up to the group.	
5.5.1	Comment – a report today on rural policing commented that the main issues were speeding and fly-tipping.	
5.5.1.1	Answer – mostly flytipping is the responsibility of the local authority. Speeding is one of the priorities for the PCC and we are actively support Community Speedwatch. We do a number of speed awareness courses. Any surplus funds are invested into local community projects.	
5.5.1.2	There are a number of mobile speed vans and motorcycles. The motorcycles help with reducing speeding in the villages particularly where the roads are narrow. Fixed cameras are costs and there has to be evidence to support a fixed camera. You can request the mobile speed camera in your area.
