Planning permission has been granted for 24/03168/REG03 to constructe a Recycling Centre (RC) in Locksbrook Road on the site of the Cleansing Yard and The Old Coal Yard to replace the existing site at Midland Rd which will close in 2026 for redevelopment. In order to commence construction of Bath RC, Cleansing Services will move out of this site to the Transport Depot also in Locksbrook Road. This site is currently not fit for purpose and requires remodelling and refurbishment.
