#### Details of the delegated authority being settled:

Delegated authority is granted to the Divisional Director (Environmental Services) to convert a footway to a cycle track for shared use (sections 66(4) and 65(1) of the Highways Act 1990. The Environmental Services scheme of delegation has been amended to reflect this. **Rationale:** 

There is currently no delegated authority to officers to advertise and make a Cycle Track Order for shared use, although the obvious parallel exists for the making of a Traffic Regulation Order.
