E3249 Introduction of S106 Monitoring Fees

Decision: The Cabinet Member agrees that the Council implements a fixed fee for the monitoring of S106 agreements. The fee will be set at £400 per obligation to be written into the legal agreements. Fees will be capped at £10,000 per legal agreement. The fee is to be payable on commencement of development and the scale of fees will be reviewed within 36 months of the date of this decision.
