Bath & North East Somerset Council is looking to appoint two additional independent Non-Executive Directors to further strengthen and diversify its wholly owned housing company (Aequus Group) Board of Directors. One of the current Non-Executive Directors is standing down from his role at the end of March 2022 and there are 3 other Non-Executive Directors coming to the end of their term within the next few years so, it was proposed to start the recruitment process now to ensure the continuity of Board.

UPDATES TO CABINET PORTFOLIOS

There have been some changes to Cabinet portfolios which are set out below:

- Cllr Dine Romero's portfolio is now entitled Children and Young People and Communities. This portfolio now also includes refugees and asylum seekers. Responsibility for culture has moved to the Leader's portfolio.

- Cllr Richard Samuel's portfolio, Economic Development and Resources, now includes Bath River Line (moved from Cllr Warren's portfolio).
- Cllr Sarah Warren's portfolio, Climate and Sustainable Travel, now includes regional working (WECA) and bus stops (moved from Cllr Rigby's portfolio).
- Cllr Manda Rigby's portfolio, Transport, now includes residents' parking, including zones (RPZ), car park provision and sub-regional working (Western Gateway Transport) (moved from Cllr Warren's portfolio).
