The SPD has been updated to reflect new requirements set out in the Local Plan Partial Update, including relating to zero carbon development, Biodiversity net Gain and housing accessibility. Following consultation on the draft SPD and consideration of the comments received this report recommends adoption of the updated SPD.

This will then be used by Development Management to assess whether planning applications comply with the policy.
