### E3460 Hygge Park and Sulis Down Support Provider Procurement (WL)

Accommodation for new supported living schemes is currently being built at two sites: Hygge Park in Keynsham and Sulis Down in Bath. Both will house 5 individuals with support needs in individual flats, have some communal space, and office/ living space for a support member of staff 24/7. The schemes will be open to individuals with a learning disability and/or autism with Care Act eligible care and support needs.

The Specialist Commissioning Team is responsible for commissioning a support provider to provide core support for all the individuals who will make these flats their homes. We propose to complete a competitive tender to appoint one core provider across both schemes. This approach offers the market a viable contract and an opportunity to grow their business and position within B&NES.

#### E3458 Roman Baths Forward Plan 2023 - 2026 (WL)

A Museum Forward Plan is a requirement of the Arts Council England's Accreditation Scheme. The Accreditation Scheme is the UK industry standard for museums and galleries.

It helps everyone involved with a museum to do the right things, helping people to access and engage with collections, and protect them for future generations.

The Accreditation Scheme does this by making sure museums manage their collections properly, engage with visitors, and are governed appropriately by encouraging all museums and galleries to meet an agreed standard in:

• how they're run;

• how they manage their collections; and

• how they engage with their users.

We must provide the following for the Roman Baths Museum:

2.1 An approved forward plan which covers the

current and subsequent planning year.

This needs to be signed approval from someone with delegated authority.

### **CALLED IN DECISIONS**

This decision was the subject of a call-in by at least 9 members. The call-in has been validated under the rules within the Constitution. The decision will be examined through the overview and scrutiny process at the Corporate PDS Panel meeting on 11<sup>th</sup> July 2023 and a recommendation may be made back to the decision maker. If so, the response of the decision maker (the Cabinet member or the Cabinet, whichever is relevant) will be recorded in a subsequent Weekly List. Once made, this decision will not be eligible for a further call-in.

E3453 Entry Hill Depot Site, Entry Hill, Bath BA2 5NA – Recommendation for Disposal (WL)

The Entry Hill Depot Site does not offer an opportunity to develop for Residential Development in the short to medium term and therefore could be offered for sale or lease for employment use only in accordance with the local plan.

The proposal to delegate to the Head of Corporate Estate in consultation with the Head of Finance and Head of Legal Services the decision to sell to a single proposed purchaser subject to valuation by a third party without prior marketing of the site, the costs of which will be borne by the proposed purchaser whether the matter proceeds to completion or not. The rationale being that there are no alternative uses of higher value to which this land could be developed in the medium to long term, owing mostly to planning restrictions (albeit provisions to recover overage from the purchaser or their successors in title will be included in any sale contract). It is intended that the proposed purchaser will support the local economic growth through development for employment uses resulting in an estimated additional GVA of £1.4 million pa.
