## Appendix 1A

## Commissioning for Quality and Innovation (CQUIN) update for Quarters one and two 2011-12:Summary of achievements

The table below gives details of performance against the CQUIN schemes for quarters 1 and 2. Some of the payments are made when baseline exercises take place and when trajectories for improvement set by the commissioners are met. The VTE risk assessment national targets for acute trusts have been met by the RUH and RNHRD. Improvements have been made in the area of Dementia and Stroke Care. 98% of the staff on the Older Peoples Unit has received training on caring for people with dementia and assurance has been provided that the rest of the stretch targets will be met in quarter 3. The scheme with Sirona Care and Health has already ensured that every person with learning difficulties are offered and receive a health or well persons check and are followed up with action plans for any health needs. Improvements are also being made with end of life care to ensure that people die in the place of their choice and that staff are trained to support the pathways of end of life care.
