#### TERMS OF REFERENCE

**Review Title: Review of Primary Provision Bath and North East Somerset** 

A Review by the Children & Young People Overview and Scrutiny Panel

## **Background**

All primary schools in Bath & North East Somerset are to be reviewed over the period September 2003 to May 2009.

The process to be followed when undertaking an Area Review has been the subject of wide and lengthy consultation. It was finally approved by the School Organisation Committee (a body independent of the Council) on 22 July 2003.

Each school is initially to be reviewed alongside its partner schools in a geographical area.

## **Purpose**

The aims of the review process are to:

- Maintain and improve educational standards
- Maximise the use of existing resources (land, buildings and funding)
- Increase access to high quality facilities for children, staff and the community
- Make the choice of a local school the natural and easy choice for parents

### **Objectives**

At the end of each Area Review, elected Councillors may decide that some changes (school closures, new schools, enlarging schools etc.) appear to be necessary and initiate a further consultation process focusing on the school(s) affected. It is equally possible that Councillors may simply acknowledge that the pattern of school provision is working effectively and that no changes are required in the short or medium-term.

## Scope

- Educational Standards
- Resources
  - Land
    - enough suitable land, removal of excess land

- Buildings
  - condition, suitability and sufficiency of school accommodation
- Funding
- Sufficiency of Places
  - enough places to meet current and forecast demand
  - removal of surplus places

### **Approach**

The Panel will undertake the following activities to gather information:

- 1. Research
  - Receiving a discussion paper including factual data sets on the schools under review
  - Receiving briefings from the Education service
- 2. Consultation
  - Visits to Schools
  - Contributor session to establish the views of key stakeholders
  - Seeking the views of parents, governors and schools

#### 3. Formulation of recommendations

- All information gathered will be considered by the Overview & Scrutiny Panel, at a facilitated session, and conclusions and recommendations drawn up.

## **Outputs of this Review**

- Notes and papers from public Children and Young People O&S Panel meetings
- Notes and papers from contributor sessions
- Report incorporating key findings, conclusions and recommendations for primary school provision in the area
- Recommendations to be presented to the Cabinet Member for Children's Services

#### **Constraints**

- The review must be managed within the budget and resources available to the Panel.
- As this review impacts on Primary schools, all public meetings will need to be held during term times.
