Following the decision of the High Court on 16th February 1998, we enclose an application for a Modification Order to strike out the existence of Bridleway CL15/11 at Norton Malreward.

The appropriate Notice WCA 6 (photocopy enclosed) has been served on Mr S R Young and a Certificate of Notice WCA 7 is enclosed.

The Council is already in receipt of the Decision Letters of the two Public Inquiries. We assume that you have all of the relevant documents relating to these, and we confirm handing to you a copy of the full Submission and Proof of Evidence from ourselves to the Second Public Inquiry. We have already submitted additional evidence from Mr W G Goldstone which was not considered by either Inquiry.

We would like the Council to re-examine:-

- (a) 1811 Ordnance Survey map supporting the Ramblers claim that a route went south of the Church rather than North.
- (b) Para 177 of the Decision Letter dated 28th May 1997 with the complete set of correspondence sent to you with our letter of the 4th December 1997.
- (c) The last sentence of para 180 of the Decision Letter
- (d) Para 181 of the Decision Letter where the Inspector suggests that the (then) owner dedicated the route as a Bridleway. No factual or written evidence of this alleged dedication has been presented. (Parts of the Parish Clerks submission and her childrens submissions dated 21st February 1997 refer to this aspect).
- (e) The various points raised in our letter of 4th December 1997 and the enclosures sent with it.

Please let us know if there are any other points you would like clarified.

Lastly, we would be grateful if this matter could be expedited soon, as it has been on-going since 1989, over 9 years.
