

Report on the consultation on the draft vision and priorities for the CYPP 2011-2014

Background

In March 2010, the Children Trust Board (CTB) tasked a multi-agency sub-group to lead on the consultation on the vision and priorities for the next CYPP 2011-2014 and make recommendations on the governance arrangements required to deliver the CYPP. In June 2010 the CTB endorsed the previously agreed set of principles: to agree clear key areas for improvement across the partnership: create an executive, strategy & delivery groups to deliver on the CYPP priorities: move away from LAP Boards and move towards locality sponsored networks

The CYPP sub-group have met regularly to lead the consultation and progress a governance arrangement to support delivery of the plan. In July 2010, the new coalition government announced its plans to repeal the current legislation requiring the CTB, CYPP to be on statutory bases and removing the statutory duty to co-operate from Schools. It is the view of local CTB members that we should continue to have a CTB : that schools and learning settings are the most critical factors in both safeguarding and developing our children , continued engagement with and by schools is viewed as critical and that we will continue to work as a Board towards our new "lighter " touch CYPP.

Consultation

A 3 month consultation on the development of the vision, values and priorities 2011-2014 has taken place with the Children's Trust Board, the Local Area Partnerships, through staff management structures, the trades unions, children and young people in and out of school, parents and carers, the voluntary and community sector and the Local Strategic Partnership for the period May 31st- July 31st.

The poster and postcard, developed to promote the consultation are attached for review. Classroom packs containing the whole exercise (paper questionnaire and postcard x 30) were sent out to all primary and secondary schools across B&NES. Voluntary sector youth groups received

proportionately smaller packs. The questionnaire was placed on the B-Active website and advertised widely. The youth service distributed a further 2000 post cards.

1022 completed questionnaire and 1142 completed cards were returned. There was a fair spread across the geographical areas. 48% of females and 52% of males overall answered. 52 completed questionnaires were received from parents and carers and approximately 100 people engaged in the Leadership Forum consultation event.

Outcome

The **vision** for the next CYPP was fully supported by all who engaged in the consultation. The vision for 2011-2014 is as follows:

“We want all Children and Young People to enjoy childhood and to be well prepared for adult life”

Priorities:

6 priority areas have been agreed as follows:

- Key area 1: Providing children and young people with a safe environment, including empowering children and young people to recognise and manage risks
- Key areas 2: Promoting children and young people’s emotional health and resilience for learning and life
- Key area 3: Reducing health, education and social inequalities in specific groups of children and young people and specific geographical areas
- Key area 4: Supporting all young people to engage in employment , education and training from 16-19
- Key areas 5: Positive learning experience
- Key areas 6: Promote and support healthy lifestyles for CYPP

Next Steps

The Children Trust Board are expected to sign off on the vision, priorities and proposed governance model to deliver the new CYPP on September 16th 2010. The first draft of the CYPP will be distributed widely in September 2010 for further review and consultation. It is planned that the second draft CYPP will be distributed in December 2010 for final review and comment. The CYPP 2011-2014 will be published on April 1st 2011.
