## Details of Incidents / Medic Responses

### Friday 19<sup>th</sup> October 2012

22:00 - Marshals signed on duty

Meeting with BANES Council and Police - Patrolling town and showing presence to all Door Supervisors at the pubs / venues etc.

23:05 - Took glass away from 2 males in the High Street.

Further patrols of town carried out

00:40 - 2 groups of males fighting next to Lloyds Bank - Marshals split them up and made them move away

01:20 - Many people using the streets as a public toilet – Marshals spoke to as many as possible

01:26 - 2 males fighting at Charcoal Grill - when the Marshals arrived both males decided to walk away. No police attended.

Note: After 01:00 Charcoal Grill is the main place where fights & aggravation will occur. It is highly recommended that this venue employs a Door Supervisor(s) - we provide Door Supervisors for similar venues in other towns – this is actually a requirement of their license.

02:05 - 3 males started a fight next to Charcoal Grill - Marshals got involved and calmed the situation down

02:09 - People still going in to the Riverside – some appeared extremely intoxicated (questionable as to where they should've have been let in due to how intoxicated they were), some also looked under age.

02:15 - 2 Males started on another male at the Charcoal Grill marshals ask them to move away

02:24 - People leaving the Riverside with glasses

03:00- Marshals signed off duty

### Saturday 20<sup>th</sup> October 2012

22:00 - Marshals signed on duty

22:40 - 3 Males and 1 female tried taking pint glasses from the Greyhound, Marshals asked them to leave the glasses on the side - all males refused and started getting aggressive. We called CCTV & explained to the males why we were asking them to do this. The Door Supervisors then refused them entry so they all walked away.

23:00 – Took pint glasses from 2 males as they left Riverside pub

23:00 - Took 3 pint glasses from 2 males and 1 female

23:30 - Patrolled the Skate Park – There were some youths drinking alcohol by the side of the Skate Park, Marshals tried to call 98 CCTV but there was no answer. We informed the youths that

they are not allowed to drink there and we took a bottle of vodka from them.

00:10 - People were trying to leave the Riverside with drinks, Marshals made them take the glasses back to the venue.

00:15 - Fight next to Town Hall - 3 males punched another male. One of the Street Marshals called CCTV & requested Ambulance. Marshal passed the description to CCTV operator, Police were also contacted. Police arrested one of the males, and the male who had been punched was taken to the RUH by the Ambulance. Incident lasted approx 30 minutes.

01:50 - Marshals walked to the Esso garage to show a presence - the reason being is that a lot young people were parking their scooters there and also a white BMW was parked next to the till and the driver was intoxicated. Marshals contacted CCTV and Police, Marshals passed the registration number and detailed description of the car and driver to the Police.

02:20 - 2 Males were arguing next to the Johnsons shop, Marshals attended & took control of the situation and made both males walk away in different directions

02:50 – Final patrol carried out

03:00 - Marshals signed off duty

03:05 - Marshal (Dominik) noticed 2 males fighting on his way back to his car so he contacted CCTV and waited for the Police to arrive.
