

PROPOSED TRAFFIC REGULATION ORDER

BATH AND NORTH EAST SOMERSET COUNCIL**(VARIOUS BYWAYS OPEN TO ALL TRAFFIC, ENGLISH COMBE, PENSFORD, PRISTON AND PUBLOW) (WIDTH RESTRICTION) ORDER 200-**


NOTICE is hereby given that the Bath and North East Somerset Council proposes to make an order under provisions contained in the Road Traffic Regulation Act 1984 as amended the effect of which will be to prohibit any person from causing or permitting any motor vehicle, the width of which, inclusive of any load on or being drawn by the vehicle, exceeds 3 feet and 3 inches to proceed in the lengths of road as specified in the Schedule to this notice. The affected roads are **Birchwood Lane Byway Open to all Traffic CL17/34 Publow and BA8/87 Pensford, Ringspit Lane Byway Open to all Traffic CL17/41 Publow and Mill Lane Byway Open to all Traffic BA11/22 Englishcombe and BA20/18 Priston.**

Full details of the proposal are contained in the draft order, which together with a map and a Statement of the Council's Reasons for proposing to make the order may be inspected at The Hollies, Midsomer Norton and at our offices below during normal office hours.

| Birchwood Lane, Publow and Pensford | That length of Byway Open To All Traffic CL17/34, Publow and BA8/87, Pensford which extends from its junction with Woollard Lane to a point 750 metres due south of said junction, a distance measured along the said length of approximately 800 metres. |
| Mill Lane, Englishcombe and Priston | That length of Byway Open to All Traffic BA11/22, Englishcombe and BA20/18, Priston which extends from its junction with BA11/11 west of Home Farm, Inglesbatch, to the north side of Conygre Brook at Priston Mill Farm, Priston, a distance measured along the said length of approximately 650 metres. |
| Ringspit Lane, Publow | That length of Byway Open To All Traffic CL17/41, Publow which extends from its junction with the A37 Hursley Hill to its junction with Blackrock Lane, a distance measured along the said length of approximately 450 metres |
