1 THE ISSUE

The B&NES Fairer Contributions Policy is amended each year to reflect changes in statutory benefit entitlements and minor policy changes which may affect financial assessment.

2 RECOMMENDATION

The Cabinet members are asked to agree:

- 2.1 The change relating to the minimum income threshold buffer detailed on p5 of the attached policy document which brings the policy in line with national DH guidance, and
- 2.2 The changes relating to Disability Related Expenditure set out in Appendix 3, p14-15 of the attached policy document which provide greater clarity and flexibility for service users, carers and staff and are in line with national DH guidance.

3 FINANCIAL IMPLICATIONS

3.1 The recommendations in 2.1 & 2.2 above relate to The Council's Financial Plan 2013/14 – 15/16 Appendix 2 Annex 5 which highlights the need to ensure the Council's policy is consistent with national DH guidance.

5 THE REPORT

- 5.1 The main report comprises the Fairer Contributions Policy 2013/14 (attached). The document is broadly the same as the policy document agreed in 2012/13 however a number of minor changes have been made to provide greater clarity and consistency with national DH guidance as set out below.
- 5.2 The minimum income threshold buffer applied during the financial assessment process has been changed from 30% to 25% as per national DH guidance and consistent with the Council's Financial Plan 2013/14 2015/16.
- 5.3 Guidance on Disability Related Expenditure has been expanded and enhanced to ensure that all eligible expenditure is routinely and consistently included in an individual's financial assessment therefore maximising the resources they have available to them to continue to live independently.
- 5.4 Minor changes have been made throughout the document to reflect the Council's new relationship with Sirona Care & Health CIC (who are responsible for requesting financial assessments for individual service users and for collating evidence in relation to appeals), and also to reflect forthcoming changes to the wider welfare benefits system that will be brought about by recent Government reforms.

6 RISK MANAGEMENT

6.1 The report author and Cabinet member have fully reviewed the risk assessment related to the issue and recommendations, in compliance with the Council's decision making risk management guidance.

7 EQUALITIES

- 7.1 An Equality Impact Assessment was completed when the policy was agreed and the changes highlighted in the report are unlikely to make material changes to this assessment.
- 7.2 Some positive impacts are likely to be seen by all service users subject to the policy with the improved application of Disability Related Expenditure criteria.
