In addition, existing waiting restrictions outside the barber shop on the western side of the road are to be amended to provide the necessary visibility for pedestrians. The proposals follow extensive consultations which the Design Group carried out with local residents, the local Ward Councillors. The primary outcome will be enhanced accessibility & safety for pedestrians, particularly school children to and from Bath Community Academy (formally Culverhay School).

Once the crossing has been in operation for more than three months a pedestrian count survey will be undertaken to determine its impact on road
