## 5 THE REPORT

- 5.1 The proposals relate to Clara Cross Lane, Dartmouth Avenue, Englishcombe Lane, Entry Hill, Harcourt Gardens, Hillcrest Drive, Kempthorne Lane, Lynbrook Lane, Mount Grove, Mount Road, Oolite Road, Saffron Court, Sham Castle Lane, Southdown Road, St Marys Close, Tyning Lane, Upper Bloomfield Road, Wellsway (junction with Oolite Road), Grosvenor Place and Herbert Road.
- 5.2 The proposals were advertised on 9<sup>th</sup> September 2010 for a period of 21 days. Comments received are included in the appendix.
- 5.3 Comments in relation to Lynbrook Lane/Entry Hill have been received together with points relating to Kempthorne Lane and St Marys Close. No comments were received regarding the remaining proposals. A further site visit has therefore been made to Entry Hill and it has been concluded that the proposals do not need to be implemented in order to allow essential private vehicles to effect a turning manoeuvre. To remove on-street parking as detailed in the proposal would adversely impact on local residents. It is likely that residents will approach the Council with additional requests for restrictions on Kempthorne Lane at the conclusion of their enquiry. Finally, the St Marys Close proposal could be reduced by five metres from 21 to 16 metres to achieve the access requirement whilst maximising on-street parking. These suggested changes are detailed in the Appendix to this report.
