
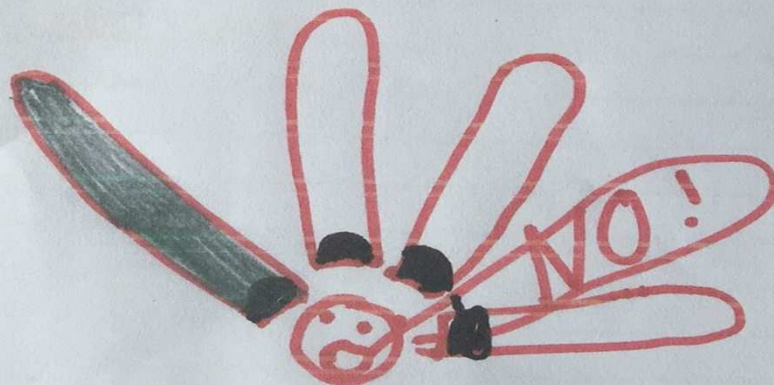
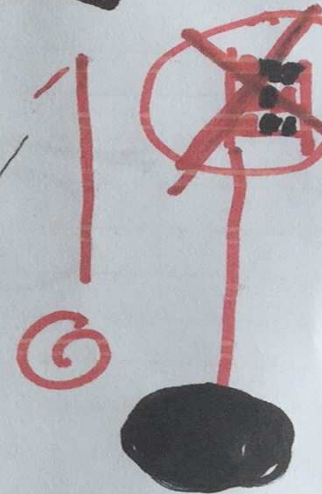

The Petition

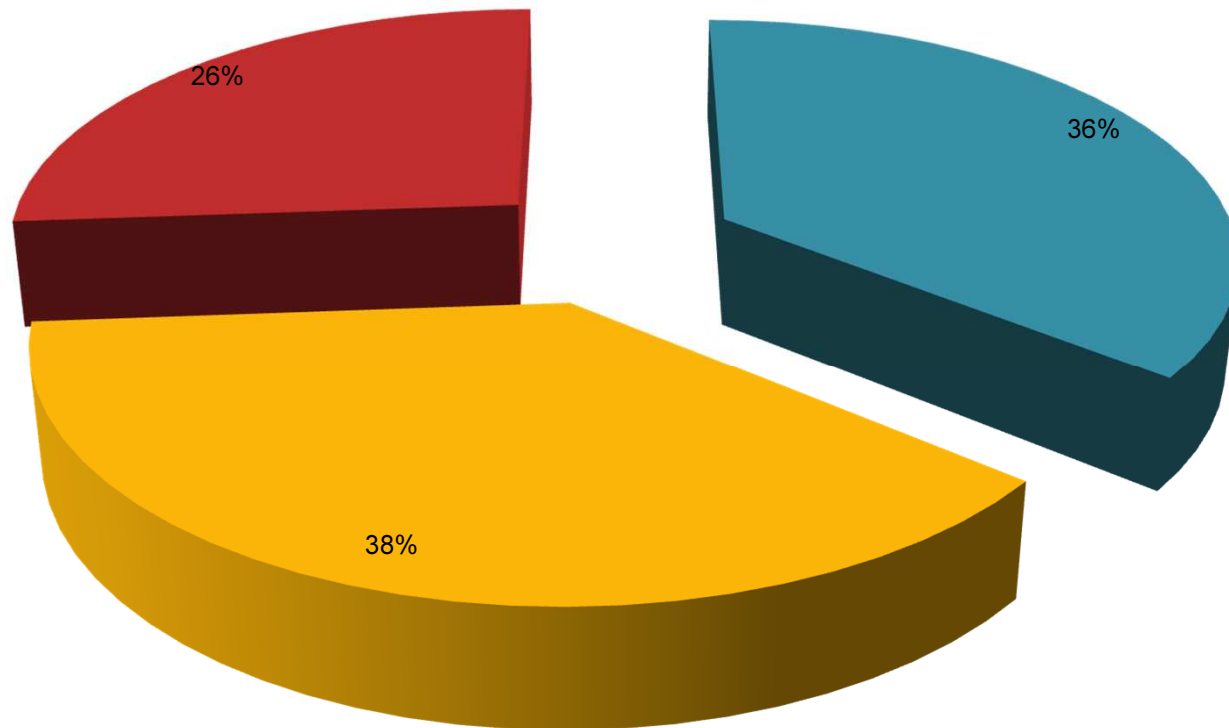
- 11 614 signatures so far, on-line and hard copy

Comments

- **“Impact to wildlife and landscape would be devastating.”
(Bath resident)**
- **“This is one of the few remaining open green spaces that is easily accessible from the city - do not destroy a visual beauty for a political effort that is being pushed in the wrong location. Good luck getting buses back along London road in rush hour to actually deliver drivers back to their cars!” (Bath resident)**
- **“We are visiting Bath and walked the wonderful, natural meadow last night.... I have wanted to visit the English countryside for a long time and I cannot imagine what it would be like with a carpark right in the middle of the meadow.” (Visitor from Dallas, USA)**



Comments

- **“It would be inconceivable to concrete over the Roman Baths, so why destroy an equally important historic landscape?” (Spanish visitor)**
- **“Bath needs to protect these meadows, once they are gone 'sorry' just won't do” (Bath resident)**

- **“I once supported P&R schemes. In fact, I was one of the people campaigning to bring them here. Alas, studies have shown that, not only do they not solve the problem, they add to it.
