As well as providing local library services, it is a valuable community resource particularly for parents, carers and families.

Parishes have been involved in providing input into the roll out of FixMyStreet and have commented on the refresh of the Council's website. They have particularly welcomed the introduction of FixMyStreet as it enables them to quickly report issues, identify whether other residents have already reported them and obtain updates. Parishes continue to offer valuable feedback for improvements to FixMyStreet and will continue to be involved in the website refresh as it progresses.
	Statistics for FixMyStreet (as of writing) show 245 reports in the previous week, 653 fixed in the previous month and 31,468 updates on reports https://fix.bathnes.gov.uk/ .
We will work together to protect the most vulnerable in our community.	Parishes regularly attend the Connecting Communities Forums and through these have raised awareness of issues facing vulnerable people and the local services available to support them, such as Age UK B£NES, DHI, and Mentoring Plus. This initiative has been welcomed by parishes, many of which were unaware of the range of support and activities on offer. They now feel better placed to support vulnerable people in their communities and have been promoting these services to their residents via their website and local newsletters.

It was recognised that the Council's withdrawal of funding for the Parish Sweeper scheme would have impacts for those parishes currently receiving a grant under the scheme. As a result, a working group was established including parish representatives, including non-members of the scheme. As a result, a package was drawn up offering a phased reduction of funding which enabled parishes to better plan for the withdrawal using their own local resources and based on priorities in their communities.
