128/19-20 **Karen Warrington Ward Councillor invitation to discuss Planning applications & The Old garage Street name proposal**

The Parish Council discussed recent planning applications which have been granted by BANES despite strong opposition. There are Strong feelings amongst the Councillors who feel our opinions are not being considered. Karen advised that we should speak with her in the future and will investigate recent permitted developments.

Banes recently asked the Parish Council for suggestions for a new street name for the Old garage development. The Parish Council proposed the name Malcolm Close This was unanimously voted on and has since won Parishioner approval, who feel this is a fitting tribute for an outstanding member of the Community.

The name suggestion has received one objection and many Parishioners have since emailed BANES, submitting their support for this tribute.

The Parish Council were then asked to offer an alternative name, which was declined by the Parish Council, who unanimously stand by our previous suggestion.
