1 THE ISSUE

1.1 This report sets out the recommendations from the CIL for Bath Panel relating to the tenth allocation of funding to eight projects from Bath's "neighbourhood portion" of the Community Infrastructure Levy.

2 RECOMMENDATION

The Council Leader is asked to agree that following: -

- 2.1 An allocation of £9,000 for a Multi-Use Games Area (MUGA) at Rosewarn Park in Whiteway, Bath. (Capital External)
- 2.2 An allocation of £9,612 for the restoration on the boundary walls at The Jewish Burial Ground, Combe Down Bath. (Capital External)
- 2.3 An allocation of £9,950 for drainage works on the football pitch at Bath City Football Club in Twerton, Bath. (Capital External)
- 2.4 An allocation of £6,800 for work on landscaping, planting and a memorial plaque at The Workhouse Burial Ground, The Wellsway, Odd Down Bath. (Capital External)
- 2.5 An allocation of £39,249.87 for refurbishment of the Ball Court and improvements to Community Garden at The Weston Hub, Penn Hill Road, Weston Bath (Capital External)
- 2.6 An allocation of £4,476 for improvements to Weston Free Church (Moravian) for improvements to Community Garden at Moravian Church
- 2.7 An allocation of £5,000 for restoration of the historic water fountain and landscaping works delivered through The Bear Flat Association at The Gore, Elm Place, Bear Flat Bath. (Capital External)
- 2.8 Amend the provisional Capital Programme for Bath Area Forum from £124k to reflect balance of funding available prior to these allocations. These allocations, if approved, will reduce it to £40k.

3 RESOURCE IMPLICATIONS (FINANCE, PROPERTY, PEOPLE)

- 3.1 The funding allocations of £84,087.87 for the seven recommended project grants are to be drawn down from the existing Bath CIL contributions set aside for neighbourhood projects.
- 3.2 The seven projects are all one-off payments allocations.
- 3.3 There are no other financial implications for the Council.
- 3.4 An agreed process has been set up for financial payments for Bath CIL external capital projects.

4 STATUTORY CONSIDERATIONS AND BASIS FOR PROPOSAL

4.1 Regulation 59F of the 2010 CIL Regulations provides that charging authorities who spend the neighbourhood portion of CIL can spend these funds:

"to support the development of the relevant area by funding—

- (a) the provision, improvement, replacement, operation or maintenance of infrastructure; or
- (b) anything else that is concerned with addressing the demands that development places on an area.
- "relevant area" means that part of the charging authority's area that is not with the area of a Parish council.
- 4.2 Guidance requires that in the absence of any parish or town Council for Bath, Bath and North East Somerset Council hold the Neighbourhood portion of CIL funding for Bath pending allocation. In allocating funding, the Council should engage with communities where development has taken place and seek their views on how best to allocate the funding.
- 4.3 The established a working group, process and criteria to formulate recommendations for allocation of the neighbourhood portion for Bath, is now recommending to a tenth set of proposals to be supported from this fund.

5 THE REPORT

- 5.1 The "neighbourhood portion" of the Community Infrastructure Levy comprises 15% of the total CIL amount generated from development within the city. In the absence of a town or parish council, it is for Bath & North East Somerset to hold such funding, but it must be allocated through engagement with the communities where development has taken place. £124,696 remains available as at April 2021 and must be used to support the development of the relevant area, namely Bath, by funding the provision, improvement, replacement, operation or maintenance of infrastructure; or anything else that is concerned with addressing the demands that development places on an area.
- 5.2 A clear and transparent process exists for preparing recommendations to the Leader of the Council on the neighbourhood portion of CIL for Bath. This comprises:
 - Dedicated web pages which provide an update on the CIL neighbourhood portion in Bath and a rolling open application process to submit projects which meet the criteria.
 - An application form requesting details of local engagement on the proposed project and information as to how it meets the demands of development.
 - Dissemination through a wide range of methods including through social media, ward members and the Council's Funding Bulletin.
 - The establishment of a neighbourhood portion of CIL for Bath group, drawn from the Bath Ward Councillors, Communality Representatives and Community Engagement Officers, to consider applications arising from this process.
 - All projects are required to complete a funding agreement which will monitor achievements as set out in the original application form. A designated monitoring officer has been identified to oversee this process.

- 5.3 The projects recommended in this report were considered at the working group meeting which took place on **26**th **April 2021**. The minutes of the group are included as appx 1. The recommended projects arising from this process are summarised below:
 - (1) £9,000 for a Multi-Use Games Area (MUGA) at Rosewarn Park in Whiteway, Bath. (Capital External)
 - (2) £9,612 for the restoration on the boundary walls at The Jewish Burial Ground, Combe Down Bath. (Capital External)
 - (3) £9,950 for drainage works on the football pitch at Bath City Football Club in Twerton, Bath. (Capital External)
 - (4) £6,800 for work on landscaping, planting and a memorial plaque at The Workhouse Burial Ground, The Wellsway, Odd Down Bath. (Capital External)
 - (5) £39,249.87 for refurbishment of the Ball Court, improvements to Community Garden and a new Defibrillator at The Weston Hub, Penn Hill Road, Weston Bath (Capital External)
 - (6) £4,476 for improvements to Weston Village delivered through Future Weston which include a improvements to Community Garden at Moravian Church and a new Village History Board (Capital External)
 - (7) £5,000 for restoration of the historic water fountain and landscaping works delivered through The Bear Flat Association at The Gore, Elm Place, Bear Flat Bath. (Capital External)

6 RATIONALE

6.1 In the absence of a Parish Council for Bath, the Bath and North East Somerset Council has a statutory responsibility to allocate the local portion of CIL.

7 CLIMATE CHANGE

7.1 No Recommendations to be made.

8 OTHER OPTIONS CONSIDERED

- 8.1 Consideration was given to this report being presented to full Cabinet, but it is considered appropriate that this be a single member decision.
- 8.2 The CIL for Bath Panel has considered a number of funding applications that requested support from the Bath CIL neighbourhood portion. The unsuccessful applications have been contacted and provided with the reasons why they were not successful; detail is included within appx 1.

9 CONSULTATION

9.1 Each of the applications which are contained within this recommendation submitted for agreement has completed a project expression of interest and application for funding form. All projects identify the local consultation and engagement that has taken place, and this was further tested through the process set out in this report.

- 9.2 The projects recommended in this report were considered by the CIL for Bath Panel and is seeking Council approval.
- 9.3 The Bath & North East Somerset Council Section 151 Officer and Monitoring Officer were both consulted in the preparation of this report.
- 9.4 This report has undergone a public sector equalities impact assessment. No negative impacts were identified.

10 RISK MANAGEMENT

10.1 A risk assessment related to the issue and recommendations has been undertaken, in compliance with the Council's decision-making risk management guidance.
