Analysis of Central Area Questionnaires

A number of questions were asked of residents to try and determine whether they were happy with their existing present arrangements or if they wanted changes to the controlled parking zone.

A total of 622 questionnaires were returned out of a total of 4192 issued to addresses within the central area controlled parking zone. This represents 14.8%
