Rationale for decision	Following consultation with key stakeholders and statutory consultation under Regulation 12 (b) of the Town and Country Planning (Local Planning) (England) Regulations 2012, the revised EERSC SPD will provide up to date guidance to supplement the adopted Local Plan (Core Strategy and Placemaking Plan) and the proposed updates within the Local Plan Partial Update and how energy efficiency can be maximised through retrofitting and sustainable construction.
Financial and budget implications	The review and preparation of the revised EERSC SPD has been undertaken by the Planning Policy Team and the costs of its preparation and public consultation will be covered within the existing salary budget and the Council's Local Development Framework budget. The review of the SPD is not anticipated to increase resource requirements in relation to the determination of planning applications.
