## Radstock Children's Centre - Lease Proposal to Youth Connect South West

The Radstock Children's Centre is currently let to Youth Connect South West. It was previously proposed that the building be sold to fund Hope House Children's Centre. However, that project was completed without the need for the sale proceeds. Youth Connect South West have expressed an interest in leasing the building so that they can continue to deliver their services. The building is also part of the proposed regeneration area and so retention is preferable to maintain flexibility over future development proposals.

## CIL for Bath Advisory Board Recommendations Round Fifteen

To agree the recommendation from the CIL for Bath Advisory Board relating to the round fifteen allocation of funding (£263,100) for six projects from Bath's "neighbourhood portion" of the Community Infrastructure Levy.

#### **Decision:**

- An allocation of £75,000 to Bath City Football Club towards the cost of a FIFA Quality PRO all-weather pitch at Twerton Park stadium in the ward of Twerton.
- An allocation of £40,000 to Curo Housing Group for the installation of swings, toddler equipment, flooring, and the enhancement of an existing Whiteway Green Park.
- An allocation of £60,000 over three years to Bath Preservation Trust to continue in delivering projects through The Bath World Heritage Enhancement Fund.
- An allocation £27,100 to Weston Community Library in order to carry out necessary refurbishments and cover rental costs for the next decade.
- An allocation of £47,000 to support the work of The Student Community Partnership Community Warden and Administrator for an additional year.
- An allocation of £14,000 to BaNES Allotment Association to support funding of communal projects that would include the creation of smaller plots and micro sites.

- To close the remaining 11 places at Charlton House Nursing home and then develop the site to provide alternative care provision and/or housing options that would meet the needs of the local community now and into the future.
- To offer community groups/charitable organisations use of the day centre spaces at the community resource centres at a reduced rental rate if the organisations offer services that are accessible to the care home residents and the community.

(2) To ask officers to bring forward a further report including recommendations following the consultation.
