Revisions to DIY Waste Limits at the Council's Household Waste and Recycling Centres

The Controlled Waste (England and Wales) Regulations 2012 have been reviewed and revised in regard to the management of waste generated by small scale DIY construction activities by householders. The purpose of this decision paper is to align our public recycling centre policies with the new limits set out in the revised legislation and subsequent statutory guidance.

ONE WORD 5G Mobile Network Pilot Project

The Department for Science, Innovation and Technology (DSIT) put out an Open Networks Ecosystem (ONE) funding call in March 2023. The ONE fund was developed in order to tackle key barriers to the adoption of open mobile networks: with trials in areas of high demand, and to allow for development of new Open Radio Access Network (Open RAN) software and hardware solutions to improve

performance of these networks.

The ONE WORD 5G Mobile Network Pilot aims to improve connectivity and boost the local economy as a result of providing a new cutting-edge mobile network directly in the historic centre of Bath.
