Fixed Penalty Notice charging schedule re Public Space Protection Orders (for anti-social behaviour related to alcohol)

The Issue	To agree the schedule of charges for Fixed Penalty Notices (FPNs) issued under Section 63 and 67 of the Anti-Social Behaviour, Crime and Policing Act 2014.
Decision Date	19 December 2024.
The decision	The Cabinet Member agrees:
	To set the Fixed Penalty charge for breach of Public Spaces Protection Orders at the following levels:
	Penalty Amount: Set the maximum Fixed Penalty Notice (FPN) amount for breach of PSPO at £100, to be paid within 28 days of notice being issued.
	Early Payment Reduction: Offer a reduced penalty of £75 if the payment is made within 14 days of the FPN being issued.
	To consider the legislative requirement for FPNs, as outlined in the Statutory Considerations section of the report.
	To ensure transparency and formal documentation of this decision through the Single Member Decision process.
	4) That the implementation of all future changes to PSPO Fixed Penalty charges are delegated to and implemented by the Director of People and Change, or any successor or equivalent role to that post in consultation with the relevant Cabinet Member.
Rationale for decision	The Fixed Penalty Notice levels have been reviewed within the scope of the legislation. The aim of setting the penalty amounts is to ensure transparency in the process, and act as a deterrent to those breaching a Public Spaces Protection Order (for anti-social behaviour related to alcohol).
Financial and budget implications	Legal and administrative costs of issuing FPNs will be covered within existing budgets. Any revenue received from FPNs will be reinvested into Council-led initiatives, enhancing local services and furthering community safety objectives.
