<b>Decision maker/s</b>	Cllr P May, Cabinet Member for Children's Services
<b>The Issue</b>	<p>The Local Authority is responsible for deciding the structure and values of the schools funding formula, following guidance from the DFE on the regulations applicable to school funding. This decision is relating to the make up of the formula for 2025-26 and will provide the funding allocations for both maintained and academy mainstream schools.</p>
<b>Decision Date</b>	7 <sup>th</sup> January 2026
<b>The decision</b>	<p>The Cabinet Member agrees to:</p> <ul style="list-style-type: none"><li>1.1 Agree to follow the formula set out in the report, continuing to follow the National Funding Formula (NFF) and to utilise the factor values provided by the DFE, providing the resources are available.</li><li>1.2 Agree that should resources not allow the funding of the formula factors in full that a proportionate reduction of all allowable factors is made to reduce the allocations to fit the resources available.</li><li>1.3 Agree to set the MFG at 0%per pupil.</li></ul>
<b>Rationale for decision</b>	<p>The Local Authority is continuing to mirror the National Funding Formula (NFF) as prescribed by the DFE. This approach has been followed for several years in line with the desires of both maintained schools and academies.</p> <p>The approach will ensure that school funding allocations are as close to the NFF as possible so that when the DFE take control of the formula decisions (DFE plans suggest 2027-28 financial year or later) the schools allocations from local decision making will not be significantly different thus avoiding turbulence in school budgeting.</p>
<b>Financial and budget implications</b>	<p>The overall funding allocation of resources for schools is provided by a ring fenced element of the Dedicated Schools Grant (DSG) known as the Schools Block</p> <p>The methodology of the decision taken will ensure that schools allocations are contained within this block allocation</p>

<b>Consultation undertaken</b>	Cabinet colleagues; Trades Unions; Service Users; Stakeholders/Partners; Other Public Sector Bodies; Section 151 Finance Officer; Chief Executive; Monitoring Officer
<b>How consultation was carried out</b>	Full written consultation of schools and academies occurred during Autumn term. Results formally discussed and supported by schools forum.
<b>Other options considered</b>	<p>There are many options available to allocate funding to schools and schools forum discussed the strategy of following the NFF on several occasions.</p> <p>As part of that strategy several options for the allocation of the resources to schools were considered prior to the consultation of schools on the proposals in this report. Several alternatives were set out in the schools consultation paper</p>
